Senator Scott's statement is as follows:

The Navajo tribe has a version of the Golden Rule that says, "Treat all people as if they were related to you." Now this advice applies to all of us in every aspect of our lives. But not surprisingly, I would like you to apply it to insurance rates in Michigan. Consider if it was your elderly mother and father, both careful drivers, paying some \$3,000 every six months to insure their six-year-old car. Imagine it was your son or daughter just out of college with clean driving records trying to pay \$6,000 every year to insure their first car. Imagine it was your spouse who relies on that car to get to work, to school, and to doctor's appointments paying \$3,700 every six months just for the privilege of doing so. Just remember this is the median for our largest city in the state of Michigan.

Treat all people as if they were related to you. That's exactly what I am struggling to do in my continuing efforts to bring equality to insurance rates in Michigan. You can help me by moving my bills.
