## HOUSE SUBSTITUTE FOR SENATE BILL NO. 74

A bill to amend 2008 PA 23, entitled

"Enhanced driver license and enhanced official state personal identification card act,"

by amending section 4 (MCL 28.304), as amended by 2020 PA 129.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 4. (1) The secretary of state may issue an enhanced 1 2 driver's license or enhanced official state personal identification 3 card to an applicant who provides satisfactory proof of his or her full legal name, United States citizenship, identity, date of 4 5 birth, Social Security number, residence address, and a 6 photographic identity document. If the applicant is a program participant in the address confidentiality program under the 7 8 address confidentiality program act, he or she shall present to the

secretary of state his or her participation card issued under the
 address confidentiality program act. An applicant may choose to
 apply for a standard driver license or standard official state
 personal identification card or an enhanced driver license or
 enhanced official state personal identification card.

6 (2) An enhanced driver license or enhanced official state
7 personal identification card must include reasonable security
8 measures to protect against unauthorized disclosure of personal
9 information regarding residents of this state that is contained in
10 the enhanced driver license or enhanced official state personal
11 identification card.

12 (3) An enhanced driver license or enhanced official state personal identification card may include radio frequency 13 14 identification technology that is limited to a randomly assigned 15 number that must be encrypted if agreed to by the United States 16 Department of Homeland Security, and does not include biometric 17 data. The secretary of state shall ensure that the radio frequency 18 identification technology is secure from unauthorized data access 19 and includes reasonable security measures to protect against 20 unauthorized disclosure of personal information. An applicant must sign a declaration acknowledging his or her understanding of the 21 radio frequency identification technology before he or she is 22 issued an enhanced driver license or enhanced official state 23 24 personal identification card.

25 (4) An enhanced driver license or enhanced official state
26 personal identification card that expires on or after March 1, 2020
27 is considered valid until September 30, 2020.

28 (5) The requirements of this act are in addition to the29 requirements otherwise imposed on individuals who apply for a

standard driver license or standard official state personal
 identification card.

(6) The holder of an enhanced driver license issued under this 3 4 act is subject to every licensing sanction provided under the Michigan vehicle code, 1949 PA 300, MCL 257.1 to 257.923. As used 5 6 in this subsection, "licensing sanction" means the restriction, 7 suspension, revocation, or denial of a driver license; the addition 8 of points to a driving record; until October 1, 2018, the 9 assessment of a driver responsibility fee; the assessment of a 10 civil fine or criminal penalty resulting from a conviction; a civil 11 infraction determination; the imposition of probationary terms and conditions; or any other penalty provided under the Michigan 12 vehicle code, 1949 PA 300, MCL 257.1 to 257.923. 13

14 (7) Beginning on March 16, 2021, upon receipt of a notice from 15 the department of the attorney general that an individual who has been issued an enhanced driver license or enhanced official state 16 personal identification card under this act has been certified as a 17 18 program participant in the address confidentiality program, the secretary of state shall issue a corrected enhanced driver license 19 20 or enhanced official state personal identification card to that 21 individual by mailing the license or card to his or her designated 22 address. An enhanced driver license or enhanced official state 23 personal identification card issued under this subsection or 24 subsection (1) to a program participant must display the 25 individual's designated address and must not display the 26 individual's residence address. The requirements of this subsection 27 are in addition to the requirements for individuals who are issued 28 a corrected standard driver license under section 310f of the 29 Michigan vehicle code, 1949 PA 300, MCL 257.310f, or a corrected

official state personal identification card under section 2a of
 1972 PA 222, MCL 28.292a.

3 (8) As used in this section:

4 (a) "Address confidentiality program" means a program as that 5 term is defined in section 3 of the address confidentiality program 6 act.

7 (b) "Designated address" means that term as defined in section
8 3 of the address confidentiality program act.

9 (c) "Program participant" means that term as defined in 10 section 3 of the address confidentiality program act.

Enacting section 1. This amendatory act takes effect 180 days after the date it is enacted into law.

13 Enacting section 2. This amendatory act does not take effect14 unless Senate Bill No. 70 of the 100th Legislature is enacted into15 law.
