- 3 constitution of 1963, total state spending from state sources under
- 4 part 1 for fiscal year 2019-2020 is \$96,262,000.00 and state
- 5 spending from state sources to be paid to local units of government
- 6 for fiscal year 2019-2020 is \$14,267,700.00. The itemized statement
- 7 below identifies appropriations from which spending to local units
- 8 of government will occur:

- 12 Total department of education...... \$ 14,267,700
- Sec. 202. The appropriations authorized under this part and
- 14 part 1 are subject to the management and budget act, 1984 PA 431,
- **15** MCL 18.1101 to 18.1594.
- Sec. 203. As used in this part and part 1:
- 17 (a) "Department" means the Michigan department of education.
- 18 (b) "District" means a local school district as that term is
- 19 defined in section 6 of the revised school code, 1976 PA 451, MCL
- 20 380.6, or a public school academy as that term is defined in
- 21 section 5 of the revised school code, 1976 PA 451, MCL 380.5.
- (c) "FTE" means full-time equated.
- 23 Sec. 204. The departments and agencies receiving
- 24 appropriations in part 1 shall use the internet to fulfill the
- 25 reporting requirements of this part. This requirement may include
- 26 transmission of reports via electronic mail to the recipients
- 27 identified for each reporting requirement, or it may include

- 1 placement of reports on an internet or intranet site.
- 2 Sec. 205. Funds appropriated in part 1 shall not be used for
- 3 the purchase of foreign goods or services, or both, if
- 4 competitively priced and of comparable quality American goods or
- 5 services, or both, are available. Preference shall be given to
- 6 goods or services, or both, manufactured or provided by Michigan
- 7 businesses, if they are competitively priced and of comparable
- 8 quality. In addition, preference should be given to goods or
- 9 services, or both, that are manufactured or provided by Michigan
- 10 businesses owned and operated by veterans, if they are
- 11 competitively priced and of comparable quality.
- Sec. 206. The state superintendent of public instruction shall
- 13 take all reasonable steps to ensure businesses in deprived and
- 14 depressed communities compete for and perform contracts to provide
- 15 services or supplies, or both. The state superintendent of public
- 16 instruction shall strongly encourage firms with which the
- 17 department contracts to subcontract with certified businesses in
- 18 depressed and deprived communities for services, supplies, or both.
- 19 Sec. 207. The departments and agencies receiving
- 20 appropriations in part 1 shall prepare a report on out-of-state
- 21 travel expenses not later than January 1 of each year. The travel
- 22 report shall be a listing of all travel by classified and
- 23 unclassified employees outside this state in the immediately
- 24 preceding fiscal year that was funded in whole or in part with
- 25 funds appropriated in the department's budget. The report shall be
- 26 submitted to the senate and house appropriations committees, the
- 27 house and senate fiscal agencies, and the state budget director.

- 1 The report must include the following information:
- 2 (a) The dates of each travel occurrence.
- 3 (b) The transportation and related costs of each travel
- 4 occurrence, including the proportion funded with state general
- 5 fund/general purpose revenues, the proportion funded with state
- 6 restricted revenues, the proportion funded with federal revenues,
- 7 and the proportion funded with other revenues.
- 8 Sec. 208. Funds appropriated in part 1 shall not be used by a
- 9 principal executive department, state agency, or authority to hire
- 10 a person to provide legal services that are the responsibility of
- 11 the attorney general. This prohibition does not apply to legal
- 12 services for bonding activities and for those outside services that
- 13 the attorney general authorizes.
- 14 Sec. 209. Not later than November 30, the state budget office
- 15 shall prepare and transmit a report that provides for estimates of
- 16 the total general fund/general purpose appropriation lapses at the
- 17 close of the prior fiscal year. This report shall summarize the
- 18 projected year-end general fund/general purpose appropriation
- 19 lapses by major departmental program or program areas. The report
- 20 shall be transmitted to the chairpersons of the senate and house
- 21 appropriations committees and the senate and house fiscal agencies.
- 22 Sec. 211. The department shall cooperate with the department
- 23 of technology, management, and budget to maintain a searchable
- 24 website accessible by the public at no cost that includes, but is
- 25 not limited to, all of the following for each department or agency:
- (a) Fiscal year-to-date expenditures by category.
- (b) Fiscal year-to-date expenditures by appropriation unit.

- 1 (c) Fiscal year-to-date payments to a selected vendor,
- 2 including the vendor name, payment date, payment amount, and
- 3 payment description.
- 4 (d) The number of active department employees by job
- 5 classification.
- 6 (e) Job specifications and wage rates.
- 7 Sec. 212. Within 14 days after the release of the executive
- 8 budget recommendation, the department shall cooperate with the
- 9 state budget office to provide the senate and house appropriations
- 10 chairs, the chairs of the senate and house appropriations
- 11 subcommittees responsible for the department budget, and the senate
- 12 and house fiscal agencies with an annual report on estimated state
- 13 restricted fund balances, state restricted fund projected revenues,
- 14 and state restricted fund expenditures for the fiscal years ending
- 15 September 30, 2019 and September 30, 2020.
- 16 Sec. 213. The department shall maintain, on a publicly
- 17 accessible website, a department scorecard that identifies, tracks,
- 18 and regularly updates key metrics that are used to monitor and
- 19 improve the department's performance.
- 20 Sec. 214. Total authorized appropriations from all sources
- 21 under part 1 for legacy costs for the fiscal year ending September
- 22 30, 2020 are estimated at \$14,654,400.00. From this amount, total
- 23 agency appropriations for pension-related legacy costs are
- 24 estimated at \$7,123,800.00. Total agency appropriations for retiree
- 25 health care legacy costs are estimated at \$7,530,600.00.
- 26 Sec. 215. The department shall provide through the internet
- 27 the state board of education agenda and all supporting documents,

- 1 and shall notify the state budget director and the senate and house
- 2 fiscal agencies that the agenda and supporting documents are
- 3 available on the internet, at the time the agenda and supporting
- 4 documents are provided to state board of education members.
- 5 Sec. 217. The department may assist the department of health
- 6 and human services, other departments, and local school districts
- 7 to secure reimbursement for eligible services provided in Michigan
- 8 schools from the federal Medicaid program. The department may
- 9 submit reports of direct expenses related to this effort to the
- 10 department of health and human services for reimbursement.
- 11 Sec. 219. From the funds appropriated in part 1, the
- 12 department shall ensure that kindergarten benchmark data include a
- 13 method for information to be provided regarding a child's
- 14 participation in the great start readiness program.
- 15 Sec. 220. The department shall post on its website a link to
- 16 the federal Institute of Education Sciences' What Works
- 17 Clearinghouse. The department also shall work to disseminate
- 18 knowledge about the What Works Clearinghouse to districts and
- 19 intermediate districts so that it may be used to improve reading
- 20 proficiency for pupils in grades K to 3.
- 21 Sec. 221. The department shall require all districts and
- 22 intermediate school districts to maintain complete records within
- 23 the personnel file of a teacher or school employee of any
- 24 disciplinary actions taken by the governing board against the
- 25 teacher or employee for sexual misconduct. The records shall not be
- 26 destroyed or removed from the teacher's or employee's personnel
- 27 file except as required by a court order.

- 1 Sec. 222. The department shall not take disciplinary action
- 2 against an employee who communicates truthfully and factually with
- 3 a member of the legislature or his or her staff.
- 4 Sec. 223. The department and agencies receiving appropriations
- 5 in part 1 shall receive and retain copies of all reports funded
- 6 from appropriations in part 1. Federal and state guidelines for
- 7 short-term and long-term retention of records shall be followed.
- 8 The department may electronically retain copies of reports unless
- 9 otherwise required by federal and state guidelines.
- 10 Sec. 225. (1) From the funds appropriated in part 1, the
- 11 department must comply with section 17c of the state school aid act
- 12 of 1979, 1979 PA 94, MCL 388.1617c.
- 13 (2) If the department fails to comply with subsection (1), the
- 14 state funds appropriated in part 1 for unclassified positions,
- 15 state board/superintendent operations, school support services
- 16 operations, and field services operations shall each be reduced by
- **17** 2.5%.
- 18 Sec. 226. From the funds appropriated in part 1, the
- 19 department shall coordinate with the other departments to
- 20 streamline state services and resources, reduce duplication, and
- 21 increase efficiency. This includes, but is not limited to, working
- 22 with the department of treasury to coordinate with the financial
- 23 independence team and overseeing deficit districts and working with
- 24 the department of health and human services and department of
- 25 licensing and regulatory affairs to coordinate with early childhood
- 26 programs and overseeing child care providers.
- 27 Sec. 227. (1) The department shall provide data requested by a

- 1 member of the legislature, his or her staff, or the house and
- 2 senate fiscal agencies in a timely manner. If the department fails
- 3 to provide reasonably requested data within 30 days after the
- 4 request, the state money appropriated in part 1 for state
- 5 board/superintendent operations shall be reduced by 1%.
- 6 (2) If the department fails to provide to the legislature
- 7 reports and other data required by boilerplate or statute within 30
- 8 days after the date the information is due, the state money
- 9 appropriated in part 1 for state board/superintendent operations
- 10 shall be reduced by 1%.
- 11 Sec. 229. The department shall not enter into a contract
- 12 funded under part 1 that exceeds \$1,000,000.00, submit federal
- 13 accountability plans, or request amendments to federal
- 14 accountability plans until after notification of the content to
- 15 both the house and senate appropriations committees and the state
- 16 budget director.
- Sec. 230. From the funds appropriated in part 1, the
- 18 department shall compile a report that identifies any new, or lack
- 19 thereof, mandates required of nonpublic schools. In compiling the
- 20 report, the department may consult with relevant statewide
- 21 education associations in Michigan. The report compiled by the
- 22 department shall indicate the type of mandate, including, but not
- 23 limited to, student health, student or building safety,
- 24 accountability, and educational requirements, and shall indicate
- 25 whether a school has to report on the specified mandates. The
- 26 report required under this section shall be completed by April 1,
- 27 2020 and transmitted to the state budget director, the house and

- 1 senate appropriations subcommittees responsible for the department
- 2 of education, and the senate and house fiscal agencies not later
- 3 than April 15, 2020.
- 4 Sec. 231. From the funds appropriated in part 1, the
- 5 department shall collect information from all school districts,
- 6 intermediate school districts, and public school academies that
- 7 have not adopted any policies that were specified by section 12b of
- 8 the child protection law, 1975 PA 238, MCL 722.632b, during the
- 9 fiscal year ending September 30, 2018, or that adopted new policies
- 10 specified by section 12b of the child protection law, 1975 PA 238,
- 11 MCL 722.632b, during the fiscal year ending September 30, 2019. The
- 12 information collected shall be reported to the house and senate
- 13 appropriations committees, the house and senate fiscal agencies,
- 14 and the state budget office. The report shall include a list of
- 15 each school district, intermediate school district, and public
- 16 school academy that has adopted each policy specified by section
- 17 12b of the child protection law, 1975 PA 238, MCL 722.632b.
- 18 Sec. 232. From the funds appropriated in part 1, the
- 19 department shall ensure that the most recently issued report of
- 20 regional in-demand occupations issued by the department of
- 21 technology, management, and budget is distributed in electronic or
- 22 paper form to all high schools in each school district,
- 23 intermediate school district, and public school academy.
- Sec. 233. (1) From the funds appropriated in part 1, the
- 25 department shall develop and implement a training program to
- 26 provide resources and programming to pupils in grades 9 to 12 who
- 27 are interested in a career in teaching and who are members of

- 1 groups that are underrepresented in the teaching profession in this
- 2 state.
- 3 (2) The department shall do all of the following with respect
- 4 to the training program developed and implemented under subsection
- 5 (1):
- 6 (a) Create a process for nomination and admission of pupils to
- 7 the program.
- 8 (b) Advertise the program.
- 9 (c) Invite postsecondary institutions in this state that

- 24 postsecondary teacher preparation programs.

- 26 (iii) Employment as a teacher.

1 STATE BOARD OF EDUCATION/OFFICE OF THE SUPERINTENDENT

- 2 Sec. 301. (1) The appropriations in part 1 may be used for per
- 3 diem payments to the state board for meetings at which a quorum is
- 4 present or for performing official business authorized by the state
- 5 board. The per diem payments shall be at a rate as follows:
- 6 (a) State board of education president \$110.00 per day.
- 7 (b) State board of education member other than president -
- **8** \$100.00 per day.
- 9 (2) A state board of education member shall not be paid a per
- 10 diem for more than 30 days per year.
- 11 Sec. 302. From the amount appropriated in part 1 to the state
- 12 board of education, not more than \$35,000.00 shall be expended in
- 13 the current fiscal year for in-state travel and out-of-state travel
- 14 directly related to the duties of the state board of education.

15 CENTRAL SUPPORT

- 16 Sec. 325. Within 10 days of the receipt of a grant
- 17 appropriated in the federal and private grants line item in part 1,
- 18 the department shall notify the house and senate chairpersons of
- 19 the appropriations subcommittees responsible for the department
- 20 budget, the house and senate fiscal agencies, and the state budget
- 21 director of the receipt of the grant, including the funding source,
- 22 purpose, and amount of the grant.

23 SPECIAL EDUCATION SERVICES

- 24 Sec. 350. From the funds in part 1 for special education
- 25 operations, the department shall use \$100,000.00 to design and

- 1 distribute to all parents and legal guardians of a student with a
- 2 disability information about federal and state mandates regarding
- 3 the rights and protections of students with disabilities,
- 4 including, but not limited to, individualized education programs to
- 5 ensure that parents and legal guardians are fully informed about
- 6 laws, rules, procedural safeguards, problem-solving options, and
- 7 any other information the department determines is necessary so
- 8 that parents and legal guardians may be able to provide meaningful
- 9 input in collaboration with districts to develop and implement an
- 10 individualized education program.

11 MICHIGAN SCHOOLS FOR THE DEAF AND BLIND

- 12 Sec. 401. The employees at the Michigan Schools for the Deaf
- 13 and Blind who work on a school-year basis are considered annual
- 14 employees for purposes of service credits, retirement, and
- 15 insurance benefits.
- 16 Sec. 402. For each student enrolled at the Michigan Schools
- 17 for the Deaf and Blind, the department shall assess the
- 18 intermediate school district of residence 100% of the cost of

- 18 outreach program for providing qualified services and may be used
- 19 for any expenses necessary to provide the qualified services. Any
- 20 money that is unexpended at the end of the current fiscal year may
- 21 be carried forward into the succeeding fiscal year.
- 22 (2) As used in this section, "qualified services" means
- 23 document reproduction and services; conducting conferences,
- 24 workshops, and training classes; and providing specialized
- 25 equipment, facilities, and software.
- 26 Sec. 409. When conducting a due process hearing resulting from
- 27 a parent's appeal of his or her child's individualized education

- 1 program team's decision on the child's educational placement, a

- 3 Michigan Schools for the Deaf and Blind as the least restrictive
- 4 environment under federal law for the parent's child who is deaf,
- 5 deafblind, or hard of hearing.

6 EDUCATOR EXCELLENCE

- 9 revocation/felony conviction files of educational personnel.
- 10 Sec. 503. From the funds appropriated in part 1, the
- 11 department shall, upon request, consult with the Michigan Virtual
- 12 Learning Research Institute and external stakeholders in connection
- 13 with the department's implementation and administration of
- 14 professional development training described in section 35a of the
- 15 state school aid act of 1979, 1979 PA 94, MCL 388.1635a, including,
- 16 but not limited to, the online training of educators of pupils in
- 17 grades K to 3 described in that section.
- 18 Sec. 506. Revenue received from teacher testing fees that is

14 EDUCATIONAL SUPPORTS

- 20 Sec. 702. From the funds appropriated in part 1 for
- 21 educational supports, funds shall only be used toward implementing
