PROVISIONS CONCERNING APPROPRIATIONS

GENERAL SECTIONS

28 Sec. 201. In accordance with section 30 of article IX of the
 29 state constitution of 1963, total state spending from state



1 resources in this appropriation act for the fiscal year ending
 2 September 30, 2020 is \$28,699,800.00. State appropriations paid to
 3 local units of government are \$17,762,900.00 as follows:

11 **MICHIGAN NATURAL RESOURCES TRUST FUND**

12 Sec. 301. (1) The department of natural resources shall enter
 13 into agreements with local units of government to administer the
 14 grants identified in part 1. Among other provisions, the agreements
 15 must require that grant recipients dedicate to public outdoor
 16 recreation uses in perpetuity the land acquired or developed; to
 17 replace lands converted from or lost to public outdoor recreation
 18 use; and, for parcels acquired that are larger than 5 acres, to
 19 provide this state with a nonparticipating 1/6 minimum royalty
 20 interest in any acquired minerals that are retained by the grant
 21 recipient.

22 (2) The agreements under subsection (1) must also provide that
 23 the full payments of grants be made only after proof of
 24 acquisition, or proof of completion of the development project, is
 25 submitted by the grant recipient and all costs are verified by the
 26 department of natural resources. This requirement may be waived by
 27 the department of natural resources.

28 Sec. 302. The appropriations in part 1 for capital outlay
 29 shall be carried forward at the end of the fiscal year consistent



1 with the provisions of section 248 of the management and budget
2 act, 1984 PA 431, MCL 18.1248.

3 Sec. 303. (1) The state share of the following capital outlay
4 appropriation authorized in 2018 PA 165 for a Michigan natural
5 resources trust fund project that has since been withdrawn by the
6 grantee is reduced up to the amount indicated and the money lapsed
7 for the purpose of redirecting resources to Michigan natural
8 resources trust fund projects appropriated in part 1:

11 (2) The state share of the following capital outlay
12 appropriation authorized in 2019 PA 12 for a Michigan natural
13 resources trust fund project that has since been withdrawn by the

15 for the purpose of redirecting resources to Michigan natural
16 resources trust fund projects appropriated in part 1:

20 (3) Any money lapsed under subsection (1) or (2) must be
21 returned to the funds from which originally appropriated and is
22 available for reappropriation.
