HOUSE BILL No. 5954

by amending section 135 (MCL 750.135), as amended by 2002 PA 689.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 135. (1) Except as provided in subsection (3), a father 2 or mother of a child under the age of 6 years, or another 3 individual, who exposes the child in any street, field, house, or other place, with intent to injure or wholly to abandon the child, 5 is quilty of a felony, punishable by imprisonment for not more than 6 10 years.
 - (2) Except for a situation involving actual or suspected child abuse or child neglect, it is an affirmative defense to a prosecution under subsection (1) that the child was not more than 72 hours 30 DAYS old and was surrendered to an emergency service

- 17 (B) (a) "Emergency service provider" means a uniformed
- 18 employee or contractor of a fire department, hospital, or police
- 19 station when that individual is inside the premises and on duty.
- 20 (C) (b)—"Fire department" means an organized fire department
- 21 as that term is defined in section 1 of the fire prevention code,
- 22 1941 PA 207, MCL 29.1.
- 23 (D) (c) "Hospital" means a hospital that is licensed under
- 24 article 17 of the public health code, 1978 PA 368, MCL 333.20101 to
- **25** 333.22260.
- 26 (E) "NEWBORN SAFETY DEVICE" MEANS THAT TERM AS DEFINED IN
- 27 SECTION 1 OF THE SAFE DELIVERY OF NEWBORNS LAW, MCL 712.1.

- 7 after the date it is enacted into law.
- 8 Enacting section 2. This amendatory act does not take effect
- 9 unless House Bill No. 5750 of the 99th Legislature is enacted into
- **10** law.
