A bill to amend 1931 PA 328, entitled

"The Michigan penal code,"

by amending sections 50 and 50b (MCL 750.50 and 750.50b), section 50 as amended by 2007 PA 152 and section 50b as amended by 2008 PA 339.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 50. (1) As used in this section and section 50b:
 (a) "Adequate care" means the provision of sufficient food,
 water, shelter, sanitary conditions, exercise, and veterinary
 medical attention in order to maintain an animal in a state of good
 health.

6 (b) "Animal" means any A vertebrate other than a human being.

7 (c) "Animal protection shelter" means a facility operated by a
8 person, humane society, society for the prevention of cruelty to

animals, or any other nonprofit organization, for the care of
 homeless animals.

3 (d) "Animal control shelter" means a facility operated by a
4 county, city, village, or township to impound and care for animals
5 found in streets or otherwise at large contrary to any AN ordinance

7 (E) "BREEDER" MEANS A PERSON THAT BREEDS ANIMALS OTHER THAN
8 LIVESTOCK OR DOGS FOR REMUNERATION, OR THAT IS A LARGE-SCALE DOG
9 BREEDING KENNEL AS THAT TERM IS DEFINED IN SECTION 1 OF 1969 PA
10 287, MCL 287.331.

11 (F) (e) "Licensed veterinarian" means a person licensed OR
12 OTHERWISE AUTHORIZED to practice veterinary medicine under article
13 15 of the public health code, 1978 PA 368, MCL 333.16101 to
14 333.18838.

15 (G) (f) "Livestock" means that term as defined in SECTION 5 OF 16 the animal industry act, of 1987, 1988 PA 466, MCL 287.701 to 17 287.747.287.705.

18 (H) (g) "Person" means an individual, partnership, limited
19 liability company, corporation, association, governmental entity,
20 or other legal entity.

(I) "PET SHOP" MEANS THAT TERM AS DEFINED IN SECTION 1 OF 1969
PA 287, MCL 287.331.

(J) (h) "Neglect" means to fail to sufficiently and properly
care for an animal to the extent that the animal's health is
jeopardized.

26 (K) (i) "Sanitary conditions" means space free from health
 27 hazards including excessive animal waste, overcrowding of animals,

or other conditions that endanger the animal's health. This
 definition does not include any condition resulting from a
 customary and reasonable practice pursuant to farming or animal
 husbandry.

5 (1) (j) "Shelter" means adequate protection from the elements
6 and weather conditions suitable for the age, species, and physical
7 condition of the animal so as to maintain the animal in a state of
8 good health. Shelter, for livestock, includes structures or natural
9 features such as trees or topography. Shelter, for a dog, includes
1 or more of the following:

11

(i) The residence of the dog's owner or other individual.

12 (*ii*) A doghouse that is an enclosed structure with a roof and 13 of appropriate dimensions for the breed and size of the dog. The 14 doghouse shall MUST have dry bedding when the outdoor temperature 15 is or is predicted to drop below freezing.

16 (*iii*) A structure, including a garage, barn, or shed, that is 17 sufficiently insulated and ventilated to protect the dog from 18 exposure to extreme temperatures or, if not sufficiently insulated 19 and ventilated, contains a doghouse as provided under subparagraph 20 (*ii*) that is accessible to the dog.

(M) (k) "State of good health" means freedom from disease and illness, and in a condition of proper body weight and temperature for the age and species of the animal, unless the animal is undergoing appropriate treatment.

25 (N) (*l*)—"Tethering" means the restraint and confinement of a
26 dog by use of a chain, rope, or similar device.

27

(O) (m) "Water" means potable water that is suitable for the

age and species of animal AND that is made regularly available
 unless otherwise directed by a licensed veterinarian.

3 (2) An owner, possessor, BREEDER, OPERATOR OF A PET SHOP, or
4 person having the charge or custody of an animal shall not do any
5 of the following:

(a) Fail to provide an animal with adequate care.

7 (b) Cruelly drive, work, or beat an animal, or cause an animal8 to be cruelly driven, worked, or beaten.

9 (c) Carry or cause to be carried in or upon a vehicle or
10 otherwise any live animal having the feet or legs tied together,
11 other than an animal being transported for medical care - or a
12 horse whose feet are hobbled to protect the horse during transport,
13 or in any other cruel and inhumane manner.

14 (d) Carry or cause to be carried a live animal in or upon a 15 vehicle or otherwise without providing a secure space, rack, car, 16 crate, or cage - in which livestock may stand - and in which all 17 other animals may stand, turn around, and lie down during 18 transportation, or while awaiting slaughter. As used in this 19 subdivision, for purposes of transportation of sled dogs, "stand" 20 means sufficient vertical distance to allow the animal to stand 21 without its shoulders touching the top of the crate or 22 transportation vehicle.

(e) Abandon an animal or cause an animal to be abandoned, in
any place, without making provisions for the animal's adequate
care, unless premises are vacated for the protection of human life
or the prevention of injury to a human. An animal that is lost by
an owner or custodian while traveling, walking, hiking, or hunting

is not abandoned under this section when the owner or custodian has
 made a reasonable effort to locate the animal.

3 (f) Negligently allow any animal, including one who is aged,
4 diseased, maimed, hopelessly sick, disabled, or nonambulatory to
5 suffer unnecessary neglect, torture, or pain.

6 (q) Tether a dog unless the tether is at least 3 times the length of the dog as measured from the tip of its nose to the base 7 of its tail and is attached to a harness or nonchoke collar 8 designed for tethering. THIS SUBDIVISION DOES NOT APPLY IF THE 9 TETHERING OF THE DOG OCCURS WHILE THE DOG IS BEING GROOMED, 10 11 TRAINED, TRANSPORTED, OR USED IN A HUNT OR EVENT WHERE A SHORTER 12 TETHER IS NECESSARY FOR THE SAFETY AND WELL-BEING OF THE DOG AND 13 OTHERS.

14 (3) If an animal is impounded and is being held by an animal control shelter or its designee or an animal protection shelter or 15 16 its designee or a licensed veterinarian pending the outcome of a 17 criminal action charging a violation of this section or section 18 50b, before final disposition of the criminal charge, the 19 prosecuting attorney may file a civil action in the court that has 20 jurisdiction of the criminal action, requesting that the court 21 issue an order forfeiting the animal to the animal control shelter 22 or animal protection shelter or to a licensed veterinarian before 23 final disposition of the criminal charge. The prosecuting attorney 24 shall serve a true copy of the summons and complaint upon the 25 defendant and upon a person with a known ownership interest or 26 known security interest in the animal or a person who has filed a 27 lien with the secretary of state in an ON THE animal. involved in

the pending action. The forfeiture of an animal under this section 1 2 encumbered by a security interest is subject to the interest of the holder of the security interest who-IF HE OR SHE did not have prior 3 4 knowledge of - or **DID NOT** consent to the commission of the crime. 5 Upon the filing of the civil action, the court shall set a hearing on the complaint. The hearing shall MUST be conducted within 14 6 days of the filing of the civil action, or as soon as practicable. 7 The hearing shall MUST be before a judge without a jury. At the 8 9 hearing, the prosecuting attorney has the burden of establishing by a preponderance of the evidence that a violation of this section or 10 11 section 50b occurred. If the court finds that the prosecuting 12 attorney has met this burden, the court shall order immediate forfeiture of the animal to the animal control shelter or animal 13 14 protection shelter or the licensed veterinarian unless the defendant, within 72 hours of the hearing, submits to the court 15 clerk cash or other form of security in an amount determined by the 16 17 court to be sufficient to repay all reasonable costs incurred, and anticipated to be incurred, by the animal control shelter or animal 18 19 protection shelter or the licensed veterinarian in caring for the 20 animal from the date of initial impoundment to the date of trial. 21 If cash or other security has been submitted, and the trial in the 22 action is continued at a later date, any order of continuance shall 23 MUST require the defendant to submit additional cash or security in 24 an amount determined by the court to be sufficient to repay all 25 additional reasonable costs anticipated to be incurred by the 26 animal control shelter or animal protection shelter or the licensed 27 veterinarian in caring for the animal until the new date of trial.

If the defendant submits cash or other security to the court under 1 2 this subsection the court may enter an order authorizing the use of that money CASH or other security before final disposition of the 3 4 criminal charges to pay the reasonable costs incurred by the animal 5 control shelter or animal protection shelter or the licensed 6 veterinarian in caring for the animal from the date of impoundment to the date of final disposition of the criminal charges. The 7 testimony of a person at a hearing held under this subsection is 8 9 not admissible against him or her in any criminal proceeding except 10 in a criminal prosecution for perjury. The testimony of a person at 11 a hearing held under this subsection does not waive the person's 12 constitutional right against self-incrimination. An animal seized under this section or section 50b is not subject to any other civil 13 14 action pending the final judgment of the forfeiture action under this subsection. 15

THE PERSON IS GUILTY OF A FELONY PUNISHABLE BY 1 OR MORE OF THE
FOLLOWING AND MAY BE ORDERED TO PAY THE COSTS OF PROSECUTION:

- 26 (*ii*) A FINE OF NOT MORE THAN \$10,000.00.

6 (5) The court may order a person convicted of violating
7 subsection (2) to be evaluated to determine the need for
8 psychiatric or psychological counseling and, if determined
9 appropriate by the court, to receive psychiatric or psychological
10 counseling. The evaluation and counseling shall MUST be at the
11 defendant's own expense.

12 (6) This section does not prohibit a person from being charged 13 with, convicted of, or punished for any other violation of law 14 arising out of the same transaction as the violation of this 15 section.

applicable. If the court does not order a defendant to pay all of
the applicable costs listed in this subsection, or orders only
partial payment of these costs, the court shall state on the record
the reason for that action.
