SUBSTITUTE FOR SENATE BILL NO. 1188

A bill to prohibit local units of government from adopting or enforcing certain ordinances or charter provisions, including those prohibiting or restricting removal of trees or other vegetation; and to provide the powers and duties of certain local officials.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "vegetation removal preemption act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Enforce an ordinance, charter provision, or regulation"
- 5 means to prosecute, sue, ticket, or fine a person for a violation
- 6 of, or otherwise subject a person to, an ordinance, charter
- 7 provision, or regulation.
- 8 (b) "Heritage tree" means a tree that meets the following

- 2 (i) Is not diseased, dying, or otherwise a threat to
- 3 structures or human safety.
- 4 (ii) Is one of the following trees of at least the following
- 5 diameter in inches, measured at 4.5 feet above the highest ground
- 6 at the base of the tree:
- 7 (A) Basswood (*Tilia* L.), 36.
- 8 (B) Beech (Fagus L.), 30.
- 9 (C) Birch (Betula L.), 30.
- 10 (D) Cherry species, 30.
- 11 (E) Chestnut (Castanea Mill.), 16.
- 12 (F) Eastern hemlock (Tsuga canadensis (L.) Carrière), 20.
- 13 (G) Eastern red cedar (Juniperus virginiane L.), 20.
- 14 (H) Kentucky coffeetree (Gymnocladus dioicus (L.) K. Koch),
- **15** 30.
- 16 (I) Hickory (*Carya* Nutt.), 30.
- 17 (J) Locust (Robinia L.), 36.
- 18 (K) Maple (Acer L.), except boxelder (Acer negundo L.) and
- 19 silver maple (Acer saccharinum L.), 30.
- 20 (L) Oak (Quercus L.), 36.
- 21 (M) Sassafras (Sassafras albidum (Nutt.) Nees), 20.
- 22 (N) Sycamore (Platanus L.), 30.
- 23 (O) Tamarack (Larix laricina (Du Roi) K. Koch), 20.
- **24** (P) Walnut (*Juglans* L.), 30.
- 25 (Q) White pine (Pinus strobus L.), 24.
- 26 (c) "Local unit of government" means a city, village,
- 27 township, or charter township.

- 1 Sec. 5. (1) A local unit of government shall not adopt,
- maintain, or, for violations occurring on or after <<
 effective date of this act,>>
- 3 enforce an ordinance, charter provision, or regulation that does
- 4 any of the following, and an ordinance, charter provision, or
- 5 regulation that does any of the following is void:
- 6 (a) Prohibits, requires approval for, or otherwise restricts
- 7 the trimming, felling, or removal of any vegetation, other than a
- 8 heritage tree, located on private property with an agricultural,
- 9 business, commercial, or industrial zoning classification.
- 10 (b) Requires mitigation, including, but not limited to, the
- 11 planting of trees or other vegetation or the payment of a fee or
- 12 fine, for the trimming, felling, or removal of any vegetation,
- 13 other than a heritage tree, from private property with an
- 14 agricultural, business, commercial, or industrial zoning
- 15 classification.
- 16 (2) Subsection (1) does not require a local unit of government
- 17 to refund any fee, fine, or costs received by the local unit of
- 18 government before the enactment date of this act as a result of the
- 19 enforcement of an ordinance or charter provision described in
- 20 subsection (1).
- Sec. 7. This act shall not be construed to do any of the
- 22 following:
- 23 (a) Prohibit a local unit of government from adopting,
- 24 maintaining, or enforcing an ordinance, charter provision, or
- 25 regulation that does any of the following:
- 26 (i) Requires private property to be maintained in a healthy,
- 27 neat, and orderly appearance free from noxious weeds, invasive

- 1 vegetation, excessive lawn grass, refuse, and debris.
- 2 (ii) Provides property owners the voluntary option to preserve
- 3 or maintain trees or vegetation as part of a site plan, planned
- 4 unit development agreement, cluster development plan, or other
- 5 provision of a zoning ordinance adopted under the Michigan zoning
- 6 enabling act, 2006 PA 110, MCL 125.3101 to 125.3702, related to the
- 7 development or redevelopment of a site in exchange for reduction of
- 8 other restrictions in the zoning ordinance.
- 9 (iii) Restricts or allows trimming or removal of trees or
- 10 vegetation on public property or within a public right-of-way.
- 11 (iv) Allows trimming or removal of trees or other vegetation
- 12 within easements or locations that would enhance clear vision or
- 13 other traffic safety considerations.
- 14 (b) Prohibit a local unit of government from entering into a
- 15 voluntary planned unit development agreement with a private
- 16 landowner consistent with section 503 of the Michigan zoning
- 17 enabling act, 2006 PA 110, MCL 125.3503.
- 18 (c) Conflict with any of the following:
- 19 (i) State or federal stormwater management, floodplain, or
- 20 soil erosion and sedimentation control requirements including those
- 21 contained within part 31 of the natural resources and environmental
- 22 protection act, 1994 PA 451, MCL 324.3101 to 324.3134, or part 91
- 23 of the natural resources and environmental protection act, 1994 PA
- 24 451, MCL 324.9101 to 324.9123a.
- 25 (ii) The drain code of 1956, 1956 PA 40, MCL 280.1 to 280.630.
- 26 (iii) The insect pest and plant disease act, 1931 PA 189, MCL
- 27 286.201 to 286.228.

- 1 (d) Exempt property owners from continued compliance with tree
- 2 or vegetation requirements contained in site plans, including site
- 3 plans adopted as part of a planned unit development agreement or
- 4 cluster development plan, adopted on or before the enactment date
- **5** of this act.
- 6 (e) Prohibit a local unit of government from requiring tree or
- 7 vegetation greenbelts within property boundary setbacks or in
- 8 parking lots pursuant to a zoning ordinance adopted under the
- 9 Michigan zoning enabling act, 2006 PA 110, MCL 125.3101 to
- **10** 125.3702.
- 11 Enacting section 1. This act takes effect 90 days after the
- 12 date it is enacted into law.
