**Overview**

2020 PA 66, Senate Bill 151, contains supplemental appropriation adjustments for multiple budget areas for FY 2019-20. In sum, FY 2019-20 adjustments would increase Gross appropriations by \$144.7 million and increase GF/GP appropriations by \$100.7 million.

Appropriation and boilerplate priorities initiated by the State Budget Office and by the legislature are identified following this overview.

<b>7. Glen Oaks Community College – Campus Renovation – VETOED</b>	<b>Gross</b>	<b>\$0</b>
The Campus Renovation project at Glen Oaks Community College has a total cost of \$7.3 million; a total state share of \$3.5 million; and a total college share of \$3.8 million. The project cost is \$350,000 more than the estimated cost included in the planning authorization which would be covered by the community college. The increased cost is the result of the increased complexity of building system components and equipment in the renovated spaces. The project would involve renovation of 167,188 sq. ft. of the Library, Art Studio, and the Auto, Manufacturing, Electrical and Welding Laboratories. The facility was constructed in 1969. The laboratories would be upgraded with technological improvements that would better train students in skilled trades. A host of building improvements would be made including replacement of 50 year old windows, improved exterior wall insulation, improved ADA accessibility, and upgraded classrooms to provide modern instruction technology. <b>8. Macomb Community College – Skilled Trades and Advanced Technology Center – VETOED</b>	<b>Gross</b>	<b>\$0</b>
The Skilled Trades and Advanced Technology Center Renovation project at Macomb Community College has a total cost of \$44.8 million; a total state share of \$14.8 million; and a total college share of \$29.9 million. The project cost is \$4.7 million more than the estimated cost included in the planning authorization which would be covered by the community college. The increased cost is the result of the economic and construction market cost increases in Southeast Michigan. The project would involve renovation and addition of approximately 139,250 sq. ft. of the existing Skilled Trades and Advanced Technology Center. The addition would expand classrooms and technical lab spaces for various manufacturing fields. 110,000 sq. ft. of roofing would be replaced. The building would be upgraded to meet ADA accessibility standards. Windows and the ceiling system would be replaced with more energy efficient options. The HVAC system would be replaced, along with bathroom and water fountain fixtures. Various electrical system components would be upgraded. The Center would also feature upgraded Giga Speed cable, additional Wi-Fi capacity, improved flexible classroom space and security camera coverage. **9. Ferris State University – Center for Virtual Learning – VETOED**

The Center for Virtual Learning project at Ferris State University has a total cost of \$29.5 million; a total state share of \$22.1 million; and a total university share of \$7.4 million. The project would involve demolition of Bishop Hall and renovation and expansion of approximately 60,395 sq. ft. of Vandercook Hall. Renovation would increase the number of classrooms, laboratories, faculty offices and administrative spaces in a more centralized location and would be rebranded as the Center for Virtual Learning. Computer laboratories, online learning facilities and digital media production facilities would be expanded and provided more modern spaces. The project would include high efficiency lighting, high efficiency HVAC systems, and interior-finish materials that feature high recycled content. Bishop Hall, which has safety and structural issues such as water leakage, outdated elevators and a HVAC system that causes mold, would be torn down. The project was approved for planning authorization in 2018 PA 618.

**10. Northern Michigan University – Career Tech and Engineering Technology Facility – VETOED**

The Career Tech and Engineering Technology Facility project at Northern Michigan University has a total cost of \$28.6 million; a total state share of \$20.0 million; and a total university share of \$8.6 million. The project would involve the renovation of the 216,870 sq. ft. Career Tech and Engineering Technology Facility and would remove 43,000 sq. ft. of space. The renovation would include improving existing classrooms and industrial and service career laboratories to become more flexible, movable, and more interactive. Portions of the building's HVAC, electrical, and building control systems would be exposed to provide for a living laboratory. HVAC, air handling and lighting systems would be upgraded. Informal learning areas would be added along with a new educational manufacturing design center. The project was approved for planning authorization in 2018 PA 618.

**11. Oakland University – South Foundation Hall Renovation and Expansion – VETOED**

The South Foundation Hall Renovation and Expansion project at Oakland University has a total cost of \$40.0 million; a total state share of \$30.0 million; and a total university share of \$10.0 million. The project would involve renovation of 49,645 sq. ft. of South Foundation Hall, constructed in 1958, and an approximately 41,455 sq. ft. addition that would add new active-learning classroom space, student support services offices, and workspace for faculty members. The renovation portion of the project includes transforming classroom space with new furniture, finishes, and technology updates to provide more flexibility. HVAC, electrical systems, plumbing, and fire suppression systems would also be upgraded. The project was approved for planning authorization in 2018 PA 618.

**CORRECTIONS**

**12. John Does v Department of Corrections Settlement**

Includes \$25.0 million GF/GP for the first payment agreed to in the *John Does v Department of Corrections* settlement. The case involved approximately 1,300 members that were incarcerated October 2010 through the date of the settlement. The lawsuits claimed a variety of injuries including sexual assault and harassment, inappropriate use of segregation, and deprivation of educational and rehabilitative experiences due to the young age of the members. The case settled for \$80.0 million total inclusive of attorney fees and costs. The remaining payments will be made as follows: \$15.0 million on October 15, 2020; \$25.0 million on October 15, 2021; and \$15.0 million on October 15, 2022.

**Sec. 201. State Spending and State Appropriations Paid to Local Units of Government**

Estimates total state spending from state sources and payments to be made to local units of government.

**Sec. 202. Appropriations Subject to Management and Budget Act**

Subjects appropriations to the Management and Budget Act, 1984 PA 431.

## **FY 2019-20 Supplemental Boilerplate Items**

### ***Sec. 203. State Administrative Board Transfers***

Authorizes the legislature, by a concurrent resolution adopted by a majority of the members elected to and serving in each house, to inter-transfer funds if the State Administrative Board transfers funds.

### ***Sec. 204. Appropriation of Federal Revenues for Coronavirus-19***

Appropriates up to \$50.0 million of federal revenues for Coronavirus-19 to departments for state and local preparedness and response activities; requires departments receiving federal funds to report on the amount of funds received, the types of activities supported with the funds, and the amount of funds expended.

## **AGRICULTURE AND RURAL DEVELOPMENT**

### ***Sec. 301. County Fair Capital Grant Program – VETOED***

Establishes criteria for the county fair capital grant program, including matching requirements.

### ***Sec. 302. Festivals and Events – VETOED***

Requires \$50,000 to be used for the promotion of festivals and events.

## **ATTORNEY GENERAL**

### ***Sec. 351. Litigation Expense Reimbursements***

Appropriates up to \$500,000 from litigation expense reimbursements for court fees and legal costs assessed against the Governor, the office of the Governor, the Attorney General, and the office of the Attorney General when acting as the named party in litigation against the state; authorizes unexpended funding, up to \$250,000, to be carried forward.

### ***Sec. 352. Clergy Abuse Investigation – VETOED***

Requires funding to be expended for victim advocacy services for victims of abuse by members of the clergy, managing documents related to the church investigation, and costs associated with internal investigators to complete the investigation; designates unexpended funds as a work project account and authorizes unexpended funds to carry forward.

## **CAPITAL OUTLAY**

### ***Sec. 401. Public Purpose, Lease and Conveyance, and Annual Appropriation for Capital Outlay – VETOED***

States that the legislature determines that leases for SBA-financed facilities are for a public purpose, as authorized by the State Building Authority Act of 1964; legislature approves and authorizes leases and conveyances of property to the SBA and from the SBA to state and educational institutions, as applicable, executed by the Governor and Secretary of State on behalf of the state; expresses intent of the legislature to annually appropriate sufficient amounts to pay rent obligations pursuant to the lease.

### ***Sec. 402. North Central Michigan College – AD/CL Classroom Renovation and Expanded Learning Space Project Scope Revision***

Provides for a revised scope for the North Central Michigan College – AD/CL Classroom Renovation and Expanded Learning Space project that was approved for construction authorization in 2018 PA 207, and a revised project cost and scope change in 2018 PA 618 at a total project cost of \$7.4 million; a state share of \$3.4 million; and a college share of \$4.0 million. The scope change removes a 1,740 sq. ft. addition and removes some renovated office space from the project to maintain the overall project construction cost at \$7.4 million.

### ***Sec. 403. Schoolcraft College – Applied Science Renovation and Expansion Project Cost Increase and Scope Revision***

Provides for a \$2.8 million cost increase and a revised scope for the Schoolcraft College – Applied Science Renovation and Expansion project that was approved for construction authorization in 2018 PA 618 at a total project cost of \$21.5 million; a state share of \$10.0 million; and a college share of \$11.5 million. The college would be responsible for funding the entire cost increase resulting in a college share of \$14.3 million and a total project cost of \$24.3 million. The cost increase is the result of adding four health profession programs that increases equipment, furniture, and construction costs. The scope change removes the fitness leadership and massage therapy academic programs and adds 1,800 sq. ft to the project.

### ***Sec. 404. Washtenaw Community College – Advanced Transportation Center Project Cost Increase and Scope Revision***

Provides for a \$2.2 million cost increase and a revised scope for the Washtenaw Community College – Advanced Transportation Center project that was approved for construction authorization in 2018 PA 207 at a total project cost of \$5.7 million; a state share of \$2.0 million and a community college share of \$3.7 million. The community college would be responsible for funding the entire cost increase resulting in a community college share of \$5.9 million and a total project cost of \$7.9 million. The cost increase is the result of increased labor and construction material costs and the addition of a second-story to the project. The scope change adds 1,107 sq. ft. to the project through the addition of a second story to the design.

### ***Sec. 405. Lake Superior State University – Center for Freshwater Research and Education Project Cost Increase***

Provides for a \$1.0 million cost increase for the Lake Superior State University – Center for Freshwater Research and Education project that was approved for construction authorization in 2018 PA 207 at a total project cost of \$13.2 million; a state share of \$8.8 million; and a university share of \$4.4 million. The university would be responsible for funding the entire cost increase resulting in a university share of \$5.4 million and a total project cost of \$14.2 million. The cost increase is the result of increased construction material costs, single contractor bids, and the increased HVAC and mechanical equipment costs.

### ***Sec. 406. State Capitol Restoration/Infrastructure Upgrade Project – VETOED***

Provides for a \$5.0 million cost increase and a revised project scope for the Michigan State Capitol Commission – State Capitol Restoration/Infrastructure project. The project would be revised to include the addition of parking infrastructure to the Michigan State Capitol grounds.

## **ENVIRONMENT, GREAT LAKES, AND ENERGY**

### ***Sec. 451. Environmental Cleanup Support***

Authorizes unexpended funds appropriated for Environmental Cleanup Support to be considered work project appropriations and carried forward into succeeding fiscal year; program would perform contaminated site cleanups estimated to cost \$2.0 million with a tentative completion date of September 30, 2022.

### ***Sec. 452. Superfund Cleanup***

Authorizes unexpended funds appropriated for Superfund Cleanup to be considered work project appropriations and carried forward into succeeding fiscal year; program would perform contaminated site cleanups estimated to cost \$3.0 million with a tentative completion date of September 30, 2023.

### ***Sec. 453. Scrap Tire Grants – Alpena – VETOED***

Requires \$3.0 million to be used to expand the Scrap Tire Market Development Grant Program.

### ***Sec. 454. EPA Containment Study – VETOED***

Requires the department to award \$100,000 for a United States Environmental Protection Agency containment study.

### ***Sec. 455. Michigan Geological Survey – VETOED***

Requires the department to award \$500,000 for the Michigan Geological Survey at Western Michigan University.

### ***Sec. 456. Multistate Aquifer Study – VETOED***

Requires the department, in coordination with the United States Geological Survey, to award \$500,000 to support a study, including the acquisition of necessary equipment, to determine an estimated storage capacity and maximum yield of the Michindoh Aquifer.

## **HEALTH AND HUMAN SERVICES**

### ***Sec. 501. Child Advocacy Centers – VETOED***

Requires funding for child advocacy centers to be allocated for operations and for increased services for victims and their families.

### ***Sec. 502. School Success Partnership Program – VETOED***

Allocates \$250,000 to the Northeast Michigan Community Services Agency for the School Success Partnership Program; requires report.

### ***Sec. 503. Parent-to-Parent Program – VETOED***

Allocates \$250,000 to the Adoptive Family Support Network for the Parent-to-Parent Program for adoptive parents; requires report.

### ***Sec. 504. Adoption Services Rate Increase – VETOED***

Requires that \$700,000 GF/GP and any eligible federal matching funds be used to provide up to a 6.5% increase to private adoption agency rates for adoption support services.

### ***Sec. 505. Traumatic Brain Injury – VETOED***

Allocates \$1.5 million from the Injury Control Intervention Project line item for implementation of software in the assessment and treatment of traumatic brain injuries in hospital settings.

### ***Sec. 506. Cloud-Based Analytics – VETOED***

Requires DHHS to contract for a cloud-based analytics platform to assess behavioral health services data; specifies program requirements.

### ***Sec. 507. Private Duty Nursing Services – VETOED***

Requires DHHS to provide a 15% pay rate increase to private duty nurses providing services to Medicaid recipients under the age of 21.

### ***Sec. 508. Non-Critical Access Hospitals***

Requires DHHS to award rural access payments to non-critical access hospitals that provide services to low-income residents of rural areas; specifies distribution formula.

### ***Sec. 509. CCWIS Software Development – VETOED***

Requires DHHS to utilize the agile software development model in the development of the Comprehensive Child Welfare Information System modules, to be the proprietor of CCWIS software, or commit the software to the public domain, to designate an employee with child welfare experience as the product owner, and to report on who was chosen as the designee; requires in-person updates every other month and written reports in the off months on software development progress; specifies definitions of terms used in the section.

## **FY 2019-20 Supplemental Boilerplate Items**

### ***Sec. 510. Hackley Community Care – VETOED***

Requires DHHS to allocate \$2.0 million for Hackley Community Care federally qualified health center (FQHC) to ensure continued access to health services for patients previously served through Muskegon Family Care; requires federal funding to be expended first.

### ***Sec. 511. Human Trafficking Survivors Assistance – VETOED***

Requires DHHS to allocate \$1.0 million to support 2 long-term women's shelters for survivors of human trafficking.

### ***Sec. 512. Homeless and Runaway Youth Programs – VETOED***

Requires DHHS to allocate \$800,000 for current programs that provide services for runaway and homeless youth.

### ***Sec. 513. Senior Community Health Improvement Grant – VETOED***

Allocates \$100,000 for a one-time grant for senior community health improvement programming and infrastructure needs projects to the City of Livonia.

### ***Sec. 514. SAFE Substance Abuse Coalition – VETOED***

Requires DHHS to allocate \$100,000 to SAFE Substance Abuse Coalition for community and school outreach related to drug addiction.

### ***Sec. 515. Unified Clinics Resiliency Center for Families and Children – VETOED***

Requires DHHS to allocate \$1.4 million to develop and operate a resiliency center for families and children to provide services for those experiencing trauma and related conditions; requires report.

## **LABOR AND ECONOMIC OPPORTUNITY**

### ***Sec. 551. Michigan Defense Industry Economic Development – VETOED***

Requires \$500,000 to be used to support economic development in the Michigan defense industry.

### ***Sec. 552. Dropout Support and Career Training Grant – VETOED***

Requires \$375,000 to be used to support a program to assist adults over the age of 23 with obtaining high school diplomas and placement in career training programs; provides requirements to qualify as an eligible program provider; provides detailed reimbursement rates for certain performance measures.

### ***Sec. 553. Going Pro Expenditure Report – VETOED***

Requires the department to report on Going Pro expenditures by program/grant type for the prior fiscal year and to provide a projected expenditure report by program/grant type for the current fiscal year.

### ***Sec. 554. Going Pro Program – VETOED***

Requires the department to publish data and reports on the Going Pro Program; requires the department to expand workforce training and re-employment services to better connect workers to in-demand jobs and identify specific outcomes with performance metrics for this initiative.

### ***Sec. 555. Going Pro Administration – VETOED***

Requires Going Pro to be administered according to specific guidelines outlined in boilerplate; authorizes up to \$5.0 million of funds appropriated for Going Pro to be used for matching funds when federal funds requiring a match become available; expresses that the intent of the funds is to increase the skill level of employees in skilled trades and to address in-demand talent needs in Michigan.

### ***Sec. 556. Going Pro Talent Fund – VETOED***

Authorizes funds appropriated for Going Pro to be deposited into the Going Pro Talent Fund; states that if the funds are deposited, they are considered available for expenditure under the Going Pro Talent Fund Act.

### ***Sec. 557. Pure Michigan Slogan Revenue – VETOED***

Authorizes Travel Michigan to receive and expend private revenue related to use of copyrighted slogans and images; requires revenue generated to be used to market the state as a travel destination; requires report on source of revenues received if the fund receives revenue from the use of "Pure Michigan."

### ***Sec. 558. Electronic Recording Commission – VETOED***

Requires the Electronic Recording Commission to expend up to \$200,000 for FY 2019-20 and the two subsequent years for grants to counties to facilitate or upgrade real property e-recording capabilities; requires grants to be awarded following application to and approval by the commission; prohibits grants from exceeding \$12,000 per request; requires grants to be used to invest or upgrade software necessary for the electronic recording of real property documents.

### **Sec. 560. Michigan Enhancement Grants Distribution Process – VETOED**

Requires MSF to execute a grant agreement with each recipient of a Michigan enhancement grant; requires 50% of grant funds to be disbursed upon execution of grant agreement; specifies requirements of grant agreement; requires grantees to respond to all reasonable requests for information; requires grants to be disbursed by September 30, 2022; requires funds to be returned to the state treasury if sufficient information is not provided by grantee; requires MSF to provide quarterly updates.

### **Sec. 561. Michigan Reconnect Grant Program – VETOED**

Provides requirements for the Michigan Reconnect Grant program; states that funds will only be available after House Bills 5576 and 5580 and Senate Bill 268 are enacted into law; requires the department to allocate 10.0 FTE positions for navigators who provide support services and 2.0 FTE positions for oversight and implementation of the program.

### **Sec. 562. Museums Support – VETOED**

Allocates \$500,000 to each of the following: Arab American National Museum in Dearborn, Charles H. Wright Museum of African American History in Detroit, and Holocaust Memorial Center in Farmington Hills.

## **MILITARY AND VETERANS AFFAIRS**

### **Sec. 601. Buddy-to-Buddy Program – VETOED**

Requires funding to be used to train volunteer veterans to provide outreach and support for other service members and veterans dealing with challenges related to finances, securing benefits, legal issues, education, and health, family, and emotional concerns.

## **NATURAL RESOURCES**

### **Sec. 651. State Parks – Michigan Conservation Corps – VETOED**

Requires appropriation to be used for re-establishing the Michigan Conservation Corps.

### **Sec. 652. Brandon Road Lock and Dam – VETOED**

Appropriates and permits interest or earnings deposited into the Michigan Infrastructure Fund to be used for Brandon Road Lock and Dam.

## **FY 2019-20 Supplemental Boilerplate Items**

### **Sec. 653. *Blanchard Dam Bond Inspection and Repair Needs Study* – VETOED**

Appropriates funding to DNR to conduct a study of repair needs and inspection at Blanchard Dam in Isabella County.

### **Sec. 654. *Boat Launch/Marina Grants – Linden Mill Pond Launch* – VETOED**

Authorizes up to \$30,000 for kayak launch upgrades at Linden Mill Pond Launch.

### **Sec. 655. *Boat Launch/Marina Grants – Cedar River Marina* – VETOED**

Authorizes up to \$970,000 for improving access to the Cedar River and Lake Leelanau.

## **STATE**

### **Sec. 701. *Branch Security Program* – VETOED**

Authorizes unexpended funds appropriated for branch office security to be considered a work project appropriation for purpose of improving security at Secretary of State branch offices; authorizes unexpended funds to carry forward.

## **TECHNOLOGY, MANAGEMENT, AND BUDGET**

### **Sec. 751. *Venture Michigan Fund II Voucher Purchase***

Authorizes State Budget Director to purchase tax vouchers that meet criteria described in the section; authorizes expenditure of \$19.1 million; requires vouchers to be forwarded to the state treasurer to be destroyed upon purchase of the vouchers.

### **Sec. 752. *Coronavirus Public Health Emergency***

Requires funds to be allocated to departments for preparedness and response activities for Coronavirus (COVID-19); authorizes expenditure for specified activities; requires departments expending funds to report on types of activities supported with funds and amount of funds expended.

### **Sec. 753. *Coronavirus Response Fund***

Appropriates \$15.0 million GF/GP for deposit into the Coronavirus Response Fund.

### **Sec. 754. *State Restricted Contingency Fund Authorization***

Appropriates up to \$15.0 million in state restricted contingency funds; authorizes expenditure of funds after legislative transfer to specific line items.

## **TREASURY**

### **Sec. 801. *Financial Data Analytic Tool Reimbursement***

Requires funds to be used for reimbursements to counties, cities, villages, townships, and regional councils of government for the cost of a data analytical tool that provides financial data analysis and early warning analysis; requires reimbursements to only be provided for data analytic tools from 1 or 2 vendors approved by the Department of Technology, Management, and Budget; designates unexpended funds as work project appropriation.

### **Sec. 802. *High Water Public Infrastructure Repair* – VETOED**

Requires funds for High Water Public Infrastructure Repair to be awarded on a competitive basis to counties, cities, villages, and townships for public infrastructure damages or prevention methods due to high waters and shoreline erosion; prohibits grants from exceeding \$250,000; requires grant recipients to contribute a minimum of 25% of the total project cost.

### **Sec. 803. *Property Tax Assessor Training* – VETOED**

Requires funds for Property Tax Assessor Training to be used to expand in-person training throughout the state in at least each regional prosperity zone.

### **Sec. 901. *Repealers***

(1) Repeals section 461 of 2019 PA 154 and replaces it with Section 508 of this bill. (2) Repeals section 936 of 2019 PA 56 and replaces it with Section 801 of this bill.
