(a) Add gross interest income and dividends derived from 5 6 obligations or securities of states other than Michigan, in the 7 same amount that has been excluded from adjusted gross income less related expenses not deducted in computing adjusted gross income 8 because of section 265(a)(1) of the internal revenue code. 9

A person who takes the deduction under subsection (1)(e) is not eligible for the 26 unrestricted deduction of \$35,000.00 for a single return and 27 \$55,000.00 for a joint return, or \$70,000.00 for a joint return if 28 29 applicable, under this subdivision.

(d) Except as otherwise provided under subdivision (c) for a 1 person who was retired as of January 1, 2013, for a person born 2 after 1952 who has reached the age of 62 through 66 years of age 3 and who receives retirement or pension benefits from employment 4 with a governmental agency that was not covered by the federal 5 6 social security act, chapter 532, 531, 49 Stat 620, the sum of the deductions under subsection (1) (f) (i), (ii), and (iv) is limited to 7 \$15,000.00 for a single return and, except as otherwise provided 8 9 under this subdivision, \$15,000.00 for a joint return. If both 10 spouses filing a joint return receive retirement or pension benefits from employment with a governmental agency that was not 11 12 covered by the federal social security act, chapter 532, 531, 49 13 Stat 620, the sum of the deductions under subsection (1)(f)(i), (ii), 14 and (iv) is limited to \$30,000.00 for a joint return.

15 (e) Except as otherwise provided under subdivision (c) or (d), 16 for a person born after 1952, the deduction under subsection 17 (1) (f) (i), (ii), or (iv) does not apply. When that person reaches the age of 67, that person is eligible for a deduction of \$20,000.00 18 for a single return and \$40,000.00 for a joint return, which 19 20 deduction is available against all types of income and is not 21 restricted to income from retirement or pension benefits. If a person takes the deduction of \$20,000.00 for a single return and 22 23 \$40,000.00 for a joint return, that person shall not take the deduction under subsection (1) (f) (iii) and shall not take the 24 personal exemption under subsection (2). That person may elect not 25 26 to take the deduction of \$20,000.00 for a single return and 27 \$40,000.00 for a joint return and elect to take the deduction under 28 subsection (1) (f) (iii) and the personal exemption under subsection 29 (2) if that election would reduce that person's tax liability. (f) For a joint return, the limitations and restrictions in 4 5 this subsection shall be applied based on the age date of birth of 6 the older spouse filing the joint return. If a deduction under 7 subsection (1)(f) was claimed on a joint return for a tax year in 8 which a spouse died and the surviving spouse has not remarried 9 since the death of that spouse, the surviving spouse is entitled to 10 claim the deduction under subsection (1)(f) in subsequent tax years 11 subject to the same restrictions and limitations, for a single return, that would have applied based on the date of birth of the 12 13 older of the 2 spouses.
