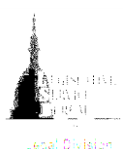

25 Sec. 202. The appropriations made and expenditures authorized
26 under this act and the departments, commissions, boards, offices,
27 and programs for which appropriations are made under this act are
28 subject to the management and budget act, 1984 PA 431, MCL 18.1101
29 to 18.1594.



1 Sec. 203. If the state administrative board, acting under
2 section 3 of 1921 PA 2, MCL 17.3, transfers funds from an amount
3 appropriated under this act, the legislature may, by a concurrent
4 resolution adopted by a majority of the members elected to and
5 serving in each house, inter-transfer funds within this act for the
6 particular department, board, commission, officer, or institution.

7 Sec. 204. Federal revenues up to \$50,000,000.00 authorized by
8 and available from the federal government for the respiratory virus
9 Coronavirus-19 (COVID-19) public health emergency are appropriated
10 to departments for state and local preparedness and response
11 activities. Departments receiving federal funds for this purpose
12 shall report to the senate and house appropriations committees, the
13 relevant senate and house appropriations subcommittees, the senate
14 and house fiscal agencies, and the state budget office no later
15 than June 30, 2020 and September 30, 2020 on the federal funds
16 received, the types of activities supported with the funds, and the
17 amount of funds expended to date.

19 **DEPARTMENT OF AGRICULTURE AND RURAL DEVELOPMENT**

20 Sec. 301. (1) The department shall establish and administer a
21 county fairs, shows, and expositions grant program. The program
22 shall have the following objectives:

23 (a) Assist in the promotion of building improvements or other
24 capital improvements at county fairgrounds of this state.

25 (b) Provide financial support, promotion, prizes, and premiums

12 (4) All fairs receiving grants under this section shall
13 provide a report to the department on the financial impact
14 resulting from the capital improvement project on both fair and
15 nonfair events. These reports are due for 3 years immediately
16 following the completion of the capital improvement project.

17 (5) The department shall identify criteria, evaluate
18 applications, and provide recommendations to the director for final
19 approval of grant awards.

20 (6) The department may expend money from the funds
21 appropriated in part 1 for the county fairs, shows, and expositions
22 grants for administering the program.

23 (7) The unexpended portion of the county fairs, shows, and
24 expositions grants is considered a work project appropriation in
25 accordance with section 451a of the management and budget act, 1984
26 PA 431, MCL 18.1451a. The following apply to the project:

27 (a) The purpose of the project is to support building
28 improvements or other capital improvements at county fairgrounds of
29 the state.



1 (b) All grants will be distributed in accordance with this
2 section and the grant guidelines published prior to the request for
3 proposals.

4 (c) The estimated cost of the project is identified in the
5 appropriation line item.

6 (d) The tentative completion date for the work project is
7 September 30, 2022.

8 (8) The department shall provide a year-end report on the
9 county fairs, shows, and expositions grants no later than December
10 1, 2020 to the senate and house appropriations subcommittees on
11 agriculture and rural development, the senate and house fiscal
12 agencies, and the state budget office that includes a listing of
13 the grantees, award amounts, match funding, and project outcomes.

14 Sec. 302. From the funds appropriated in part 1 for county
15 fairs, shows, and expositions, \$50,000.00 shall be used to promote
16 festivals and events in this state.

17

18 **ATTORNEY GENERAL**

19 Sec. 351. (1) In addition to the funds appropriated in part 1,
20 there is appropriated up to \$500,000.00 from litigation expense
21 reimbursements awarded to the state.

22 (2) The funds may be expended for the payment of court
23 judgments, settlements, arbitration awards or other administrative
24 and litigation decisions, attorney fees, and litigation costs,
25 assessed against the office of the governor, the department of the
26 attorney general, the governor, or the attorney general when acting
27 in an official capacity as the named party in litigation against
28 the state. The funds may also be expended for the payment of state
29 costs incurred under section 16 of chapter X of the code of



1 criminal procedure, 1927 PA 175, MCL 770.16.

2 (3) Unexpended funds at the end of the fiscal year may be
3 carried forward for expenditure in the following year, up to a
4 maximum authorization of \$250,000.00.

5 Sec. 352. (1) From the funds appropriated in part 1 for clergy
6 abuse investigation, the department shall not expend funds for any
7 purpose other than the following:

8 (a) Victim advocacy services for victims of abuse by members
9 of the clergy identified in the church special investigation.

10 (b) Managing documents related to the church special
11 investigation.

12 (c) Costs associated with internal investigators to complete
13 the special investigation of the clergy of the Catholic church.

14 (2) The unexpended funds appropriated in part 1 for clergy
15 abuse investigation are designated as a work project appropriation,
16 and any unencumbered or unallotted funds shall not lapse at the end
17 of the fiscal year and shall be available for expenditures for
18 projects under this section until the projects have been completed.
19 The following is in compliance with section 451a of the management
20 and budget act, 1984 PA 431, MCL 18.1451a:

21 (a) The purpose of the project is for victim advocacy services
22 for victims of abuse by members of the clergy identified in the
23 church special investigation, managing documents related to the
24 church special investigation, and costs associated with internal
25 investigators completing the special investigation of the clergy of
26 the Catholic church.

27 (b) The project will be accomplished by utilizing state
28 employees or contracts with service providers, or both.

29 (c) The total estimated cost of the project is \$1,000,000.00.



1 (d) The tentative completion date is September 30, 2021.

3 **CAPITAL OUTLAY**

4 Sec. 401. For the state building authority financed
5 construction authorizations in part 1, the legislature hereby
6 determines that the leases of the facilities from the authority are
7 for a public purpose as authorized by 1964 PA 183, MCL 830.411 to
8 830.425. The legislature approves and authorizes the leases and
9 conveyances of the property to the state building authority, the
10 state building authority acquiring the facilities and leasing them
11 to the state and the educational institutions, or state, as
12 applicable, and the governor and secretary of state executing the
13 leases for and on behalf of the state pursuant to the requirements
14 of 1964 PA 183, MCL 830.411 to 830.425. Per the requirements of the
15 leases, it is the intent of the legislature to annually appropriate
16 sufficient amounts to pay the rent as obligated pursuant to the
17 leases.

18 Sec. 402. The scope of the North Central Michigan College
19 AD/CL Classroom Renovation and Expanded Learning Space project,
20 initially authorized for construction in 2018 PA 207, and re-
21 authorized in 2018 PA 618, is amended to remove a small addition on
22 the north side of the building and to remove major renovations and
23 space reconfigurations to a portion of the west end of the main
24 level of the building. The total project cost remains \$7,400,000.00
25 (total state building authority share \$3,399,800.00; community
26 college share \$4,000,000.00; state general fund/general purpose
27 share \$200.00).

28 Sec. 403. The scope of Schoolcraft College's Applied Science
29 Renovation and Expansion project, initially authorized for



1 construction in 2018 PA 618, is amended to remove the fitness
2 leadership and massage therapy academic programs and incorporate
3 the surgical technician, radiology technician, ultrasound
4 technician, and sterile processing technician programs. The cost to
5 construct the project is hereby increased to a new total project
6 cost of \$24,286,600.00 (total state building authority share
7 \$9,999,800.00; community college share \$14,286,600.00; state
8 general fund/general purpose share \$200.00).

9 Sec. 404. The cost to construct the Washtenaw Community
10 College Advanced Transportation Center project, initially
11 authorized for construction in 2018 PA 207, is hereby increased by
12 \$2,229,300.00 to a new total project cost of \$7,900,000.00 (total
13 state building authority share \$1,999,800.00; community college
14 share \$5,900,000.00; state general fund/general purpose share
15 \$200.00).

16 Sec. 405. The cost to construct the Lake Superior State
17 University Center for Freshwater Research and Education project,
18 initially authorized for construction in 2018 PA 207, is hereby
19 increased by \$1,000,000.00 to a new total project cost of
20 \$14,200,000.00 (total state building authority share \$8,849,800.00;
21 university share \$5,350,000.00; state general fund/general purpose
22 share \$200.00).

23 Sec. 406. The cost and the scope to construct the Michigan
24 State Capitol Commission - State Capitol Restoration/Infrastructure
25 Upgrade project, initially authorized for construction in 2017 PA
26 107, and reauthorized in 2018 PA 618, is hereby increased by
27 \$5,000,000.00 to a new total project cost of \$115,009,400.00 (state
28 building authority share \$115,009,300.00; state general
29 fund/general purpose share \$100.00). The scope change includes the



1 addition of parking infrastructure to the capitol grounds.

2

3 **DEPARTMENT OF ENVIRONMENT, GREAT LAKES, AND ENERGY**

4 Sec. 451. The unexpended funds appropriated in part 1 for
5 environmental cleanup support are designated as a work project
6 appropriation, and any unencumbered or unallotted funds shall not
7 lapse at the end of the fiscal year and shall be available for
8 expenditures for projects under this section until the projects
9 have been completed. The following is in compliance with section
10 451a of the management and budget act, 1984 PA 431, MCL 18.1451a:

11 (a) The purpose of the project is to provide contaminated site
12 cleanup.

13 (b) The project will be accomplished by utilizing contracts
14 with service providers.

15 (c) The total estimated cost of the project is \$2,000,000.00.

16 (d) The tentative completion date is September 30, 2022.

17 Sec. 452. The unexpended funds appropriated in part 1 for
18 superfund cleanup are designated as a work project appropriation,
19 and any unencumbered or unallotted funds shall not lapse at the end
20 of the fiscal year and shall be available for expenditures for
21 projects under this section until the projects have been completed.
22 The following is in compliance with section 451a of the management
23 and budget act, 1984 PA 431, MCL 18.1451a:

24 (a) The purpose of the project is to provide contaminated site
25 cleanup.

26 (b) The project will be accomplished by utilizing contracts
27 with service providers.

28 (c) The total estimated cost of the project is \$3,000,000.00.

29 (d) The tentative completion date is September 30, 2023.



1 Sec. 453. From the funds appropriated in part 1 for scrap tire
2 grants, the department shall award \$3,000,000.00 for a project
3 based on a previously submitted grant application in a county with
4 a population between 29,000 and 30,000 according to the most recent
5 federal decennial census.

6 Sec. 454. From the funds appropriated in part 1 for EPA
7 containment study, the department shall award \$200,000.00 to a
8 nonprofit air quality research and planning organization to conduct
9 studies on speciated, high-temporal resolution volatile organic
10 compound measurements and high-resolution meteorological model
11 simulation with the weather research forecasting model.

12 Sec. 455. From the funds appropriated in part 1 for Michigan
13 geological survey, the department shall award \$500,000.00 for the
14 Michigan geological survey.

15 Sec. 456. From the funds appropriated in part 1 for multistate
16 aquifer study, the department, in coordination with the United
17 States Geological Survey, shall award an amount not to exceed
18 \$500,000.00 to support a study, including the acquisition of
19 necessary equipment, to determine an estimated storage capacity and
20 maximum yield of the Michindoh Aquifer.

21

22 **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

23 Sec. 501. From the funds appropriated in part 1 for child
24 advocacy centers, \$1,000,000.00 shall be allocated to support
25 general operations of child advocacy centers. The purpose of this
26 additional funding is to increase the amount of services provided
27 to children and their families who are victims of abuse over the
28 amount provided in the previous fiscal year. None of the additional
29 funding directed in this section shall be used for purposes other



1 than those described under section 4 of the children's advocacy
2 center act, 2008 PA 544, MCL 722.1044.

3 Sec. 502. (1) From the funds appropriated in part 1 for school
4 success partnership program, the department shall allocate
5 \$250,000.00 to support the Northeast Michigan Community Service
6 Agency programming. The department shall require the following
7 performance objectives be measured and reported for the duration of
8 the state funding for the school success partnership program:

9 (a) Increasing school attendance and decreasing chronic
10 absenteeism.

11 (b) Increasing academic performance based on grades with
12 emphasis on math and reading.

13 (c) Identifying barriers to attendance and success and
14 connecting families with resources to reduce these barriers.

15 (d) Increasing parent involvement with the child's school and
16 community.

17 (2) By July 15 of the current fiscal year, the Northeast
18 Michigan Community Service Agency shall provide reports to the
19 department on the number of children and families served and the
20 services that were provided to families to meet the performance
21 objectives identified in this section. The department shall
22 distribute the reports within 1 week after receipt to the senate
23 and house appropriations subcommittees on the department budget,
24 the senate and house fiscal agencies, the senate and house policy
25 offices, and the state budget office.

26 Sec. 503. (1) From the funds appropriated in part 1 for
27 adoption support services, the department shall allocate
28 \$250,000.00 to the Adoptive Family Support Network to operate and
29 expand its adoptive parent mentor program to provide a listening



1 ear, knowledgeable guidance, and community connections to adoptive
2 parents and children who were adopted in this state or another
3 state.

4 (2) The Adoptive Family Support Network shall submit to the
5 senate and house appropriations subcommittees on the department
6 budget, the senate and house fiscal agencies, the senate and house
7 policy offices, and the state budget office by August 1 of the
8 current fiscal year a report on the program described in subsection
9 (1), including, but not limited to, the number of cases served and
10 the number of cases in which the program prevented an out-of-home
11 placement.

12 Sec. 504. From the funds appropriated in part 1 for adoption
13 support services, the department shall allocate \$700,000.00 of
14 state general fund/general purpose and any eligible federal
15 matching funds to increase rates paid to adoption service providers
16 by up to 6.5% for adoption placement, adoption finalization, and
17 adoption permanency in all rate categories.

18 Sec. 505. (1) From the funds appropriated in part 1 for injury
19 control intervention project, \$1,500,000.00 shall be allocated for
20 implementation of evidence-based, real-time, quality assurance
21 decision support software in the treatment of traumatic brain
22 injury and for protocols that are to be available to all hospitals
23 providing those trauma services. The funds shall be used to
24 purchase statewide licenses for traumatic brain injury treatment
25 software and related software services and to offset hospital
26 software integration costs. The department shall seek federal
27 matching funds that may be available for implementation of this
28 section.

29 (2) By August 1 of the current fiscal year, the department



1 shall report to the senate and house appropriations subcommittees
2 on the department budget, the senate and house fiscal agencies, the
3 senate and house policy offices, and the state budget office on
4 both of the following:

5 (a) Expenditures broken down by purpose of expenditure.

6 (b) Expenditures broken down by hospital.

7 Sec. 506. (1) From the funds appropriated in part 1 for
8 medical services administration, the department shall allocate
9 \$200,000.00 of general fund/general purpose revenue and any
10 associated federal match toward the existing cloud-based analytics
11 platform for Medicaid claims to focus on behavioral health
12 services. The vendor shall identify areas of best practice, cost
13 reduction, opportunities for quality improvement, and comparative
14 cost analysis among providers, hospitals, and managed care
15 organizations. Through the existing platform, the vendor shall
16 facilitate specific analysis of the unique behavioral health cohort
17 of patients that compares specific episodic metrics combined with
18 substance use disorder data for the same time period. The data
19 analysis shall include the ability to adjust for variations in
20 patient risk and acuity differences when comparing performance
21 across regions and hospitals. Specific analytics for this cohort
22 shall provide data analysis on, but not be limited to, the
23 following:

24 (a) Readmission rates.

25 (b) Mortality rates and complication rates.

26 (c) Total episode costs, including pre- and post-discharge
27 costs, across high-volume episodes of care.

28 (2) Within 30 days after the end of the previous fiscal
29 quarter, the department shall make available state medical



1 assistance program claims data from the previous quarter, without
2 charge, to the vendor in subsection (1).

3 Sec. 507. From the funds appropriated in part 1, the
4 department shall provide a 15% rate increase beginning April 1 of
5 the current fiscal year for private duty nursing services for
6 Medicaid beneficiaries under the age of 21. These additional funds
7 must be used to attract and retain highly qualified registered
8 nurses and licensed practical nurses to provide private duty
9 nursing services so that medically frail children can be cared for
10 in the most homelike setting possible.

11 Sec. 508. From the funds appropriated in part 1 for hospital
12 services and therapy, \$13,904,800.00 in general fund/general
13 purpose revenue and any associated federal match shall be awarded
14 as rural access payments to noncritical access hospitals that meet
15 criteria established by the department for services to low-income
16 rural residents. One of the reimbursement components of the
17 distribution formula shall be assistance with labor and delivery
18 services. The department shall ensure that the rural access
19 payments described in this section shall be distributed in a manner
20 that ensures both of the following:

21 (a) No hospital shall receive more than 10% of the total rural
22 access funding referenced in this section.

23 (b) To allow hospitals to understand their rural payment
24 amounts under this section, the department shall provide hospitals
25 with the methodology for distribution under this section and
26 provide each hospital with its applicable data that are used to
27 determine the payment amounts by August 1 of the current fiscal
28 year. The department shall publish the distribution of payments for
29 the current fiscal year and the immediately preceding fiscal year.



1 Sec. 509. (1) From the funds appropriated in part 1 for
2 comprehensive child welfare information system, the department
3 shall implement an agile software development plan that is funded
4 with a time and materials contract.

5 (2) The state shall be the owner of this software or it shall
6 be committed to the public domain.

7 (3) The department shall choose a product owner that will
8 implement a user-centered design that includes user stories into
9 the development of the comprehensive child welfare information
10 system. The product owner shall be an employee of the department
11 who has child welfare specific work experience.

12 (4) At the commencement of the project, the department shall
13 report to the house and senate appropriations subcommittees on the
14 department budget, the house and senate fiscal agencies, and the
15 state budget office on the individual who has been chosen as the
16 product owner.

17 (5) The department shall provide in-person updates every other
18 month and provide written reports in the off months. Updates and
19 reports shall be provided to the house and senate appropriations
20 subcommittees on the department budget, the house and senate fiscal
21 agencies, and the state budget office on the status of the work
22 completed to date. The reporting shall include demonstrations of
23 the completed work, also known as a sprint period. During these
24 demonstrations, the department shall provide a quality assessment
25 surveillance plan as shown in appendix B of "De-risking custom
26 technology projects" from the United States General Services
27 Administration. At each demonstration, the department shall
28 validate which user stories have been included into the software
29 development and the remaining user stories that will be included



1 into the product.

2 (6) As used in this section:

3 (a) "Agile software development" means the use of development
4 methodologies using iterative development with work completed by
5 cross-functional teams of software development.

6 (b) "Product owner" means a department employee who
7 iteratively prioritizes and defines the work for the product team,
8 works with users, stakeholders, technologists, and the software
9 vendor to envision the direction for the product, and ensures that
10 value is being delivered to end users as quickly as possible.

11 (c) "User centered design" means software development that
12 places the highest priority on the needs of the specific people who
13 are expected to use the software.

14 (d) "User stories" means a task that the agile software
15 development team will focus on over a given 2-week development
16 period and includes clearly labeled progress towards meeting the
17 needs of the end users.

18 Sec. 510. (1) From the funds appropriated in part 1 for
19 federally qualified health center transition, the department shall
20 allocate up to \$2,000,000.00 to a federally qualified health center
21 in a county with a population between 172,000 and 173,000 in the
22 most recent federal decennial census. These funds are intended to
23 ensure continued access to needed health services for patients
24 previously served through Muskegon Family Care.

25 (2) The funds appropriated in this section shall only be
26 provided when federal United States Department of Health and Human
27 Services Health Resources and Services Administration funding
28 allocated to support transition costs is fully expended.

29 Sec. 511. (1) From the funds appropriated in part 1 for human



1 trafficking survivors' assistance, the department shall allocate
2 \$500,000.00 of Michigan merit award trust fund to support a long-
3 term women's shelter in southeastern Michigan for women aged 18 and
4 older who are survivors of human trafficking that offers housing
5 and comprehensive services to address the physical, psychological,
6 and spiritual aspects of recovery through a voluntary 2-year
7 program. Services provided by the shelter include counseling and
8 therapy for both trauma and addiction, medical and dental
9 evaluations and services, job training, GED or high school
10 completion programs or college, skilled trade training, computer
11 skills training, job placement counseling, legal assistance, health
12 and wellness consulting, addiction recovery meetings, and
13 opportunities for spiritual growth.

14 (2) From the funds appropriated in part 1 for human
15 trafficking survivors' assistance, the department shall allocate
16 \$500,000.00 of Michigan merit award trust fund to support a long-
17 term women's shelter in a city with a population between 188,000
18 and 189,000 according to the most recent federal decennial census.
19 The shelter shall offer housing and comprehensive services to women
20 who are survivors of human trafficking.

21 Sec. 512. From the funds appropriated in part 1 for runaway
22 and homeless youth services program, the department shall allocate
23 \$800,000.00 to support runaway and homeless youth services
24 programs. The purpose of the additional funding is to support
25 current programs for contracted providers that provide emergency
26 shelter and services to homeless and runaway youth.

27 Sec. 513. From the funds appropriated in part 1 for senior
28 community health grant, \$100,000.00 shall be allocated for a grant
29 for senior community health improvement programming and



1 infrastructure needs projects to a community located in a county
2 with a population greater than 1,800,000 and in a city with a
3 population of between 96,900 and 97,000 according to the most
4 recent federal decennial census.

5 Sec. 514. From the funds appropriated in part 1 for substance
6 abuse community and school outreach, the department shall allocate
7 \$100,000.00 to a coalition located in a county with a population of
8 at least 1,500,000 according to the most recent federal decennial
9 census with an aim to lead and support communities to dispel the
10 myths and stigmas about drug addiction through public education,
11 sharing stories of recovery, partnering with local and state
12 leaders, creating positive social changes, and providing recovery
13 support services for those in need.

14 Sec. 515. (1) From the funds appropriated in part 1 for
15 unified clinics resiliency center for families and children, the
16 department shall allocate \$1,375,000.00 to a 4-year state
17 university located in a county with a population between 250,000
18 and 251,000 according to the most recent federal decennial census
19 to be used to develop and operate a resiliency center for families
20 and children to address the multifaceted needs of those
21 experiencing trauma, toxic stress, chronic disability,
22 neurodevelopmental disorders, or addictions.

23 (2) Outcomes and performance measures for the resiliency
24 center funded under this section shall include, but not be limited
25 to, the following:

26 (a) The number of children and families who received services
27 from the center.

28 (b) The types of screening offered by the center and the
29 number of clients that received each screening type.



1 (c) The number of trauma assessments completed through the
2 center's programs and the average cost of a trauma assessment for
3 each type of client, including children, adults, and families.

4 (d) The types of services offered by the center and the number
5 of clients that received each service type.

6 (e) The number of referrals for services made to children and
7 families.

8 (f) A breakdown of the expenditures made for the development
9 of the resiliency center for families and children by major
10 category.

11 (3) By August 1 of the current fiscal year, the resiliency
12 center for families and children shall report to the house and
13 senate appropriations subcommittees on the department budget, the
14 house and senate fiscal agencies, the house and senate policy
15 offices, and the state budget office on the status of the
16 development of the resiliency center funded under this section and
17 on the information required in subsection (2).

18 (4) The unexpended portion of funds appropriated in part 1 for
19 unified clinics resiliency center for families and children is
20 designated as a work project appropriation. Any unencumbered or
21 unallotted funds shall not lapse at the end of the fiscal year and
22 shall be available for expenditure for the project under this
23 section until the project has been completed. The following is in
24 compliance with section 451a(1) of the management and budget act,

24 enhancement grants, \$200,000.00 shall be awarded to a city with a
25 population of between 29,900 and 31,000 located in a county with a
26 population of between 425,700 and 425,800 according to the most
27 recent federal decennial census for water line replacement.

28 (55) From the funds appropriated in part 1 for Michigan
29 enhancement grants, \$1,411,300.00 shall be awarded to a county road



1 commission located in a county with a population of between 36,600
2 and 36,700 according to the most recent federal decennial census
3 for the repayment of a state infrastructure bank loan related to
4 road repairs due to flooding.

5 (56) From the funds appropriated in part 1 for Michigan
6 enhancement grants, \$250,000.00 shall be awarded to a land bank
7 located in a county with a population of between 136,100 and
8 136,200 according to the most recent federal decennial census for
9 building demolition.

10 (57) From the funds appropriated in part 1 for Michigan
11 enhancement grants, \$1,000,000.00 shall be awarded to a public
12 museum in a county with a population between 400,000 and 450,000
13 and in a city with a population over 100,000 according to the most
14 recent federal decennial census.

15 (58) From the funds appropriated in part 1 for Michigan
16 enhancement grants, \$1,000,000.00 shall be awarded to an
17 independent biomedical research and science education organization
18 in a county with a population between 600,000 and 610,000 and in a
19 city with a population over 185,000 according to the most recent
20 federal decennial census to be used for matching federal funds,
21 private and nonprofit grants, and private contributions.

22 (59) From the funds appropriated in part 1 for Michigan
23 enhancement grants, \$250,000.00 shall be awarded to the Conductive
24 Learning Center at Aquinas College. The funding shall be used to
25 support the operational costs of the conductive education model
26 taught at the Conductive Learning Center to maximize the
27 independence and mobility of children and adults with neuromotor
28 disabilities. The conductive education model funded under this
29 grant must be based on the concept of neuroplasticity and the



1 ability of people to learn and improve when they are motivated,
2 regardless of the severity of their disability.

3 (60) From the funds appropriated in part 1 for Michigan
4 enhancement grants, \$200,000.00 shall be awarded to a fire
5 department located in a city with a population between 128,000 and
6 130,000 and in a county with a population between 800,000 and
7 900,000 according to the most recent federal decennial census. The
8 grant shall be used to purchase chest compression devices for
9 patients in the field and on the move to a hospital.

10 (61) From the funds appropriated in part 1 for Michigan
11 enhancement grants, up to \$250,000.00 shall be used as last dollars
12 to fund the gap between the total cost of hosting a national
13 conference for a national council that currently receives
14 association dues from this state and the total amount privately
15 raised. After the conference has concluded, any remaining funds
16 shall be used for Pure Michigan activities.

17 (62) From the funds appropriated in part 1 for Michigan
18 enhancement grants, \$500,000.00 shall be awarded to a school
19 district that has a total pupil membership between 8,775 and 9,000
20 and is located in an intermediate school district that has a
21 combined pupil membership for all its constituent districts between
22 150,000 and 200,000 according to the most recent pupil membership
23 count. The grant shall be used to offset costs associated with a
24 school-based community infrastructure project.

25 (63) From the funds appropriated in part 1 for Michigan
26 enhancement grants, \$200,000.00 shall be awarded to a township with
27 a population between 3,200 and 3,300 located in a county with a
28 population between 159,000 and 170,000 according to the most recent
29 federal decennial census. The grant shall be used to replace a



1 bridge that was constructed at least 78 years ago and is located
2 near a county park entrance.

3 (64) From the funds appropriated in part 1 for Michigan
4 enhancement grants, \$750,000.00 shall be awarded to a county with a
5 population between 60,100 and 63,000 according to the most recent
6 federal decennial census to repair the longest covered bridge in
7 Michigan.

8 (65) From the funds appropriated in part 1 for Michigan
9 enhancement grants, \$1,000,000.00 shall be awarded to an early
10 childhood collaborative that serves students located in a county
11 with a population between 400,000 and 500,000 according to the most
12 recent federal decennial census. The grant shall be used to
13 continue the expansion of early childhood services because of a
14 drinking water declaration of emergency.

15 (66) From the funds appropriated in part 1 for Michigan
16 enhancement grants, \$700,000.00 shall be awarded to a city with a
17 population of greater than 100,000 located in a county with a
18 population between 400,000 and 500,000 according to the most recent
19 federal decennial census. The grant shall be used to support a
20 cooperative grocery store to expand access to food within a food
21 desert.

22 (67) From the funds appropriated in part 1 for Michigan
23 enhancement grants, \$200,000.00 shall be awarded to a local road
24 commission located in a city with a population of greater than
25 100,000 and in a county with a population between 400,000 and
26 500,000 according to the most recent federal decennial census. The
27 grant shall be used to expand pathways from parking to industrial
28 facilities.

29 (68) From the funds appropriated in part 1 for Michigan



1 enhancement grants, \$250,000.00 shall be awarded to a national,
2 nonprofit program that connects National Guard, reserve, retired,
3 and transitioning active-duty military service members with skilled
4 training and quality career opportunities in the construction
5 industry. Grant funding must be used to recruit and assist veterans
6 to transition into apprenticeship programs in this state.

7 (69) From the funds appropriated in part 1 for Michigan
8 enhancement grants, \$175,000.00 shall be awarded to a county
9 sheriff's department located in a county with a population between
10 280,000 and 300,000 according to the most recent federal decennial
11 census. The grant shall be used to support the purchase of body
12 scanners for inmates.

13 (70) From the funds appropriated in part 1 for Michigan
14 enhancement grants, \$750,000.00 shall be awarded to a fire
15 department located in a city with a population greater than 100,000
16 and in a county with a population between 280,000 and 300,000
17 according to the most recent federal decennial census. The grants
18 shall be used to purchase a ladder truck to service the city area.

19 (71) From the funds appropriated in part 1 for Michigan
20 enhancement grants, \$100,000.00 shall be awarded to a county with a
21 population between 300,000 and 400,000 according to the most recent
22 federal decennial census. The grant shall be used to pilot
23 mentoring and after-school programs for at-risk students in
24 partnership with other not-for-profit organizations.

25 (72) From the funds appropriated in part 1 for Michigan
26 enhancement grants, \$50,000.00 shall be awarded to a county with a
27 population between 300,000 and 400,000 according to the most recent
28 federal decennial census. The grant shall be used to support the
29 county pest control to address increased vermin in a local



1 township.

2 (73) From the funds appropriated in part 1 for Michigan
3 enhancement grants, \$300,000.00 shall be awarded to a downtown
4 development authority located in a city with a population between
5 20,000 and 22,000 and a county with a population between 300,000
6 and 400,000 according to the most recent federal decennial census.
7 The grant shall be used to make improvements to an art center to
8 support individuals with disabilities.

9 (74) From the funds appropriated in part 1 for Michigan
10 enhancement grants, \$30,000.00 shall be awarded to a community
11 development corporation that has a memorandum of understanding with
12 a city that has a population between 20,000 and 22,000 located in a
13 county with a population between 300,000 and 400,000 according to
14 the most recent federal decennial census. The grant shall be used
15 to conduct a feasibility study on building a parking ramp located
16 within the city.

17 (75) From the funds appropriated in part 1 for Michigan
18 enhancement grants, \$270,000.00 shall be awarded to a Junior
19 Reserve Officers Training Corps program located at a high school in
20 a city with a population above 500,000 according to the most recent
21 federal decennial census. The grant shall be used to facilitate a
22 partnership between the Junior Reserve Officers Training Corps
23 program and the Michigan National Guard.

24 (76) From the funds appropriated in part 1 for Michigan
25 enhancement grants, \$500,000.00 shall be awarded to a county with a
26 population between 1,000,000 and 1,500,000 according to the most
27 recent federal decennial census. The grant shall be used to support
28 an increase in the county's participation in a federal free lunch
29 program.



1 (77) From the funds appropriated in part 1 for Michigan
2 enhancement grants, \$500,000.00 shall be awarded to a city with a
3 population above 500,000 according to the most recent federal
4 decennial census. The grant shall be used to support improvements
5 to picnic shelters in a community park.

6 (78) From the funds appropriated in part 1 for Michigan
7 enhancement grants, \$250,000.00 shall be awarded to a disability
8 network that serves 2 counties that each have a population above
9 800,000 according to the most recent federal decennial census. The
10 grant shall be used to support services and operations.

11 (79) From the funds appropriated in part 1 for Michigan
12 enhancement grants, \$1,000,000.00 shall be awarded to a community
13 house located in a city with a population above 100,000 and in a
14 county with a population between 600,000 and 700,000 according to
15 the most recent federal decennial census. The grant shall be used
16 to support the construction of an early childhood education and
17 senior activity center located within the city.

18 (80) From the funds appropriated in part 1 for Michigan
19 enhancement grants, \$100,000.00 shall be awarded to a city with a
20 population between 17,000 and 18,000 located in a county with a
21 population above 1,500,000 according to the most recent federal
22 decennial census. The grant shall be used to make improvements to a
23 city park's amphitheater.

24 (81) From the funds appropriated in part 1 for Michigan
25 enhancement grants, \$50,000.00 shall be awarded to an enrichment
26 center located in a city with a population between 5,500 and 8,000
27 and a county with a population above 1,500,000 according to the
28 most recent federal decennial census. The grant shall be used to
29 support vocational programs focused on skills training.



1 (82) From the funds appropriated in part 1 for Michigan
2 enhancement grants, \$600,000.00 shall be awarded to a city with a
3 population between 29,000 and 30,000 located in a county with a
4 population between 1,000,000 and 1,500,000 according to the most
5 recent federal decennial census. The grant shall be used to support
6 the demolition costs of an electroplating services building.

7 (83) From the funds appropriated in part 1 for Michigan
8 enhancement grants, \$250,000.00 shall be awarded to a school
9 district located in a city with a population above 500,000
10 according to the most recent federal decennial census. The grant
11 shall be used to install air filtration systems throughout the
12 district.

13 (84) From the funds appropriated in part 1 for Michigan
14 enhancement grants, \$100,000.00 shall be awarded to a city with a
15 population above 500,000 according to the most recent federal
16 decennial census. The grant shall be used to support green
17 infrastructure projects throughout the community.

18 (85) From the funds appropriated in part 1 for Michigan
19 enhancement grants, \$25,000.00 shall be awarded to a city with a
20 population above 500,000 according to the most recent federal
21 decennial census. The grant shall be used to support community
22 garden restorations at a street block club.

23 Sec. 560. (1) From the funds appropriated in part 1 for
24 Michigan enhancement grants, the Michigan strategic fund shall
25 execute a grant agreement with each recipient, pursuant to
26 subsection (2). All grant funds are considered to be direct
27 appropriations and, subject to receipt of all information under
28 subsections (2) and (3), shall be disbursed by the Michigan
29 strategic fund, as determined by the grant agreement. An initial



1 disbursement of 50% shall be provided to the grantee upon execution
2 of the grant agreement.

3 (2) The Michigan strategic fund shall execute a grant
4 agreement with each recipient in order to receive funding. The
5 grant agreement shall include, but is not limited to, the
6 following:

7 (a) All necessary identifying information for the recipient,
8 including any necessary tax identification information.

9 (b) A description of the project for which the grant funds
10 will be expended, including tentative timeline and estimated
11 budget. No expenditures outside of the project purpose, as stated
12 in the executed grant agreement, shall be reimbursed from
13 appropriations in part 1.

14 (c) A requirement that after the initial 50% disbursement,
15 additional funds shall only be disbursed after verification that
16 the initial payment has been fully expended, in accordance with the
17 project purpose. The remaining funds shall be disbursed in a manner
18 specified in the grant agreement. The grantee must provide
19 sufficient documentation, as determined by the Michigan strategic
20 fund, to verify that all expenditures were made in accordance with
21 the project purpose.

22 (d) A requirement for quarterly reports from the recipient to
23 the Michigan strategic fund that provide the status of the project
24 and an accounting of all funds expended by the recipient.

25 (e) A claw-back provision that allows this state to recoup or
26 otherwise collect any funds that are declined, unspent, or
27 otherwise misused.

28 (3) The grantee shall respond to all reasonable information
29 requests from the Michigan strategic fund related to grant



1 expenditures and retain grant records for a period of not less than
2 3 years, and the grant may be subject to audit or site visits, or
3 both, as determined by the Michigan strategic fund. The grant
4 agreement required under subsection (2) shall include signed
5 assurance by the chief executive officer or other executive officer
6 of the grant recipient that this requirement will be met.

7 (4) All funds awarded shall be expended by the recipient, and
8 projects completed, by September 30, 2022. If at that time, as
9 evidenced by the quarterly reports, any unexpended funds remain,
10 those funds shall be returned by the grantee to the state treasury.
11 The state budget director may, on a case-by-case basis, extend this
12 deadline, upon request by a grant recipient.

13 (5) If a grantee does not provide information sufficient to
14 execute a grant agreement by September 1, 2020, funds associated
15 with that grant shall be returned to the state treasury.

16 (6) The Michigan strategic fund shall provide quarterly
17 updates on the accounting and status of each project to the senate
18 and house appropriations committees, the senate and house fiscal
19 agencies, and the state budget office.

20 Sec. 561. (1) The funds appropriated in part 1 from the talent
21 investment fund created under section 8a of the higher education
22 loan authority act, 1975 PA 222, MCL 390.1158a, for the Michigan
23 reconnect grant program shall be distributed pursuant to this
24 section and shall only be made available after House Bill No. 5576,
25 House Bill No. 5580, and Senate Bill No. 268 of the 100th
26 Legislature are enacted into law.

27 (2) As a condition of receiving the funds appropriated in part
28 1 for the Michigan reconnect grant program, the department shall
29 allocate 10.0 FTE positions for navigators who provide support



1 services for Michigan reconnect grant program students and 2.0 FTE
2 positions for oversight and implementation of the Michigan
3 reconnect grant program.

4 Sec. 562. (1) From the funds appropriated in part 1 for
5 museums support, \$500,000.00 shall be awarded to support an Arab-
6 American museum located in a county with a population over
7 1,300,000 and in a city with a population of between 97,000 and
8 500,000 according to the most recent federal decennial census.

9 (2) From the funds appropriated in part 1 for museums support,
10 \$500,000.00 shall be awarded to support capital improvements to an
11 African-American museum in a city with a population of greater than
12 600,000 according to the most recent federal decennial census.

13 (3) From the funds appropriated in part 1 for museums support,
14 \$500,000.00 shall be awarded to support a memorial center in a
15 county with a population of between 1,000,000 and 1,700,000 and in
16 a city with a population of between 79,000 and 80,000 according to
17 the most recent federal decennial census to expand educational
18 access.

19

20 **DEPARTMENT OF MILITARY AND VETERANS AFFAIRS**

21 Sec. 601. The appropriation in part 1 for buddy-to-buddy
22 program shall be used to train volunteer Michigan veterans to
23 provide outreach and support for other Michigan service members and
24 veterans in dealing with the challenges they face, including those
25 related to finances, securing benefits, legal issues, education,
26 and health, family, and emotional concerns.

27

28 **DEPARTMENT OF NATURAL RESOURCES**

29 Sec. 651. From the funds appropriated in part 1 for state



1 parks, \$500,000.00 is allocated for the Michigan conservation
2 corps.

3 Sec. 652. In addition to the funds appropriated in part 1 for
4 Brandon Road Lock and Dam, any interest or earnings deposited into
5 the Michigan infrastructure fund is appropriated and may be
6 expended for the Brandon Road Lock and Dam.

7 Sec. 653. From the funds appropriated in part 1 for Blanchard
8 Dam bond inspection and repair needs study, \$10,000.00 is allocated
9 for the department to conduct a study of dam repair needs and for
10 dam inspection in a county with a population between 70,000 and
11 70,500 according to the most recent federal decennial census.

12 Sec. 654. From the funds appropriated in part 1 for boat
13 launch/marina grants, up to \$30,000.00 shall be awarded to a city
14 with a population of between 3,900 and 4,000 located in a county
15 with a population of between 425,700 and 425,900 according to the
16 most recent federal decennial census for kayak launch upgrades.

17 Sec. 655. From the funds appropriated in part 1 for boat
18 launch/marina grants, up to \$970,000.00 shall be allocated for
19 upgrades at Cedar River Marina.

20

21 **DEPARTMENT OF STATE**

22 Sec. 701. The unexpended funds appropriated in part 1 for a
23 branch security program are designated as a work project
24 appropriation, and any unencumbered or unallotted funds shall not
25 lapse at the end of the fiscal year and shall be available for
26 expenditures for projects under this section until the projects
27 have been completed. The following is in compliance with section
28 451a of the management and budget act, 1984 PA 431, MCL 18.1451a:

29 (a) The purpose of the project is to improve security for the



1 public and employees in secretary of state branch offices.

2 (b) The project will be accomplished by new state employees.

3 (c) The total estimated cost of the project is \$395,000.00.

4 (d) The tentative completion date is September 30, 2021.

5

6 **DEPARTMENT OF TECHNOLOGY, MANAGEMENT, AND BUDGET**

7 Sec. 751. (1) From the funds appropriated in part 1, the state
8 budget director is authorized to purchase tax vouchers described in
9 this subsection. The state budget director may purchase tax
10 vouchers described in this subsection only if the tax vouchers meet
11 all of the following:

12 (a) The tax vouchers were issued under section 23 of the
13 Michigan early stage venture investment act of 2003, 2003 PA 296,
14 MCL 125.2253, by Venture Michigan Fund, a Michigan early stage
15 venture investment corporation created under that act.

16 (b) The tax vouchers are held for the benefit of Stanton
17 Equity Trading Delaware LLC, or its successors and permitted
18 assigns.

19 (c) The tax vouchers that have a face value of \$19,100,000.00
20 are due to be tendered on or before September 30, 2020.

21 (2) From the funds appropriated in part 1, the state budget
22 director may expend up to \$19,100,000.00 to purchase the tax
23 vouchers that are tendered during the fiscal year ending September
24 30, 2020.

25 (3) Once the purchase of the tax vouchers is completed by the
26 state budget director, the state budget director shall forward the
27 tax vouchers to the state treasurer for destruction.

28 Sec. 752. The funds appropriated in part 1 for the Coronavirus
29 public health emergency shall be allocated to departments, in



1 amounts and by a method approved by the state budget director, for
2 expenditure for critical state and local preparedness and response
3 activities for the respiratory virus Coronavirus-19 (COVID-19).
4 These activities may include, but are not limited to, Coronavirus
5 monitoring, laboratory testing, contact tracing, infection control,
6 and continuation of critical state government functions.
7 Departments expending funds allocated from this appropriation shall
8 report to the senate and house appropriations committees, relevant
9 senate and house appropriations subcommittees, senate and house
10 fiscal agencies, and the state budget office no later than June 30,
11 2020 and September 30, 2020 on the types of activities supported
12 with the funds, and the amount of funds expended to date.

13 Sec. 753. (1) The Coronavirus response fund is created within
14 the state treasury.

15 (2) From the funds appropriated in part 1 for the Coronavirus
16 response fund, \$15,000,000.00 shall be deposited into the
17 Coronavirus response fund.

18 (3) Funds may only be spent from the Coronavirus response fund
19 upon appropriation, or legislative transfer pursuant to section 393
20 of the management and budget act, 1984 PA 431, MCL 18.1393.

21 (4) Interest and earnings from the investment of funds
22 deposited in the Coronavirus response fund shall be deposited in
23 the general fund.

24 (5) Funds in the Coronavirus response fund at the close of a
25 fiscal year shall remain in the Coronavirus response fund and shall
26 not lapse to the general fund.

27 Sec. 754. In addition to the funds appropriated in part 1,
28 there is appropriated an amount not to exceed \$15,000,000.00 for
29 state restricted contingency funds. These funds are not available



1 for expenditure until they have been transferred to another line
 2 item in part 1 under section 393(2) of the management and budget
 3 act, 1984 PA 431, MCL 18.1393.

4
 5 **DEPARTMENT OF TREASURY**

6 Sec. 801. (1) From the funds appropriated in part 1 for
 7 financial data analytic tool reimbursement, the department shall
 8 provide reimbursements to cities, villages, townships, counties,
 9 and regional councils of government (participating organizations)
 10 for the licensing of data analytic tools as described under this
 11 section. Reimbursements are for participating organizations that
 12 choose to use a data analytic tool with 1 of the 2 vendors approved
 13 by the DTMB under section 936 of article VIII of 2017 PA 107. Funds
 14 allocated under this section are intended to provide participating
 15 organizations with financial forecasting and transparency reporting
 16 tools to improve the financial health of participating
 17 organizations and to improve communication with the public.

18 (2) The approved data analytic tool vendors under section 936
 19 of article VIII of 2017 PA 107 must continue to do all of the
 20 following:

- 21 (a) Analyze financial data.
 22 (b) Analyze pension and other postemployment benefit trends.
 23 (c) Provide early warning indicators of financial stress.
 24 (d) Provide peer community comparisons of financial data.
 25 (e) Provide financial projections for at least 3 subsequent
 26 fiscal years.

27 (3) Funds from any financial data analytic tool reimbursement
 28 work projects shall be used prior to using funds appropriated in
 29 the current year. Funds allocated under this section shall be paid



1 to participating organizations that execute an agreement on behalf
2 of their geographic local units as a reimbursement for already
3 having a licensing agreement or for entering into a licensing
4 agreement not later than December 1 of each year, with a vendor
5 approved under section 936 of article VIII of 2017 PA 107, to
6 implement a data analytic agreement. Reimbursement under this
7 section shall be made as follows:

8 (a) All participating organizations seeking reimbursement
9 shall submit requests not later than December 31 of each year to
10 the department indicating the cost paid for the financial data
11 analytic tool by virtue of providing an invoice, purchase order, or
12 proof of payment or by either of the approved vendors of record
13 submitting on behalf of the participating organizations.

14 (b) The department shall determine the sum of the funding
15 requested by all participating organizations under subdivision (a)
16 and, if there are sufficient funds, shall reimburse 1/2 of the
17 costs submitted by each participating organization or approved
18 vendor under subdivision (a). If there are insufficient funds to
19 pay 1/2 of the costs submitted under subdivision (a), the
20 reimbursement shall be made on an equal percentage basis using 2018
21 census population estimates from the United States Census Bureau.

22 (c) The reimbursement to a participating organization shall
23 not be greater than the amount paid for a data analytic
24 application.

25 (d) A participating organization shall not be reimbursed for
26 the purchase of more than 1 software application.

27 (e) Any unexpended funds shall continue as a work project
28 appropriation, and any unencumbered or unallotted funds shall not
29 lapse at the end of the fiscal year and shall be available for



1 expenditures for projects under this section until the projects
2 have been completed. The following is in compliance with section
3 451a of the management and budget act, 1984 PA 431, MCL 18.1451a.

4 (i) The purpose of the project is for financial data analytic
5 tool reimbursement.

6 (ii) The project will be accomplished by utilizing state
7 employees, contracts with a vendor, or contracts with local units,
8 or any combination of these.

9 (iii) The total estimated cost of the project is \$602,900.00.

10 (iv) The tentative completion date is September 30, 2023.

11 (4) Payments under this section shall be made on a schedule
12 determined by the department.

13 (5) Within 30 days after the department has made all payments
14 under subsection (3), the department shall report the following to
15 the senate and house of representatives standing committees on
16 appropriations subcommittees on general government, the state
17 budget office, and the fiscal agencies:

18 (a) The total amount of payments made.

19 (b) If the payments were prorated, the amount of proration.

20 (c) A list of each payment made to cities, villages,
21 townships, counties, and regional councils of government.

22 Sec. 802. From the funds appropriated in part 1 for high water
23 public infrastructure repair, the department shall award grants to
24 counties, cities, villages, and townships for public infrastructure
25 damages or prevention methods due to high waters and shoreline
26 erosion. Grants shall be awarded on a competitive basis and shall
27 be used to address public infrastructure projects or repairs that
28 benefit the overall health, safety, and welfare of communities. A
29 grant to a single community shall not exceed \$250,000.00 and the



1 recipient shall be required to contribute a minimum of 25% of the
2 total project cost.

3 Sec. 803. From the funds appropriated in part 1 for property
4 tax assessor training, the department shall expand in-person
5 training throughout this state in at least each regional prosperity
6 zone. The department shall notify all property tax assessors in
7 each regional zone when training is available for that zone.
