January 16, 2020, Introduced by Reps. Filler, Hall, Cambensy, Garza and Wendzel and referred to the Committee on Regulatory Reform.

A bill to amend 1998 PA 58, entitled
"Michigan liquor control code of 1998,"
(MCL 436.1101 to 436.2303) by adding section 602.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 **Sec. 602. A manufacturer's termination, cancellation,**
2 **nonrenewal, or discontinuation of an agreement with a wholesaler as**
3 **allowed under sections 305(13) and 403(13), as applicable, is void**
4 **if the manufacturer sells the brands or brands of beer or wine, as**
5 **applicable, subject to the termination, cancellation, nonrenewal,**



1 or discontinuation to a wholesaler or retailer within this state
2 before the expiration of 24 months after the effective date of the
3 written notice provided to a wholesaler as required under section
4 305(13) or 403(13), as applicable.
