

SENATE BILL NO. 184

March 07, 2019, Introduced by Senator VANDERWALL and referred to the Committee on Regulatory Reform.

A bill to amend 1978 PA 368, entitled "Public health code," by amending sections 17905 and 17906 (MCL 333.17905 and 333.17906), as amended by 2015 PA 166.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 17905. (1) The department shall issue a license under
2 this article as an athletic trainer to an individual who meets all
3 of the following requirements:

1 (a) Applies to the department on a form provided by the
2 department.

3 (b) Meets the requirements for licensure in rules promulgated
4 ~~pursuant to~~ **under** section 17904.

5 (c) Pays the fees prescribed in section 16336.

6 (2) The department, **in consultation with the board**, shall
7 promulgate rules to ~~require at least 75 clock hours of continuing~~
8 ~~education within each 3-year license cycle in subjects related to~~
9 ~~athletic training and approved by the department.~~ **establish**
10 **continuing education requirements for athletic trainers.**
11 **Notwithstanding the requirements of part 161, beginning the license**
12 **cycle after the effective date of the rules promulgated under this**
13 **subsection, an individual must meet the continuing education**
14 **requirements established under this subsection. The department, in**
15 **consultation with the board, shall promulgate rules to require**
16 **licensees seeking renewal to furnish evidence acceptable to the**
17 **department and the board of the successful completion, during the**
18 **preceding license cycle, of those continuing education**
19 **requirements.**

21 section 17905 for a 3-year license cycle. The license is renewable
22 upon payment of the prescribed license renewal fee and ~~submission~~
23 ~~to the department of proof of satisfactory completion of at least~~
24 ~~75 clock hours of continuing education within the 3-year license~~
25 ~~cycle in subjects related to athletic training and approved by the~~
26 ~~department.~~ **the successful completion of the requirements for**
27 **license renewal in rules promulgated under section 17905(2).**

28 ~~(2) In addition to the continuing education requirements of~~
