Appropriations; zero budget; supplemental appropriations; provide for certain fiscal years.
Creates appropriations act.

HB 4044 Rep. Simpson
Torts; product liability; immunity from liability for drugs that have been approved by federal food and drug administration; rescind.
Amends sec. 2946 of 1961 PA 236 (MCL 600.2946).

HB 4045 Rep. McDowell
Civil procedure; statute of limitations; drug product liability cases previously prohibited because of FDA approval defense; allow to be commenced within 3 years of repeal of the defense.
Amends sec. 5805 of 1961 PA 236 (MCL 600.5805).

HB 4046 Rep. Valentine
Consumer protection; unfair trade practices; liability for inaccurate representations concerning risks of certain drugs, medications, and supplements; clarify.
Amends secs. 2 & 3 of 1976 PA 331 (MCL 445.902 & 445.903).

SB 191 Sen. Richardville
Occupations; accounting; qualifications for certified public accountants; revise, and provide certain changes to the peer review requirement.
Amends secs. 725 & 729 of 1980 PA 299 (MCL 339.725 & 339.729).

HB 4065 Rep. Mayes
Crimes; animals; fleeing the scene of dog or wolf-dog cross bite incident or failing to provide assistance to bitten individual; prohibit and provide penalties.
