God, bless the leaders of our state with the wisdom to declare, "V'eileh ha-Mishpatim"—these are the guidelines to advance the cause of a just society. Amen.

Whether it's associations, organizations, or companies in the insurance industry or constituents and citizens from across the state, there is little doubt that there is interest from all sides of this issue. I welcome all input, as this is one issue that must be solved, and I need your involvement now and your assistance in the process in order to be successful in my efforts. I look forward to working with you.
