A bill to amend 1956 PA 218, entitled
"The insurance code of 1956,"
by amending sections 1301, 1311, 1312, 1315, 1325, 1333, 1341,
1343, 1351, 1355, and 1371 (MCL 500.1301, 500.1311, 500.1312,
500.1315, 500.1325, 500.1333, 500.1341, 500.1343, 500.1351,
500.1355, and 500.1371), sections 1301, 1312, 1315, 1351, and 1371
as amended by 1992 PA 182, section 1311 as amended by 2010 PA 61,
section 1325 as amended by 1994 PA 227, section 1341 as amended by
1994 PA 443, and section 1343 as amended by 1995 PA 219, and by
adding sections 1325a and 1357.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1301. As used in this chapter:
- 2 (A) "ENTERPRISE RISK" MEANS AN ACTIVITY, CIRCUMSTANCE, EVENT,
- 3 OR SERIES OF EVENTS INVOLVING 1 OR MORE AFFILIATES OF AN INSURER

1 THAT, IF NOT REMEDIED PROMPTLY, IS LIKELY TO HAVE A MATERIAL
2 ADVERSE EFFECT ON THE FINANCIAL CONDITION OR LIQUIDITY OF THE
3 INSURER OR ITS INSURANCE HOLDING COMPANY SYSTEM AS A WHOLE,
4 INCLUDING, BUT NOT LIMITED TO, ANYTHING THAT WOULD CAUSE THE
5 INSURER TO BE HAZARDOUS TO POLICYHOLDERS, CREDITORS, AND THE
6 PUBLIC.

7 (B) ~~(a)~~—"Insurer" means that term as defined in section 106,
8 except that it does not include agencies, authorities, or
9 instrumentalities of the United States, its possessions and
10 territories, the commonwealth of Puerto Rico, the District of
11 Columbia or a state or political subdivision of a state, fraternal
12 benefit societies, or nonprofit health care corporations.

13 (C) "NAIC" MEANS THE NATIONAL ASSOCIATION OF INSURANCE
14 COMMISSIONERS.

15 (D) ~~(b)~~—"Person" means that term as defined in section 114,
16 except that it does not include ~~any~~~~A~~ securities broker performing
17 no more than the usual and customary broker's function, so long as
18 the securities broker holds less than 10% of the voting securities
19 of an insurer or of any person that controls an insurer.

20 Sec. 1311. (1) A person other than the issuer shall not make a
21 tender offer for or a request or invitation for tenders of, or
22 enter into ~~any~~~~AN~~ agreement to exchange securities for, seek to
23 acquire, or acquire, in the open market or otherwise, ~~any~~~~A~~ voting
24 security of a domestic insurer if, after the consummation thereof,
25 the person directly or indirectly, or by conversion or by exercise
26 of ~~any~~~~A~~ right to acquire, would be in control of the insurer. A
27 person shall not enter into an agreement to merge with or otherwise

1 to acquire control of a domestic insurer or any person controlling
2 a domestic insurer unless, at the time an offer, request, or
3 invitation is made or an agreement is entered into, or ~~prior to~~
4 **BEFORE** the acquisition of the securities if no offer or agreement
5 is involved, the person has filed with the ~~commissioner~~**DIRECTOR**
6 and has sent to the insurer, which has sent to its shareholders, a
7 statement containing the information required by this chapter and
8 the offer, request, invitation, agreement, or acquisition has been
9 approved by the ~~commissioner~~**DIRECTOR** in the manner prescribed in
10 this chapter.

11 ~~—— (2) Until May 1, 2012, if a domestic property and casualty~~
12 ~~insurer has 200 employees or fewer, directly or indirectly through~~
13 ~~an affiliate transacting the insurer's business, any proposal to~~
14 ~~enter into an agreement to merge with or otherwise acquire control~~
15 ~~of the domestic insurer or any person controlling the domestic~~
16 ~~insurer, or, for the purpose of obtaining control, that seeks the~~
17 ~~election of 2 or more members of the board of directors of the~~
18 ~~domestic insurer or any person controlling the domestic insurer,~~
19 ~~shall, in addition to the requirements of subsection (1), require~~
20 ~~the approval of 66.67% of the outstanding voting securities if the~~
21 ~~proposal is not supported by a majority of the domestic insurer's~~

26 **(2) IF A PERSON HAS NOT FILED A STATEMENT UNDER SUBSECTION**
27 **(1), A CONTROLLING PERSON OF A DOMESTIC INSURER SEEKING TO DIVEST**

1 ITS CONTROLLING INTEREST IN THE DOMESTIC INSURER, IN ANY MANNER,
2 SHALL FILE WITH THE DIRECTOR, WITH A COPY TO THE INSURER, A
3 CONFIDENTIAL NOTICE OF ITS PROPOSED DIVESTITURE AT LEAST 30 DAYS
4 BEFORE THE CESSATION OF CONTROL. THE DIRECTOR SHALL DETERMINE THOSE
5 INSTANCES IN WHICH THE PERSON OR PERSONS SEEKING TO DIVEST OR TO
6 ACQUIRE A CONTROLLING INTEREST IN AN INSURER ARE REQUIRED TO FILE
7 TO OBTAIN APPROVAL OF THE TRANSACTION. THE INFORMATION MUST REMAIN
8 CONFIDENTIAL UNTIL THE CONCLUSION OF THE TRANSACTION UNLESS THE
9 DIRECTOR DETERMINES THAT CONFIDENTIAL TREATMENT WILL INTERFERE WITH
10 ENFORCEMENT OF THIS SECTION.

11 (3) The person who proposes to enter into an agreement to
12 merge with or otherwise acquire control of a domestic insurer shall
13 file a ~~notification~~ **NOTICE** with the ~~commissioner~~, **DIRECTOR**, in such
14 **A** form and containing the information prescribed by applicable rule
15 promulgated or order issued by the ~~commissioner~~. **DIRECTOR**.

16 (4) For purposes of this section ~~through section~~ **AND SECTIONS**
17 **1312 TO** 1319, a domestic insurer ~~shall include any~~ **INCLUDES A**
18 person controlling a domestic insurer and any foreign insurer whose
19 written insurance premium in this state for each of the most recent
20 3 years exceeds the premiums written in its state of domicile and
21 whose written premium in this state was 20% or more of its total
22 written premium in each of the most recent 3 years.

23 Sec. 1312. (1) The statement ~~to be~~ filed with the ~~commissioner~~
24 **DIRECTOR UNDER SECTION 1311(1)** shall be made under oath or
25 affirmation and ~~shall~~ **MUST** contain **ALL OF** the following
26 information:

27 (a) The name and address of each person by whom or on whose

1 behalf the merger or other acquisition of control ~~referred to~~
2 **DESCRIBED** in section 1311 ~~is to~~ **WILL** be effected, hereinafter
3 ~~called~~ **REFERRED TO IN THIS SECTION AND SECTION 1315 AS** the
4 acquiring party. If the person is an individual, his or her
5 principal occupation, all offices and positions held during the
6 past 5 years, any civil judgments against the person for \$25,000.00
7 or more in civil fines or penalties or injunctive or other
8 equitable relief, and any conviction of crimes other than minor
9 traffic violations during the past 10 years. If the person is not
10 an individual, a report of the nature of its business operations
11 during the past 5 years or for ~~such a~~ lesser period as ~~IN WHICH~~ the
12 person and any predecessors of the person have been in existence,
13 an informative description of the business intended to be done by
14 the person and the person's subsidiaries, and a list of all
15 individuals who are or who have been selected to become directors
16 or executive officers of the person or who perform or will perform
17 functions appropriate to those positions. The list ~~shall~~ **MUST**
18 include for each individual the individual's principal occupation,
19 all offices and positions held during the past 5 years, any civil
20 judgments against the person for \$25,000.00 or more in civil fines
21 or penalties or injunctive or other equitable relief, and any
22 conviction of crimes other than minor traffic violations during the
23 past 10 years.

24 (b) The source, nature, and amount of the consideration used
25 or to be used in effecting the merger or other acquisition of
26 control, a description of any transaction ~~where~~ **IN WHICH** funds were
27 or are to be obtained for ~~such purpose,~~ **THE MERGER OR OTHER**

1 **ACQUISITION**, including any pledge of the insurer's stock, or the
2 stock of any of its subsidiaries or controlling affiliates, and the
3 identity of persons furnishing the consideration. If a source of
4 the consideration is a loan made in the lender's ordinary course of
5 business, the identity of the lender ~~shall~~**MUST** be disclosed but
6 remain confidential if the person filing the statement so requests.

7 (c) Fully audited financial information as to the earnings and
8 financial condition of each acquiring party for the preceding 5
9 fiscal years or for ~~such~~**A** lesser period ~~as~~**IN WHICH** the acquiring
10 party and any predecessors of the acquiring party have been in
11 existence and similar unaudited information as of a date not
12 earlier than 90 days ~~prior to~~**BEFORE** the filing of the statement.

13 (d) Any plans or proposals that each acquiring party may have
14 under consideration concerning the insurer's business operations,
15 including, but not limited to, plans or proposals to liquidate the
16 insurer, to sell its assets, to merge or consolidate it with any
17 person, or to make any other material change in its business or
18 corporate structure or management.

19 (e) The number of shares of any security ~~referred to~~**DESCRIBED**
20 in section 1311 that each acquiring party proposes to acquire, the
21 terms of the offer, request, invitation, agreement, or acquisition
22 ~~referred to~~**DESCRIBED** in section 1311, and a statement as to how
23 the proposal's fairness was arrived at.

24 (f) The amount of each class of ~~any~~**A** security ~~referred to~~
25 **DESCRIBED** in section 1311 that is beneficially owned or concerning
26 which there is a right to acquire beneficial ownership by each
27 acquiring party.

1 (g) A full description of ~~any contracts, arrangements, A~~
2 **CONTRACT, ARRANGEMENT**, or understanding concerning ~~any A~~ security
3 ~~referred to DESCRIBED~~ in section 1311 in which ~~any AN~~ acquiring
4 party is involved, including but not limited to transfer of any of
5 the securities, joint ventures, loan or option arrangements, puts
6 or calls, guarantees of loans, guarantees against loss or
7 guarantees of profits, division of losses or profits, or the giving
8 or withholding of proxies. The description ~~shall~~ **MUST** identify the
9 persons with whom the contracts, arrangements, or ~~understanding~~
10 **UNDERSTANDINGS** have been entered into.

11 (h) A description of the purchase of ~~any A~~ security ~~referred~~
12 ~~to DESCRIBED~~ in section 1311 during the 12 calendar months
13 preceding the filing of the statement, by ~~any AN~~ acquiring party,
14 including the dates of purchase, names of the purchasers, and
15 consideration paid or agreed to be paid for the security.

16 (i) A description of ~~any recommendations A RECOMMENDATION~~ to
17 purchase ~~any A~~ security ~~referred to DESCRIBED~~ in section 1311 made
18 during the 12 calendar months preceding the filing of the
19 statement, by ~~any AN~~ acquiring party or by ~~anyone ANOTHER PERSON~~
20 based upon interviews or at the suggestion of the acquiring party.

21 (j) Copies of all tender offers for, requests or invitations
22 for tenders of, exchange offers for, and agreements to acquire or
23 exchange ~~any securities referred to A SECURITY DESCRIBED~~ in section
24 1311 and additional related distributed soliciting material.

25 (k) The terms of ~~any AN~~ agreement, contract, or understanding
26 made with or proposed to be made with ~~any A~~ broker-dealer as to
27 solicitation of securities ~~referred to DESCRIBED~~ in section 1311

1 for tender, and the amount of ~~any fees, commissions,~~ **A FEE,**
 2 **COMMISSION,** or other compensation to be paid to ~~broker-dealers.~~ **A**
 3 **BROKER-DEALER.**

4 ~~(l) Such additional information as the commissioner prescribes~~
 5 ~~by order or rule as necessary or appropriate for the protection of~~
 6 ~~the insurer's policyholders and securityholders or in the public~~
 7 ~~interest.~~ **ADDITIONAL INFORMATION THAT THE DIRECTOR PRESCRIBES BY**
 8 **ORDER OR RULE AS NECESSARY OR APPROPRIATE FOR THE PROTECTION OF THE**
 9 **INSURER'S POLICYHOLDERS AND SECURITYHOLDERS OR IN THE PUBLIC**
 10 **INTEREST.**

11 **(2) A PERSON REQUIRED TO FILE THE STATEMENT DESCRIBED IN**
 12 **SECTION 1311 SHALL DO ALL OF THE FOLLOWING:**

13 **(A) FILE THE ANNUAL ENTERPRISE RISK REPORT UNDER SECTION**
 14 **1325A, FOR AS LONG AS CONTROL EXISTS.**

15 **(B) PROVIDE, AND ENSURE THAT ALL SUBSIDIARIES WITHIN ITS**
 16 **CONTROL IN THE INSURANCE HOLDING COMPANY SYSTEM WILL PROVIDE,**
 17 **INFORMATION TO THE DIRECTOR ON REQUEST AS NECESSARY TO EVALUATE**
 18 **ENTERPRISE RISK TO THE INSURER.**

19 **Sec. 1315. (1) The ~~commissioner~~ DIRECTOR shall approve any ~~A~~**
 20 **merger or other acquisition of control ~~referred to~~ DESCRIBED in**
 21 **section 1311 of a domestic insurer unless the ~~commissioner~~ DIRECTOR**
 22 **determines ~~on the basis of~~ FROM information furnished to the**
 23 **~~commissioner~~ DIRECTOR on the merger or other acquisition of control**
 24 **1 or more of the following:**

25 **(a) After the change of control, the domestic insurer ~~referred~~**
 26 **~~to~~ DESCRIBED in section 1311 would not be able to satisfy the**
 27 **requirements for the issuance of a certificate of authority to**

1 write the types of insurance for which it is presently authorized.

2 (b) The ~~effect of the merger~~ or other acquisition of control
3 would ~~be~~ substantially ~~to~~ lessen competition in insurance in this
4 state or tend to create a monopoly in this state.

5 (c) The financial condition of ~~any~~ **AN** acquiring party ~~is such~~
6 ~~as~~ might jeopardize the financial stability of the insurer, or
7 prejudice the interest of its policyholders or the interests of ~~any~~
8 **A** remaining ~~securityholders~~ **SECURITYHOLDER** who ~~are~~ **IS** unaffiliated
9 with the acquiring party.

10 (d) The terms of the offer, request, invitation, agreement, or
11 acquisition ~~referred to~~ **DESCRIBED** in section 1311 are unfair and
12 unreasonable to the insurer's policyholders or securityholders.

13 (e) The ~~plans or proposals that the acquiring party has~~
14 **PARTY'S PLAN OR PROPOSAL** to liquidate the insurer, sell its assets,
15 consolidate or merge ~~it~~ **THE INSURER** with ~~any~~ **A** person, or to make
16 any other material change in its business or corporate structure or
17 management, ~~are~~ **IS** unfair and unreasonable to the insurer's
18 policyholders, and not in the public interest.

19 (f) The competence, experience, and integrity of ~~these~~ **THE**
20 persons who would control the operation of the insurer are such
21 that it would not be in the interest of the insurer's policyholders
22 or the general public to permit the merger or other acquisition of
23 control.

24 (G) **THE ACQUISITION IS LIKELY TO BE HAZARDOUS OR PREJUDICIAL**
25 **TO THE INSURANCE-BUYING PUBLIC.**

26 (2) **THE DIRECTOR MAY HOLD A PUBLIC HEARING TO RECEIVE EVIDENCE**
27 **AND TO HEAR PARTIES AFFECTED BY THE MERGER OR ACQUISITION. A**

1 HEARING UNDER THIS SUBSECTION MUST BE HELD WITHIN 30 DAYS AFTER THE
2 FILING OF A STATEMENT UNDER SECTION 1311. THE DIRECTOR SHALL
3 PROVIDE NOTICE OF THE HEARING TO THE PERSON FILING THE STATEMENT AT
4 LEAST 20 DAYS BEFORE THE HEARING. NOT LESS THAN 7 DAYS' NOTICE OF
5 THE PUBLIC HEARING SHALL BE GIVEN BY THE PERSON FILING THE
6 STATEMENT TO THE INSURER AND TO ANY OTHER PERSONS DESIGNATED BY THE
7 DIRECTOR. IF THE PROPOSED ACQUISITION OF CONTROL WILL REQUIRE THE
8 APPROVAL OF MORE THAN 1 INSURANCE COMMISSIONER, THE PUBLIC HEARING
9 MAY BE HELD ON A CONSOLIDATED BASIS ON REQUEST OF THE PERSON FILING
10 THE STATEMENT OR AS DETERMINED BY THE DIRECTOR. THE DIRECTOR MAY
11 OPT OUT OF A CONSOLIDATED HEARING AND SHALL PROVIDE NOTICE TO THE
12 PERSON WHO FILED THE STATEMENT UNDER SECTION 1311 OF THE OPT-OUT
13 WITHIN 10 DAYS AFTER THE RECEIPT OF THE STATEMENT REQUIRED BY
14 SECTION 1311. A HEARING CONDUCTED ON A CONSOLIDATED BASIS MUST BE
15 HELD WITHIN THE UNITED STATES BEFORE THE COMMISSIONERS OF THE
16 STATES IN WHICH THE INSURERS ARE DOMICILED.

17 (3) IN CONNECTION WITH A CHANGE OF CONTROL OF A DOMESTIC
18 INSURER, A DETERMINATION BY THE DIRECTOR THAT THE PERSON ACQUIRING
19 CONTROL OF THE INSURER SHALL BE REQUIRED TO MAINTAIN OR RESTORE THE
20 CAPITAL OF THE INSURER TO THE LEVEL REQUIRED BY THIS ACT SHALL BE
21 MADE NOT LATER THAN 60 DAYS AFTER THE DATE OF NOTIFICATION OF THE
22 CHANGE OF CONTROL SUBMITTED UNDER SECTION 1311.

4 Sec. 1325. (1) An insurer subject to registration **UNDER**
5 **SECTION 1324** shall file a registration statement on a form provided
6 by the ~~commissioner~~**DIRECTOR** containing the following current
7 information:

8 (a) The capital structure, comprehensive financial condition,
9 ownership, and management of the insurer and ~~any~~**A** person
10 controlling the insurer.

11 (b) The identity and relationship of every member of the
12 insurance holding company system.

13 (c) The following agreements in force, relationships
14 subsisting, and transactions currently outstanding or that have
15 occurred during the last calendar year between the insurer and its
16 affiliates:

17 (i) Loans, other investments or purchases, sales, or exchanges
18 of securities of the affiliates by the insurer or of the insurer by
19 its affiliates.

20 (ii) Purchases, sales, or exchanges of assets.

21 (iii) Transactions not in the ordinary course of business.

22 (iv) Guarantees or undertakings for the benefit of an
23 affiliate that result in an actual contingent exposure of the
24 insurer's assets to liability, other than insurance contracts
25 entered into in the ordinary course of the insurer's business.

26 (v) All management and service contracts and all cost sharing
27 arrangements.

1 (vi) Reinsurance agreements.

2 (vii) Dividends and other distributions to shareholders.

3 (viii) Consolidated tax allocation agreements.

4 (d) ~~Any-A~~ pledge of the insurer's stock, including stock of
5 ~~any-A~~ subsidiary or controlling affiliate for a loan made to ~~any-A~~
6 member of the insurance holding system.

7 (e) A summary outlining all items in the current registration
8 statement representing changes from the prior registration
9 statement.

10 (f) Other matters concerning transactions between registered
11 insurers and any affiliates as ~~may be included from time to time in~~
12 any registration forms adopted or approved by the
13 ~~commissioner-DIRECTOR~~.

14 (G) STATEMENTS THAT THE INSURER'S BOARD OF DIRECTORS OVERSEES
15 CORPORATE GOVERNANCE AND INTERNAL CONTROLS AND THAT THE INSURER'S
16 OFFICERS AND SENIOR MANAGEMENT HAVE APPROVED, IMPLEMENTED, AND
17 CONTINUE TO MAINTAIN AND MONITOR CORPORATE GOVERNANCE AND INTERNAL
18 CONTROL PROCEDURES.

19 (2) If a person ultimately controlling the insurer or
20 intermediately controlling the insurer is registered on a national
21 stock exchange or is otherwise required to make periodic reports to
22 the United States ~~securities and exchange commission~~ **SECURITIES AND**
23 **EXCHANGE COMMISSION** or other instrumentality of a state or the
24 government of the United States or of ~~any-A~~ foreign nation or
25 jurisdiction regulating the financial conduct of that person, the
26 insurer shall file ~~such~~ **THE** reports with the ~~commissioner-DIRECTOR~~
27 in addition to other information required by the

1 ~~commissioner~~.DIRECTOR. IF REQUESTED BY THE DIRECTOR, THE INSURER

4 ~~securities and exchange commission or other instrumentality of a~~

7 SEC. 1325A. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION
8 (2), THE ULTIMATE CONTROLLING PERSON OF AN INSURER SUBJECT TO
9 REGISTRATION UNDER SECTION 1324 SHALL FILE AN ANNUAL ENTERPRISE
10 RISK REPORT WITH THE DIRECTOR OR A JURISDICTION DESIGNATED BY THE
11 DIRECTOR. THE REPORT MUST BE APPROPRIATE TO THE NATURE, SCALE, AND
12 COMPLEXITY OF THE OPERATIONS OF THE INSURANCE HOLDING COMPANY
13 SYSTEM AND MUST, TO THE BEST OF THE ULTIMATE CONTROLLING PERSON'S

15 OR PRIVILEGED UNDER THE LAWS OF THE JURISDICTION THAT IS THE SOURCE
16 OF THE DOCUMENT, MATERIAL, OR INFORMATION. THE DISCLOSURE OR
17 SHARING OF INFORMATION, A DOCUMENT, OR OTHER MATERIAL TO THE
18 DIRECTOR OR OTHER PERSON UNDER THIS SECTION IS NOT A WAIVER OF AN
19 APPLICABLE PRIVILEGE OR CLAIM OF CONFIDENTIALITY.

20 (3) DOCUMENTS, MATERIALS, OR OTHER INFORMATION IN THE
21 POSSESSION OR CONTROL OF THE DEPARTMENT OR THE NAIC UNDER THIS
22 CHAPTER ARE CONFIDENTIAL AND PRIVILEGED, ARE NOT SUBJECT TO THE
23 FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL 15.231 TO 15.246, ARE
24 NOT SUBJECT TO SUBPOENA, AND ARE NOT SUBJECT TO DISCOVERY OR
25 ADMISSIBLE AS EVIDENCE IN A PRIVATE CIVIL OR ADMINISTRATIVE ACTION.
26 THE DIRECTOR SHALL ENTER INTO WRITTEN AGREEMENTS WITH THE NAIC
27 GOVERNING SHARING AND USE OF INFORMATION PROVIDED UNDER THIS

1 CHAPTER. THE WRITTEN AGREEMENT MUST SPECIFY PROCEDURES AND
2 PROTOCOLS REGARDING THE CONFIDENTIALITY AND SECURITY OF INFORMATION
3 SHARED WITH THE NAIC AND ITS AFFILIATES AND SUBSIDIARIES, INCLUDING
4 PROCEDURES AND PROTOCOLS FOR SHARING BY THE NAIC WITH OTHER STATE,

11 CHAPTER IS SUBJECT TO A REQUEST OR SUBPOENA TO THE NAIC FOR
12 DISCLOSURE OR PRODUCTION, AND REQUIRE THE NAIC AND ITS AFFILIATES
13 AND SUBSIDIARIES TO CONSENT TO INTERVENTION BY AN INSURER IN A
14 JUDICIAL OR ADMINISTRATIVE ACTION.

15 (4) THE SHARING OF INFORMATION BY THE DIRECTOR UNDER THIS
16 CHAPTER IS NOT A DELEGATION OF REGULATORY AUTHORITY OR RULE-MAKING,
17 AND THE DIRECTOR IS SOLELY RESPONSIBLE FOR THE ADMINISTRATION,
18 EXECUTION, AND ENFORCEMENT OF THE PROVISIONS OF THIS CHAPTER.

19 SEC. 1357. (1) THE DIRECTOR MAY PARTICIPATE IN A SUPERVISORY
20 COLLEGE FOR A DOMESTIC INSURER THAT IS PART OF AN INSURANCE HOLDING
21 COMPANY SYSTEM WITH INTERNATIONAL OPERATIONS TO DETERMINE THE
22 INSURER'S FINANCIAL CONDITION, BUSINESS STRATEGY, RISK MANAGEMENT,
23 RISK EXPOSURES, GOVERNANCE PROCESSES, REGULATORY POSITION, OR
24 LEGALITY OF CONDUCT. THE DIRECTOR MAY PARTICIPATE IN A SUPERVISORY
25 COLLEGE WITH OTHER REGULATORS INCLUDING STATE, FEDERAL, AND
26 INTERNATIONAL REGULATORY AGENCIES, CHARGED WITH THE SUPERVISION OF
27 THE INSURER OR ITS AFFILIATES. THE AUTHORITY OF THE DIRECTOR UNDER

1 THIS SECTION INCLUDES, BUT IS NOT LIMITED TO, INITIATING A
 2 SUPERVISORY COLLEGE, CLARIFYING MEMBERSHIP AND PARTICIPATION OF

2 (6) IF THE DIRECTOR DETERMINES THAT A PERSON VIOLATED SECTION
3 1311 AND THE VIOLATION PREVENTS THE FULL UNDERSTANDING OF THE
4 ENTERPRISE RISK OF THE INSURER BY AFFILIATES OR BY THE INSURANCE
5 HOLDING COMPANY SYSTEM, THE VIOLATION MAY SERVE AS AN INDEPENDENT
6 BASIS FOR DISAPPROVING DIVIDENDS OR DISTRIBUTIONS AND FOR PLACING
