

HOUSE BILL No. 4109

January 17, 1995, Introduced by Reps. Griffin, Baade, Owen and Randall and referred to the Committee on Health Policy.

A bill to amend Act No. 368 of the Public Acts of 1978, entitled as amended
"Public health code,"
as amended, being sections 333.1101 to 333.25211 of the Michigan Compiled Laws, by adding sections 16433, 16602, 17089, 17243, 17434, 17557, 17771, 17823, 18034, 18118, 18238, 18312, 18423, and 18836.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 8 SEC. 17434. (1) AN OPTOMETRIST SHALL NOT REPRESENT HIMSELF
- 9 OR HERSELF TO THE PUBLIC AS HOLDING A LICENSE TO ENGAGE IN THE
- 10 PRACTICE OF ANOTHER HEALTH PROFESSION LICENSED UNDER THIS ARTICLE
- 11 UNLESS HE OR SHE HOLDS A VALID LICENSE UNDER THIS ARTICLE TO
- 12 ENGAGE IN THE PRACTICE OF THAT HEALTH PROFESSION.
- 13 (2) WHILE ENGAGING IN THE PRACTICE OF OPTOMETRY, AN OPTOME-

- 8 IN THE PRACTICE OF ANOTHER HEALTH PROFESSION LICENSED UNDER THIS
- 9 ARTICLE UNLESS HE OR SHE HOLDS A VALID LICENSE UNDER THIS ARTICLE
- 10 TO ENGAGE IN THE PRACTICE OF THAT HEALTH PROFESSION.
- 11 (2) WHILE ENGAGING IN THE PRACTICE OF PHYSICAL THERAPY, A
- 12 PHYSICAL THERAPIST SHALL NOT PERFORM AN ACT, TASK, FUNCTION, OR

- 14 TRAINING.
- 15 SEC. 18034. (1) A PODIATRIST SHALL NOT REPRESENT HIMSELF OR
- 16 HERSELF TO THE PUBLIC AS HOLDING A LICENSE TO ENGAGE IN THE PRAC-
- 17 TICE OF ANOTHER HEALTH PROFESSION LICENSED UNDER THIS ARTICLE
- 18 UNLESS HE OR SHE HOLDS A VALID LICENSE UNDER THIS ARTICLE TO
- 19 ENGAGE IN THE PRACTICE OF THAT HEALTH PROFESSION.
- 20 (2) WHILE ENGAGING IN THE PRACTICE OF PODIATRIC MEDICINE AND
- 21 SURGERY, A PODIATRIST SHALL NOT PERFORM AN ACT, TASK, FUNCTION,
- 22 OR PROCEDURE THAT IS BEYOND THE SCOPE OF HIS OR HER EDUCATION AND
- 23 TRAINING.
- 24 SEC. 18118. (1) A LICENSED PROFESSIONAL COUNSELOR SHALL NOT
- 25 REPRESENT HIMSELF OR HERSELF TO THE PUBLIC AS HOLDING A LICENSE
- 26 TO ENGAGE IN THE PRACTICE OF ANOTHER HEALTH PROFESSION LICENSED
- 27 UNDER THIS ARTICLE UNLESS HE OR SHE HOLDS A VALID LICENSE UNDER

- I THIS ARTICLE TO ENGAGE IN THE PRACTICE OF THAT HEALTH

- 9 PRACTICE OF ANOTHER HEALTH PROFESSION LICENSED UNDER THIS ARTICLE
- 10 UNLESS HE OR SHE HOLDS A VALID LICENSE UNDER THIS ARTICLE TO
- 11 ENGAGE IN THE PRACTICE OF THAT HEALTH PROFESSION.
- (2) WHILE ENGAGING IN THE PRACTICE OF PSYCHOLOGY, A PSYCHOL-

- 15 SEC. 18312. (!) AN OCCUPATIONAL THERAPIST SHALL NOT REPRE-
- 16 SENT HIMSELF OR HERSELF TO THE PUBLIC AS HOLDING A LICENSE TO
- 17 ENGAGE IN THE PRACTICE OF A HEALTH PROFESSION LICENSED UNDER THIS
- 18 ARTICLE UNLESS HE OR SHE HOLDS A VALID LICENSE UNDER THIS ARTICLE
- 19 TO ENGAGE IN THE PRACTICE OF THAT HEALTH PROFESSION.
- 20 (2) WHILE ENGAGING IN THE PRACTICE OF HIS OR HER HEALTH PRO-
- 21 FESSION, AN OCCUPATIONAL THERAPIST SHALL NOT PERFORM AN ACT,

- 26 TICE OF A HEALTH PROFESSION LICENSED UNDER THIS ARTICLE UNLESS HE
