

HOUSE BILL No. 4191

January 30, 1995, Introduced by Rep. Schroer and referred to the Committee on Appropriations.

A bill to amend Act No. 280 of the Public Acts of 1939, entitled as amended

"The social welfare act,"

as amended, being sections 400.1 to 400.119b of the Michigan Compiled Laws, by adding section 117.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as
- 2 amended, being sections 400.1 to 400.119b of the Michigan
- 3 Compiled Laws, is amended by adding section 117 to read as
- 4 follows:
- 5 SEC. 117. (1) THE STATE DEPARTMENT SHALL DEVELOP AND IMPLE-
- 6 MENT A SYSTEM FOR TRACKING EXPENDITURES FOR TRAINING OF DEPART-
- 7 MENT AND PRIVATE AGENCY STAFF INVOLVED IN CHILD WELFARE
- 8 SERVICES. THE DEPARTMENT SHALL SUBMIT AN ANNUAL REPORT TO THE

- 1 LEGISLATURE BY MARCH 1 OF EACH YEAR DETAILING THE EXPENDITURES
- 2 MADE FOR CHILD WELFARE TRAINING DURING THE PREVIOUS FISCAL YEAR.
- 3 (2) THE CHILD WELFARE TRAINING REVOLVING FUND IS CREATED IN
- 4 THE STATE TREASURY. THE FUND SHALL BE ADMINISTERED BY THE
- 5 DEPARTMENT AND SHALL BE USED ONLY AS PRESCRIBED IN THIS SECTION.
- 6 (3) THE STATE TREASURER SHALL CREDIT TO THE CHILD WELFARE
- 7 TRAINING REVOLVING FUND ALL AMOUNTS APPROPRIATED FOR THAT PURPOSE
- 8 AND MONEY REIMBURSED TO THE STATE BY THE FEDERAL GOVERNMENT FOR
- 9 CHILD WELFARE TRAINING. THE FUND MAY ALSO ACCEPT GIFTS AND DONA-
- 10 TIONS FROM PRIVATE SOURCES. THE STATE TREASURER SHALL DIRECT THE
- 11 INVESTMENT OF THE MONEY IN THE FUND. EARNINGS FROM THOSE INVEST-
- 12 MENTS SHALL BE CREDITED TO THE FUND.
- 13 (4) ANY MONEY REMAINING IN THE CHILD WELFARE TRAINING
- 14 REVOLVING FUND AT THE END OF A FISCAL YEAR SHALL BE CARRIED OVER
- 15 IN THE FUND TO THE NEXT AND SUCCEEDING FISCAL YEARS AND SHALL NOT
- 16 BE CREDITED TO OR REVERT TO THE GENERAL FUND.
- 17 (5) THE DEPARTMENT SHALL USE THE MONEY IN THE CHILD WELFARE
- 18 TRAINING REVOLVING FUND TO PROVIDE SPECIALIZED TRAINING PURSUANT
- 19 TO TRAINING PLANS APPROVED BY THE FEDERAL GOVERNMENT UNDER TITLE
- 20 IV OF THE SOCIAL SECURITY ACT, CHAPTER 531, 49 STAT. 620, 42
- 21 U.S.C. 601 TO 603, 604 TO 610, 612 TO 613, 615 TO 617, 620 TO
- 22 629e, 651 TO 669, 670 TO 677, 679, AND 681 TO 687, FOR ALL OF THE
- 23 FOLLOWING PUBLIC AND PRIVATE AGENCY PERSONNEL OR CLIENTS:
- 24 (A) FOSTER CARE WORKERS.
- 25 (B) PROTECTIVE SERVICES WORKERS.
- 26 (C) DELINQUENCY WORKERS.

- (D) PREVENTION SERVICES WORKERS.
- 2 (E) ADOPTION WORKERS.
- 3 (F) FAMILY HOME OR CASE AIDES.
- 4 (G) SUPERVISORS AND PROGRAM SUPPORT STAFF.
- 5 (H) ANY OTHER WORKERS PROVIDING CHILD WELFARE SERVICES.
- 6 (I) ADOPTIVE AND FOSTER PARENTS.
