THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. The title of Act No. 451 of the Public Acts of
- 2 1976, as amended, being sections 380.1 to 380.1852 of the
- 3 Michigan Compiled Laws, is amended and section 1287a is added to
- 4 read as follows:
- 5 TITLE
- 6 An act to provide a system of public instruction and elemen-
- 7 tary and secondary schools; to revise, consolidate, and classify
- 8 the laws relating to elementary and secondary education; to
- 9 provide for the classification, organization, regulation, and

1 maintenance of schools, school districts, and intermediate school 2 districts; to prescribe rights, powers, duties, and privileges of 3 schools, school districts, and intermediate school districts; to 4 provide for the regulation of school teachers and school adminis-5 trators; to provide for school elections and to prescribe powers 6 and duties with respect thereto; to provide for the levy and col-7 lection of taxes; to provide for the borrowing of money and issu-8 ance of bonds and other evidences of indebtedness; to establish a 9 fund and provide for expenditures from that fund; to provide for 10 and prescribe the powers and duties of certain state departments, 11 the state board of education, and certain other boards and offi-12 cials: TO CREATE A STATEWIDE CABINET FOR PROFESSIONAL AND TECHNI-13 CAL STANDARDS WITHIN THE LEGISLATIVE COUNCIL AND PRESCRIBE ITS 14 DUTIES; to provide for licensure of boarding schools; to pre-15 scribe penalties; and to repeal certain acts and parts of acts. 16 SEC. 1287A. (1) THE STATEWIDE CABINET FOR PROFESSIONAL AND 17 TECHNICAL STANDARDS IS CREATED WITHIN THE LEGISLATIVE COUNCIL TO 18 DEVELOP, IMPLEMENT, AND OVERSEE A STATEWIDE SYSTEM FOR GATHERING, 19 DISSEMINATING, AND PROVIDING ACCURATE INFORMATION ON EMPLOYMENT 20 AND SKILL-LEVEL NEEDS IN THE WORKPLACE AND TO ENGAGE IN RELATED 21 ACTIVITIES. THE CABINET SHALL CONSIST OF 19 MEMBERS AS FOLLOWS: (A) NOT LATER THAN OCTOBER 1, 1995, BASED ON NOMINATIONS 22 23 SUBMITTED BY ORGANIZATIONS REPRESENTING THE BUSINESS COMMUNITY, 24 THE EDUCATION COMMUNITY, AND ORGANIZED LABOR, THE GOVERNOR, THE 25 SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND THE SENATE MAJORITY 26 LEADER EACH SHALL APPOINT 3 MEMBERS, 1 REPRESENTING BUSINESS, 1 27 REPRESENTING EDUCATION, AND 1 REPRESENTING ORGANIZED LABOR. THE

- 1 GOVERNOR, SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND SENATE
- 2 MAJORITY LEADER SHALL CONFER TO ENSURE THAT, OF THE MEMBERS
- 3 APPOINTED TO REPRESENT EDUCATION, 1 REPRESENTS LOCAL PUBLIC EDU-
- 4 CATION, 1 REPRESENTS POSTSECONDARY INSTITUTIONS, AND 1 REPRESENTS
- 5 VOCATIONAL EDUCATION.
- 6 (B) IN ADDITION TO THE MEMBERS APPOINTED UNDER SUBDIVISION
- 7 (A), NOT LATER THAN OCTOBER 1, 1995, BASED ON NOMINATIONS SUBMIT-
- 8 TED BY ORGANIZATIONS REPRESENTING BUSINESS AND INDUSTRY, THE
- 9 SPEAKER OF THE HOUSE OF REPRESENTATIVES AND THE SENATE MAJORITY
- 10 LEADER EACH SHALL APPOINT 1 MEMBER TO REPRESENT BUSINESS AND
- 11 INDUSTRY.
- (C) NOT LATER THAN OCTOBER 1, 1995, BASED ON NOMINATIONS
- 13 SUBMITTED BY COMMUNITY BASED ORGANIZATIONS, THE GOVERNOR SHALL
- 14 APPOINT | MEMBER TO REPRESENT COMMUNITY BASED ORGANIZATIONS.
- 15 (D) EACH OF THE FOLLOWING SHALL SERVE AS A MEMBER:
- 16 (i) ONE MEMBER OF THE STATE BOARD OF EDUCATION, AS DESIG-
- 17 NATED BY THE STATE BOARD.
- 18 (ii) THE SUPERINTENDENT OF PUBLIC INSTRUCTION OR HIS OR HER
- 19 DESIGNEE.
- 20 (iii) THE DIRECTOR OF LABOR OR HIS OR HER DESIGNEE.
- 21 (iv) THE DIRECTOR OF COMMERCE OR HIS OR HER DESIGNEE.
- 22 (v) THE DIRECTOR OF THE STATE DEPARTMENT OF SOCIAL SERVICES
- 23 OR HIS OR HER DESIGNEE.
- 24 (vi) THE GOVERNOR'S ADVISER ON JOB TRAINING OR HIS OR HER
- 25 DESIGNEE.

- 1 (vii) ONE MEMBER OF THE MICHIGAN EMPLOYMENT SECURITY
- 2 COMMISSION, AS DESIGNATED BY THE MICHIGAN EMPLOYMENT SECURITY
- 3 COMMISSION.
- 4 (2) MEMBERS OF THE CABINET APPOINTED UNDER SUBSECTION
- 5 (1)(A), (B), OR (C) SHALL SERVE FOR TERMS OF 3 YEARS, EXCEPT THAT
- 6 OF THE MEMBERS INITIALLY APPOINTED TO THE CABINET UNDER
- 7 SUBSECTION (1)(A), 3 SHALL SERVE FOR 5 YEARS, 3 SHALL SERVE FOR 4
- 8 YEARS, AND 3 SHALL SERVE FOR 3 YEARS. THE GOVERNOR, SPEAKER OF
- 9 THE HOUSE OF REPRESENTATIVES, AND SENATE MAJORITY LEADER SHALL
- 10 CONFER AND AGREE ON AN INITIAL APPOINTMENT SCHEDULE THAT ENSURES
- 11 THAT THE TERM OF NOT MORE THAN 1 OF THE REPRESENTATIVES FROM EACH
- 12 OF THE 3 GROUPS DESCRIBED IN SUBSECTION (1)(A) EXPIRES EACH
- 13 YEAR. A VACANCY SHALL BE FILLED IN THE SAME MANNER AS THE ORIGI-
- 14 NAL APPOINTMENT.
- 15 (3) THE GOVERNOR, THE SPEAKER OF THE HOUSE OF REPRESENTA-
- 16 TIVES, AND THE SENATE MAJORITY LEADER JOINTLY SHALL APPOINT 1 OF
- 17 THE MEMBERS OF THE CABINET TO SERVE FOR A 3-YEAR TERM AS THE INI-
- 18 TIAL CHAIRPERSON OF THE CABINET. IF THE GOVERNOR, SPEAKER OF THE
- 19 HOUSE OF REPRESENTATIVES, AND SENATE MAJORITY LEADER DO NOT UNAN-
- 20 IMOUSLY AGREE ON A JOINT APPOINTEE AS THE INITIAL CHAIRPERSON, A
- 21 MAJORITY JOINTLY MAY MAKE THE APPOINTMENT. AFTER THE EXPIRATION
- 22 OF THE TERM OF THE INITIAL CHAIRPERSON, THE CABINET, BY A MAJOR-
- 23 ITY VOTE OF THE MEMBERS SERVING, ANNUALLY SHALL SELECT A MEMBER
- 24 TO SERVE AS CHAIRPERSON. A VACANCY IN THE OFFICE OF CHAIRPERSON
- 25 OF THE CABINET SHALL BE FILLED FOR THE BALANCE OF THE UNEXPIRED
- 26 TERM BY A MAJORITY VOTE OF THE MEMBERS SERVING.

- 1 (4) THE CABINET, BY A MAJORITY VOTE OF THE MEMBERS SERVING,
- 2 ANNUALLY SHALL SELECT A MEMBER TO SERVE AS VICE-CHAIRPERSON AND A
- 3 MEMBER TO SERVE AS SECRETARY. A VACANCY IN EITHER OF THOSE
- 4 OFFICES SHALL BE FILLED FOR THE BALANCE OF THE UNEXPIRED TERM BY
- 5 A MAJORITY VOTE OF THE MEMBERS SERVING.
- 6 (5) THE CABINET, BY A MAJORITY VOTE OF THE MEMBERS SERVING,
- 7 SHALL ADOPT BYLAWS AS ARE APPROPRIATE AND NECESSARY TO CARRY OUT
- 8 THE CABINET'S RESPONSIBILITIES.
- 9 (6) THE LEGISLATIVE COUNCIL SHALL PROVIDE THE CABINET WITH
- 10 SUFFICIENT STAFF TO CARRY OUT THE CABINET'S RESPONSIBILITIES.
- 11 (7) A MEMBER OF THE CABINET SHALL NOT BE PAID A SALARY FOR
- 12 SERVING ON THE CABINET, BUT EACH MEMBER MAY RECEIVE REIMBURSEMENT
- 13 FOR ACTUAL AND NECESSARY TRAVEL AND OTHER EXPENSES INCURRED IN
- 14 THE PERFORMANCE OF OFFICIAL DUTIES.
- 15 (8) NOT LATER THAN JANUARY 1, 1996, THE CABINET SHALL
- 16 DEVELOP AND IMPLEMENT A STATEWIDE SYSTEM FOR GATHERING AND DIS-
- 17 SEMINATING ACCURATE INFORMATION ON CURRENT AND ANTICIPATED
- 18 EMPLOYMENT NEEDS AND FOR DETERMINING THE TYPE AND LEVEL OF SKILLS
- 19 AND EDUCATION THAT WILL BE REQUIRED FOR EMPLOYMENT. TO THE
- 20 EXTENT POSSIBLE, THE SYSTEM SHALL INCORPORATE EXISTING RESOURCES
- 21 OF AND INFORMATION ALREADY GATHERED BY EXISTING AGENCIES, ORGANI-
- 22 ZATIONS, COUNCILS, AND COMMITTEES THAT HAVE BEEN ESTABLISHED BY
- 23 LAW AND THAT HAVE A PRIMARY FUNCTION DIRECTLY RELATED TO EDUCA-
- 24 TION, EMPLOYMENT, OR JOB TRAINING. THE SYSTEM SHALL INCLUDE AT
- 25 LEAST ALL OF THE FOLLOWING:

- 1 (A) THE ESTABLISHMENT OF A STATEWIDE LABOR MARKET
- 2 INFORMATION EXCHANGE NETWORK, TO BE COMPRISED OF SELF-GOVERNING
- 3 STATE AND LOCAL OCCUPATIONAL COUNCILS, AS FOLLOWS:
- 4 (i) A STATE OCCUPATIONAL COUNCIL FOR EACH MAJOR OCCUPATIONAL
- 5 AREA IN THE STATE. THE CABINET SHALL DETERMINE THE MAJOR OCCUPA-
- 6 TIONAL AREAS AND ENSURE THAT THERE ARE A SUFFICIENT NUMBER OF
- 7 STATE OCCUPATIONAL COUNCILS SO THAT EACH MAJOR OCCUPATIONAL AREA
- 8 OR CLUSTER OF OCCUPATIONAL AREAS IS REPRESENTED BY A COUNCIL.
- 9 EACH STATE OCCUPATIONAL COUNCIL SHALL BE COMPOSED OF INDIVIDUALS
- 10 REPRESENTATIVE OF THE MAJOR OCCUPATIONAL AREA FOR WHICH THE COUN-
- 11 CIL IS CREATED AND SHALL BE RESPONSIBLE FOR PROVIDING INFORMATION
- 12 ON CURRENT AND ANTICIPATED EMPLOYMENT NEEDS THROUGHOUT THE STATE
- 13 IN THE OCCUPATIONAL AREA, INCLUDING THE EDUCATION AND SKILLS THAT
- 14 WILL BE REQUIRED, AND FOR DEVELOPING A UNIFORM STANDARD OF COMPE-
- 15 TENCY FOR THE OCCUPATIONAL AREA. THE CABINET SHALL DETERMINE THE
- 16 NUMBER, METHOD FOR SELECTION OR APPOINTMENT, AND LENGTH OF TERM
- 17 OF MEMBERS OF A STATE OCCUPATIONAL COUNCIL; THE RESPONSIBILITY TO
- 18 BE GIVEN TO A STATE OCCUPATIONAL COUNCIL; AND THE PROCEDURES AND
- 19 TIMELINES UNDER WHICH A STATE OCCUPATIONAL COUNCIL IS EXPECTED TO
- 20 OPERATE.
- 21 (ii) LOCAL OCCUPATIONAL COUNCILS TO SERVE PARTICULAR GEO-
- 22 GRAPHIC AREAS. EACH LOCAL OCCUPATIONAL COUNCIL SHALL BE RESPON-
- 23 SIBLE FOR ASSESSING AND PROVIDING INFORMATION ON LOCAL AND
- 24 REGIONAL EMPLOYMENT NEEDS IN THE AREA SERVED BY THE COUNCIL AND
- 25 ASSISTING LOCAL AND INTERMEDIATE SCHOOL DISTRICTS TO IMPLEMENT
- 26 NEEDED CHANGES. IF POSSIBLE, AN EXISTING AGENCY, ORGANIZATION,
- 27 COUNCIL, OR COMMITTEE THAT HAS BEEN ESTABLISHED BY LAW IN THE

- 1 AREA TO BE SERVED BY A LOCAL OCCUPATIONAL COUNCIL AND THAT HAS A
- 2 PRIMARY FUNCTION DIRECTLY RELATED TO EDUCATION, EMPLOYMENT, OR
- 3 JOB TRAINING SHALL BE USED IN STRUCTURING THE LOCAL OCCUPATIONAL
- 4 COUNCIL. THE CABINET SHALL DETERMINE THE NUMBER OF LOCAL OCCUPA-
- 5 TIONAL COUNCILS NEEDED ACROSS THE STATE AND WHETHER THE COUNCILS
- 6 SHOULD BE CONFIGURED TO SERVE THE AREAS REPRESENTED BY EXISTING
- 7 LOCAL OR INTERMEDIATE SCHOOL DISTRICTS; MAKE RECOMMENDATIONS ON
- 8 THE INDIVIDUALS TO SERVE ON A LOCAL OCCUPATIONAL COUNCIL; AND
- 9 DETERMINE THE NUMBER, METHOD FOR SELECTION OR APPOINTMENT, AND
- 10 LENGTH OF TERM OF MEMBERS OF A LOCAL OCCUPATIONAL COUNCIL.
- 11 (B) THE ESTABLISHMENT AND COORDINATION OF YOUTH APPRENTICE-
- 12 SHIP, INTERNSHIP, AND COOPERATIVE EDUCATIONAL PROGRAMS IN THE
- 13 PRIVATE SECTOR WORK SETTING, WHICH SHALL INCLUDE ALL OF THE
- 14 FOLLOWING:
- 15 (i) MECHANISMS FOR BUSINESS TO WORK COOPERATIVELY WITH
- 16 SCHOOLS AND OTHER EDUCATIONAL INSTITUTIONS TO DEVELOP
- 17 SCHOOL-TO-WORK STRATEGIES, INCLUDING PROVIDING ON-THE-JOB TRAIN-
- 18 ING AND EMPLOYMENT ORIENTATION FOR STUDENTS WISHING TO PURSUE
- 19 AREAS OF STUDY RELATED TO PARTICULAR EMPLOYMENT.
- 20 (ii) MECHANISMS FOR BUSINESS AND HIGHER EDUCATION TO ASSIST
- 21 IN THE EFFORT TO PROVIDE WORK-BASED EDUCATION BY DEVELOPING
- 22 MODELS FOR YOUTH APPRENTICESHIP, INTERNSHIP, AND COOPERATIVE EDU-
- 23 CATIONAL PROGRAMS THAT CAN BE APPLIED TO A VARIETY OF OCCUPA-
- 24 TIONAL AREAS, AND THE APPROPRIATE CURRICULA TO COMPLEMENT THIS
- 25 LEARNING. THE MODELS SHALL EMPHASIZE CAREER AREAS RATHER THAN
- 26 SPECIFIC JOBS SO THAT STUDENTS ARE EXPOSED TO A VARIETY OF
- 27 OCCUPATIONS WITHIN A CAREER AREA. IN ALL INSTANCES, THE FOCUS

- I SHALL BE ON PROVIDING STUDENTS WITH BROAD AND WIDELY APPLICABLE
- 2 KNOWLEDGE AND JOB SKILLS. THE MODELS SHALL INCLUDE, BUT ARE NOT
- 3 LIMITED TO, ALL OF THE FOLLOWING:
- 4 (A) STRUCTURED ON-THE-JOB TRAINING COMBINED WITH CLASSROOM
- 5 INSTRUCTION.
- 6 (B) THE TRANSFER OF SKILLS ON THE JOB THROUGH A MENTOR OR
- 7 SKILLED SUPERVISOR.
- 8 (C) THE OPPORTUNITY FOR THE TRAINEE TO ACQUIRE SKILLS WHILE
- 9 EARNING A WAGE.
- 10 (D) A CONTRACT OR AGREEMENT BETWEEN THE TRAINING SPONSOR AND
- II THE TRAINEE ON THE PROCESS AND OUTCOMES OF TRAINING.
- 12 (E) FORMAL RECOGNITION, SUCH AS ACCREDITATION, AFFORDED PRO-
- 13 GRAMS, AND THE AWARDING OF WORKER CREDENTIALS UPON COMPLETION.
- (9) IN ADDITION TO ITS DUTIES UNDER SUBSECTION (8), THE
- 15 STATEWIDE CABINET FOR PROFESSIONAL AND TECHNICAL STANDARDS ALSO
- 16 SHALL DO ALL OF THE FOLLOWING:
- (A) IDENTIFY THE WAYS IN WHICH EXISTING REVENUE IS BEING
- 18 USED TO TRAIN AND EDUCATE INDIVIDUALS FOR THE WORKPLACE, INCLUD-
- 19 ING STATE, FEDERAL, AND PRIVATE RESOURCES, AND MAKE RECOMMENDA-
- 20 TIONS TO THE GOVERNOR AND THE LEGISLATURE ON A MORE EFFICIENT AND
- 21 EFFECTIVE USE OF THOSE FUNDS, WHETHER ADDITIONAL FUNDING IS
- 22 NEEDED, AND THE PURPOSE OF ADDITIONAL FUNDING.
- 23 (B) IDENTIFY WAYS IN WHICH BUSINESS MAY INVEST IN THE EDUCA-
- 24 TIONAL SYSTEM BY ASSISTING IN ONGOING TEACHER TRAINING, PROVIDING
- 25 EQUIPMENT, AND FURNISHING ONGOING INFORMATION ON THE CHANGES THAT
- 26 OCCUR IN THE WORKPLACE.

- 1 (C) IDENTIFY THE EDUCATIONAL EXPECTATIONS OF COMMUNITY
- 2 COLLEGES AND OTHER INSTITUTIONS OF HIGHER EDUCATION AND MAKE
- 3 RECOMMENDATIONS TO THE GOVERNOR, LEGISLATURE, AND STATE BOARD OF
- 4 EDUCATION PERTAINING TO THE ROLE COMMUNITY COLLEGES AND OTHER
- 5 INSTITUTIONS OF HIGHER EDUCATION SHOULD PLAY IN HELPING TO PRO-
- 6 VIDE STUDENTS WITH A SEAMLESS TRANSITION FROM HIGH SCHOOL TO COL-
- 7 LEGE OR WORK.
- 8 (D) PROVIDE ONGOING OVERSIGHT OVER THE LABOR MARKET INFORMA-
- 9 TION EXCHANGE SYSTEM AND THE STATE AND LOCAL OCCUPATIONAL COUN-
- 10 CILS, INCLUDING COORDINATING, MONITORING, AND MODIFYING THE
- 11 SYSTEM IMPLEMENTED UNDER SUBSECTION (8) AS NECESSARY TO MEET
- 12 CHANGING NEEDS.
- (E) BASED ON INFORMATION RECEIVED FROM THE STATE OCCUPA-
- 14 TIONAL COUNCILS, IDENTIFY THE COMPETENCIES, SKILLS AND SKILL
- 15 LEVELS, AND KNOWLEDGE, INCLUDING EMPLOYABILITY AND PROBLEM SOLV-
- 16 ING SKILLS, THAT WILL BE NEEDED IN THE WORKPLACE AND PROVIDE THIS
- 17 INFORMATION TO THE GOVERNOR, LEGISLATURE, AND STATE BOARD OF
- 18 EDUCATION.
- 19 (F) MAKE RECOMMENDATIONS TO THE GOVERNOR AND LEGISLATURE ON
- 20 WAYS IN WHICH THE STATE MIGHT ASSIST EMPLOYERS IN PROVIDING
- 21 WORKPLACE-BASED TRAINING FOR EXISTING EMPLOYEES, INCLUDING RECOM-
- 22 MENDATIONS ON THE GUIDELINES AND CRITERIA THAT SHOULD BE USED IN
- 23 EVALUATING THESE TRAINING PROGRAMS AND THE MECHANISMS THAT MIGHT
- 24 BE USED TO PROVIDE TO EMPLOYERS FINANCIAL AND OTHER INCENTIVES
- 25 FOR THESE TRAINING PROGRAMS.

- 1 (10) THE STATE BOARD, BASED ON INFORMATION PROVIDED BY THE
- 2 STATEWIDE CABINET FOR PROFESSIONAL AND TECHNICAL STANDARDS, SHALL
- 3 DO ALL OF THE FOLLOWING:
- 4 (A) EVALUATE WHETHER EXISTING CURRICULA AND PROGRAMS, BASED
- 5 ON THE MODEL CORE CURRICULUM REQUIREMENTS OUTLINED UNDER SECTION
- 6 1278, ARE REFLECTIVE OF THE NEEDED COMPETENCIES, SKILL LEVELS,
- 7 AND KNOWLEDGE, INCLUDING EMPLOYABILITY AND PROBLEM SOLVING
- 8 SKILLS.
- 9 (B) EVALUATE WHETHER EXISTING ASSESSMENT MECHANISMS USED IN
- 10 THE EDUCATIONAL SYSTEM, INCLUDING, BUT NOT LIMITED TO, THE STATE-
- 11 WIDE PROFICIENCY TEST AND THE MICHIGAN EDUCATIONAL ASSESSMENT
- 12 PROGRAM, ARE REFLECTIVE OF THE BASIC COMPETENCIES, SKILLS AND
- 13 SKILL LEVELS, AND KNOWLEDGE THAT WILL BE NEEDED IN THE
- 14 WORKPLACE.
- 15 (C) DEVELOP MECHANISMS THAT MAY BE USED IN ASSESSING WHETHER
- 16 PUPILS HAVE ATTAINED THE EXPECTED COMPETENCIES, SKILLS AND SKILL
- 17 LEVELS, AND KNOWLEDGE, INCLUDING EMPLOYABILITY AND PROBLEM SOLV-
- 18 ING SKILLS.
- 19 (D) ASSIST LOCAL AND INTERMEDIATE SCHOOL BOARDS TO ALTER,
- 20 EXPAND, AND IMPROVE EXISTING EDUCATIONAL PROGRAMS TO MEET FUTURE
- 21 EMPLOYMENT NEEDS.
- 22 (E) ESTABLISH WAYS FOR COMMUNITY COLLEGES, PROPRIETARY
- 23 SCHOOLS, AND COLLEGES AND UNIVERSITIES TO PROVIDE ADVANCED PLACE-
- 24 MENT FOR STUDENTS SUCCESSFULLY COMPLETING AN APPLIED ACADEMIC
- 25 AREA OF STUDY, BY TAKING INTO ACCOUNT THE CREDITS EARNED AND
- 26 SKILLS MASTERED FROM THAT STUDY.

- 1 (F) ESTABLISH WAYS FOR COMMUNITY COLLEGES, COLLEGES, AND
- 2 UNIVERSITIES TO COLLABORATE WITH LOCAL AND INTERMEDIATE SCHOOL
