



# HOUSE BILL No. 4266

February 1, 1995, Introduced by Reps. Llewellyn, Rhead, McBryde, Cropsey, Horton, Gernaat, Bodem, Wetters, London and Alley and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend section 4 of Act No. 380 of the Public Acts of 1965, entitled

"Executive organization act of 1965,"

being section 16.104 of the Michigan Compiled Laws; and to add sections 177a, 250a, 259, 259a, 259b, and 259c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 4 of Act No. 380 of the Public Acts of  
2 1965, being section 16.104 of the Michigan Compiled Laws, is  
3 amended and sections 177a, 250a, 259, 259a, 259b, and 259c are  
4 added to read as follows:

5 Sec. 4. Except as otherwise provided by this act, or the  
6 state constitution, all executive and administrative powers,  
7 duties, and functions, excepting those of the legislature and the  
8 judiciary, previously vested by law in the several state  
9 departments, commissions, boards, officers, bureaus, divisions,

3       SEC. 177A. IN ADDITION TO THOSE POWERS AND DUTIES OTHERWISE  
4 PROVIDED BY LAW, THE DEPARTMENT OF AGRICULTURE SHALL ADMINISTER  
5 PROGRAMS AS PROVIDED BY LAW RELATED TO THE FOLLOWING:

6       (A) FOREST MANAGEMENT.

7       (B) GEOLOGICAL SURVEY.

8       (C) LAND AND WATER MANAGEMENT.

9       (D) REAL ESTATE.

10      (E) STATE EXPOSITION AND FAIRGROUNDS.

11      SEC. 250A. THE DEPARTMENT OF NATURAL RESOURCES SHALL ADMIN-  
12 ISTER PROGRAMS AS PROVIDED BY LAW RELATED TO THE FOLLOWING:

13      (A) AIR QUALITY.

14      (B) WATER QUALITY.

15      (C) WASTE MANAGEMENT.

16      (D) ENVIRONMENTAL RESPONSE AND RADIATION.

17      (E) ENVIRONMENTAL LABORATORIES.

18      (F) RECREATION.

19      (G) STATE PARKS.

20      (H) MACKINAC ISLAND STATE PARK.

21      SEC. 259. THERE IS CREATED A DEPARTMENT OF FISH AND  
22 WILDLIFE.

23      SEC. 259A. THE HEAD OF THE DEPARTMENT OF FISH AND WILDLIFE  
24 IS THE FISH AND GAME COMMISSION.

25      SEC. 259B. THE FISH AND GAME COMMISSION SHALL CONSIST OF 5  
26 MEMBERS APPOINTED BY THE GOVERNOR FROM DISTRICTS APPORTIONED  
27 ACCORDING TO POPULATION AND GEOGRAPHIC REGIONS OF THE STATE. A

1 CANDIDATE FOR APPOINTMENT TO THE FISH AND GAME COMMISSION MUST BE  
2 ENDORSED BY AN ORGANIZATION THAT HAS AS ITS PURPOSE THE PROMOTION  
3 OF HUNTING OR FISHING WITHIN THE STATE.

4 SEC. 259C. THE DEPARTMENT OF FISH AND WILDLIFE SHALL ADMIN-  
5 ISTER PROGRAMS AS PROVIDED BY LAW RELATED TO THE MANAGEMENT AND  
6 PROTECTION OF FISH AND WILDLIFE WITHIN THE STATE.
