March 9, 1995, Introduced by Reps. Curtis, Harder, Murphy, Cherry, Yokich, Baird and Saunders and referred to the Committee on Judiciary and Civil Rights.

A bill to amend Act No. 236 of the Public Acts of 1961, entitled as amended

"Revised judicature act of 1961,"

as amended, being sections 600.101 to 600.9947 of the Michigan Compiled Laws, by adding section 2962.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 236 of the Public Acts of 1961, as

- 3 Compiled Laws, is amended by adding section 2962 to read as
- 4 follows:
- 5 SEC. 2962. (1) IN ADDITION TO ANY OTHER REMEDIES PROVIDED
- 6 BY LAW, AN INSURER WHO FAILS TO NEGOTIATE AND SETTLE AN INSURANCE
- 7 CLAIM IN GOOD FAITH IS LIABLE TO THE CLAIMANT FOR DAMAGES
- 8 INCURRED AS A RESULT OF THAT FAILURE. IN AN ACTION UNDER THIS

- 1 SECTION, THE CLAIMANT MAY ALSO RECOVER EXEMPLARY DAMAGES, COSTS
