

## **HOUSE BILL No. 4645**

March 21, 1995, Introduced by Reps. Munsell, Anthony, McNutt, Pitoniak, DeMars, Hammerstrom and McBryde and referred to the Committee on Appropriations.

A bill to amend Act No. 182 of the Public Acts of 1986, entitled

"State police retirement act of 1986," as amended, being sections 38.1601 to 38.1648 of the Michigan Compiled Laws, by adding section 33a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 182 of the Public Acts of 1986, as
- 2 amended, being sections 38.1601 to 38.1648 of the Michigan
- 3 Compiled Laws, is amended by adding section 33a to read as
- 4 follows:
- 5 SEC. 33A. (1) A DEFERRED MEMBER WHO BECOMES EMPLOYED BY A
- 6 LOCAL UNIT OF GOVERNMENT AS A LAW ENFORCEMENT OFFICER AFTER THE
- 7 DEFERRED MEMBER LEAVES MEMBERSHIP UNDER THIS ACT MAY HAVE HIS OR
- 8 HER CREDITED SERVICE WITH THAT LOCAL UNIT OF GOVERNMENT AS A LAW
- 9 ENFORCEMENT OFFICER TRANSFERRED TO THIS RETIREMENT SYSTEM AS

- I PROVIDED IN THIS SECTION. UPON APPLICATION OF THE DEFERRED
- 2 MEMBER AND UPON AGREEMENT BY THE LOCAL UNIT OF GOVERNMENT THAT
- 3 EMPLOYED THE DEFERRED MEMBER, THE RETIREMENT SYSTEM SHALL ALLOW
- 4 THE TRANSFER OF CREDITED SERVICE ALONG WITH A TRANSFER OF FINAN-
- 5 CIAL CONSIDERATION FROM THE LOCAL UNIT OF GOVERNMENT TO THE
- 6 RETIREMENT SYSTEM, IN THE MANNER PRESCRIBED IN SECTION 6 OF THE
- 7 RECIPROCAL RETIREMENT ACT, ACT NO. 88 OF THE PUBLIC ACTS OF 1961,
- 8 BEING SECTION 38.1106 OF THE MICHIGAN COMPILED LAWS.
- 9 (2) THE RETIREMENT SYSTEM SHALL NOT TRANSFER LAW ENFORCEMENT
- 10 SERVICE CREDIT UNDER THIS SECTION IF THE DEFERRED MEMBER IS OR
- 11 WILL BE RECEIVING A PENSION OR ANNUITY FOR THE SAME SERVICE FROM
- 12 ANOTHER RETIREMENT SYSTEM.
- (3) NOTWITHSTANDING SECTION 24, A DEFERRED MEMBER WHOSE
- 14 TRANSFER OF SERVICE CREDIT UNDER THIS SECTION INCREASES THAT
- 15 DEFERRED MEMBER'S SERVICE CREDIT UNDER THIS ACT TO 25 YEARS OR
- 16 MORE SHALL ONLY RECEIVE A RETIREMENT ALLOWANCE CALCULATED UNDER
- 17 SECTION 30. THIS SUBSECTION DOES NOT APPLY IF THE DEFERRED
- 18 MEMBER OTHERWISE RECEIVES ACTIVE SERVICE CREDIT UNDER THIS ACT
- 19 EQUAL TO OR GREATER THAN 25 YEARS, NOT INCLUDING THE SERVICE
- 20 CREDIT TRANSFERRED UNDER THIS SECTION.
