March 30, 1995, Introduced by Reps. Hanley, Yokich, Baird, Martinez, Berman, DeMars, Kelly, LaForge and Pitoniak and referred to the Committee on Human Services.

A bill to amend Act No. 280 of the Public Acts of 1939, entitled as amended
"The social welfare act,"
as amended, being sections 400.1 to 400.119b of the Michigan Compiled Laws, by adding section 17a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as
- 2 amended, being sections 400.1 to 400.119b of the Michigan
- 3 Compiled Laws, is amended by adding section 17a to read as
- 4 follows:
- 5 SEC. 17A. (1) AS USED IN THIS SECTION, "MEDICAID" MEANS THE
- 6 HMO REIMBURSEMENT RATE USED IN THE PROGRAM FOR MEDICAL ASSISTANCE
- 7 ESTABLISHED PURSUANT TO SECTION 105.
- 8 (2) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (3), NOT
- 9 LATER THAN MAY 1, THE DEPARTMENT SHALL SUBMIT AN ANNUAL REPORT TO

- 16 TIMES A HOUSEHOLD RECEIVED AID TO FAMILIES WITH DEPENDENT CHIL-
- 17 DREN OVER THE MOST RECENT 10-YEAR PERIOD, BROKEN DOWN BY AGE OF
- 18 HEAD OF HOUSEHOLD.
- 19 (1) THE AVERAGE MONTHLY AMOUNT OF CHILD SUPPORT RECEIVED,
- 20 AND THE AVERAGE MONTHLY AMOUNT OF CHILD SUPPORT ARREARAGE.
- 21 (M) WITH RESPECT TO ADULTS AND MINOR HEADS OF HOUSEHOLDS,
- 22 THE FOLLOWING INFORMATION:

- 4 AVERAGE COST OF THE BENEFITS AS DESCRIBED IN SUBDIVISION (A).
- 5 (ii) FOR THOSE HOUSEHOLDS WITH EARNED INCOME, THE COMBINED

- 24 (T) A CHART REPRESENTING CHANGES IN AN AVERAGE CASH GRANT
- 25 OVER THE PRECEDING 10-YEAR PERIOD COMPARED TO CHANGES IN THE CON-
- 26 SUMER PRICE INDEX.

- 1 (U) THE PERCENTAGE AND NUMBER OF MICHIGAN RESIDENTS
- 2 RECEIVING AID TO FAMILIES WITH DEPENDENT CHILDREN DURING THE
- 3 PRECEDING YEAR, THE PERCENTAGE AND NUMBER OF MICHIGAN RESIDENTS
- 4 RECEIVING PUBLIC ASSISTANCE DURING THE PRECEDING YEAR, AND A
- 5 GRAPH COMPARING THOSE PERCENTAGES WITH COMPARABLE PERCENTAGES

- 7 (V) THE NUMBER OF HOUSEHOLDS RECEIVING AID TO FAMILIES WITH

- 9 (i) THE TOTAL NUMBER OF HOUSEHOLDS IN THIS STATE.
- 10 (ii) THE TOTAL NUMBER OF HOUSEHOLDS IN THIS STATE IN WHICH A
- 11 SUBSTANTIATED CHARGE OF CHILD ABUSE OR NEGLECT HAS BEEN MADE
- 12 AGAINST A MEMBER OF THE HOUSEHOLD.
- 13 (W) MAJOR INITIATIVES THE DEPARTMENT HAS UNDERTAKEN DURING
- 14 THE YEAR TO PROMOTE SELF-RELIANCE AND REDUCE WELFARE DEPENDENCY
- 15 AND AN EVALUATION OF RESPONSES TO THOSE INITIATIVES.
- 16 (X) THE NUMBER OF CHILDREN IN THIS STATE WHO ARE RECEIVING
- 17 AID TO FAMILIES WITH DEPENDENT CHILDREN, AND THAT NUMBER AS A
- 18 PERCENTAGE OF THE TOTAL POPULATION OF CHILDREN IN THIS STATE,
- 19 BROKEN DOWN AS FOLLOWS:
- 20 (i) CHILDREN FROM BIRTH THROUGH AGE 17.
- 21 (ii) CHILDREN OF AGE 5 AND UNDER.
- 22 (iii) CHILDREN OF AGES 6 THROUGH 17.
- 23 (3) THE DEPARTMENT IS NOT REQUIRED TO INCLUDE IN THE ANNUAL
- 24 REPORT REQUIRED UNDER SUBSECTION (2) INFORMATION DESCRIBED IN
- 25 SUBSECTION (2)(H), (I), (J), (M), (N), OR (O) UNTIL THE DEPART-
- 26 MENT HAS ESTABLISHED AN AUTOMATED SOCIAL SERVICES INFORMATION
- 27 SYSTEM.

- (4) WITHIN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS SECTION,
- 2 THE DEPARTMENT SHALL DETERMINE AND REPORT TO THE LEGISLATURE THE
- 3 AVAILABILITY OF AND COSTS TO OBTAIN INFORMATION REGARDING BENE-
- 4 FITS PROVIDED TO RECIPIENTS OF AID TO FAMILIES WITH DEPENDENT
- 5 CHILDREN UNDER ALL OF THE FOLLOWING PROGRAMS:
- 6 (A) PUBLIC HOUSING OR SECTION 8 HOUSING.
- 7 (B) THE WOMEN, INFANTS, AND CHILDREN PROGRAM.
- 6 (C) SCHOOL BREAKFAST OR LUNCH PROGRAMS.
- 9 (D) THE HEAD START PROJECT.
- 10 (E) THE JOB TRAINING PARTNERSHIP PROGRAM.
- (F) ANY OTHER MEANS-TESTED BENEFIT OR ASSISTANCE PROGRAM
- 12 ADMINISTERED BY ANOTHER STATE DEPARTMENT OR FOR WHICH FUNDS ARE
- 13 APPROPRIATED IN THIS STATE PURSUANT TO THE APPROPRIATION PROCESS.
