

HOUSE BILL No. 4790

A bill to amend Act No. 451 of the Public Acts of 1994, entitled

"Natural resources and environmental protection act," as amended, being sections 324.101 to 324.90101 of the Michigan Compiled Laws, by adding section 5502a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 451 of the Public Acts of 1994, as
- 2 amended, being sections 324.101 to 324.90101 of the Michigan
- 3 Compiled Laws, is amended by adding section 5502a to read as
- 4 follows:
- 5 SEC. 5502A. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
- 6 PART OR THE RULES PROMULGATED UNDER THIS PART, THE DEPARTMENT
- 7 SHALL NOT ISSUE A PERMIT UNDER THIS PART TO INSTALL FOR A NEW OR
- 8 MODIFIED PROCESS THAT EMITS AIR CONTAMINANTS FOR A SOURCE THAT IS
- 9 LOCATED WITHIN 1,000 FEET OF A CHILD CARE CENTER AS DEFINED IN

- 1 SECTION 1 OF ACT NO. 116 OF THE PUBLIC ACTS OF 1973, BEING
- 2 SECTION 722.111 OF THE MICHIGAN COMPILED LAWS, A PRESCHOOL, OR A
- 3 PUBLIC OR NONPUBLIC SCHOOL.
- 4 (2) AS USED IN THIS SECTION, "SOURCE" INCLUDES, BUT IS NOT
- 5 LIMITED TO, MEDICAL WASTE INCINERATORS, MUNICIPAL SOLID WASTE
- 6 INCINERATORS, PULP AND PAPER MILLS, FACILITIES FOR INDUSTRIAL AND
- 7 MUNICIPAL BURNING OF WOOD, INCINERATORS AND CEMENT KILNS BURNING
- 8 HAZARDOUS WASTE, SECONDARY COPPER SMELTERS, FACILITIES FOR CHEMI-
- 9 CAL MANUFACTURING, FACILITIES FOR FERROUS METAL SMELTING AND
- 10 REFINING, SEWAGE SLUDGE INCINERATORS, AND FACILITIES FOR SECOND-
- 11 ARY LEAD SMELTING AND REFINING.
