



HOUSE BILL No. 5650

February 29, 1996, Introduced by Reps. Pitoniak, Profit, Freeman, DeHart, LaForge, Martinez, Hammerstrom, Kelly, Brewer, DeLange, Baird, Bobier, Byl, Hill, Bodem and Brater and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend Act No. 451 of the Public Acts of 1994, entitled "Natural resources and environmental protection act," as amended, being sections 324.101 to 324.90106 of the Michigan Compiled Laws, by adding section 62506a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 451 of the Public Acts of 1994, as
2 amended, being sections 324.101 to 324.90106 of the Michigan
3 Compiled Laws, is amended by adding section 62506a to read as
4 follows:

5 SEC. 62506A. (1) AS USED IN THIS SECTION:

6 (A) "HAZARDOUS WASTE", "STORAGE FACILITY", AND "TREATMENT
7 FACILITY" HAVE THE MEANINGS ASCRIBED TO THESE TERMS IN PART 111.

8 (B) "MULTISOURCE COMMERCIAL HAZARDOUS WASTE DISPOSAL WELL"
9 MEANS A DISPOSAL WELL THAT RECEIVES HAZARDOUS WASTE THAT IS

1 GENERATED BY MORE THAN 1 PERSON. MULTISOURCE COMMERCIAL
2 HAZARDOUS WASTE DISPOSAL WELL DOES NOT INCLUDE A DISPOSAL WELL
3 THAT RECEIVES HAZARDOUS WASTE FROM A SUBSIDIARY OF THE PERSON
4 THAT OWNS OR OPERATES THE MULTISOURCE COMMERCIAL HAZARDOUS WASTE
5 DISPOSAL WELL.

6 (C) "PERSON" INCLUDES A GOVERNMENTAL ENTITY.

7 (2) PRIOR TO THE DRILLING OF A MULTISOURCE COMMERCIAL HAZ-
8 ARDOUS WASTE DISPOSAL WELL OR THE CONVERSION OF A WELL TO A
9 MULTISOURCE COMMERCIAL HAZARDOUS WASTE DISPOSAL WELL, A PERSON
10 SHALL HAVE OBTAINED A CONSTRUCTION PERMIT FOR AN ON-SITE TREAT-
11 MENT FACILITY AND STORAGE FACILITY UNDER SECTION 11118.

12 (3) NOTHING IN THE AMENDATORY ACT THAT ADDED THIS SECTION
13 SHALL BE CONSTRUED TO ABROGATE COMMON LAW.

14 Section 2. This amendatory act shall not take effect unless
15 Senate Bill No. _____ or House Bill No. _____ (request
16 no. 03684'95 a **) of the 88th Legislature is enacted into law.
