

HOUSE BILL No. 5749

April 17, 1996, Introduced by Reps. Jellema, Law and Perricone and referred to the Committee on Commerce.

A bill to amend section 4701 of Act No. 236 of the Public Acts of 1961, entitled as amended

"Revised judicature act of 1961,"

- (b) "Instrumentality of a crime" means any property, other
- 20 than real property, the use of which contributes directly and
- 21 materially to the commission of a crime.
- (c) "Person" means an individual, corporation, partnership,
- 23 or other business entity, or an unincorporated or voluntary
- 24 association.
- (d) "Proceeds of a crime" means any property obtained
- 26 through the commission of a crime, including any appreciation in
- 27 the value of the property.

ì	(e) "Security interest" means any interest in real or
2	personal property that secures payment or performance of an
3	obligation.
4	(f) "Substituted proceeds of a crime" means any property
5	obtained or any gain realized by the sale or exchange of proceed
6	of a crime.
7	Section 2. This amendatory act shall take effect April 1,
8	1997.
9	Section 3. This amendatory act shall not take effect unles
