Section 1. Act No. 228 of the Public Acts of 1975, as
 amended, being sections 208.1 to 208.145 of the Michigan Compiled
 Laws, is amended by adding sections 79 and 84 to read as
 follows:

SEC. 79. (1) FOR TAX YEARS BEGINNING AFTER DECEMBER 31,
6 1996, A TAXPAYER WHO IS DUE A REFUND DETERMINED UNDER SECTION 30
7 OF ACT NO. 122 OF THE PUBLIC ACTS OF 1941, BEING SECTION 205.30
8 OF THE MICHIGAN COMPILED LAWS, MAY REQUEST A DIRECT DEPOSIT OF
9 THAT REFUND TO A FINANCIAL INSTITUTION OF THE TAXPAYER'S CHOICE

THAT IS LOCATED IN THE UNITED STATES BY COMPLETING A DIRECT
 DEPOSIT FORM PRESCRIBED BY THE DEPARTMENT AND ATTACHING THE COM PLETED FORM TO THE TAXPAYER'S ANNUAL RETURN.

4 (2) THE DEPARTMENT SHALL COMPLY WITH A REQUEST UNDER THIS 5 SECTION UNLESS THE REQUEST IS INCOMPLETE OR DEFECTIVE IN A MANNER 6 THAT PRECLUDES THE DEPARTMENT FROM HONORING THE REQUEST. 14 THE FORM REQUIRED BY SECTION 79 TO PROVIDE FOR THE DIRECT DEPOSIT
15 OF A REFUND DUE TO A TAXPAYER.
