



# HOUSE BILL No. 6091

September 18, 1996, Introduced by Rep. London and referred to the Committee on Transportation.

A bill to amend Act No. 300 of the Public Acts of 1974, entitled  
"Motor vehicle service and repair act,"  
as amended, being sections 257.1301 to 257.1340 of the Michigan  
Compiled Laws, by adding section 18a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 300 of the Public Acts of 1974, as  
2 amended, being sections 257.1301 to 257.1340 of the Michigan  
3 Compiled Laws, is amended by adding section 18a to read as  
4 follows:

5 SEC. 18A. (1) A FACILITY THAT REPAIRS OR REPLACES AIR BAGS  
6 IN A MOTOR VEHICLE SHALL MAINTAIN A RECORD OF THE PURCHASE OR  
7 SALE OF EACH USED OR RECONDITIONED AIR BAG PURCHASED OR ACQUIRED  
8 BY THE FACILITY. THE RECORD SHALL CONTAIN THE DATE OF PURCHASE  
9 OR ACQUISITION OF EACH AIR BAG, A DESCRIPTION OF EACH AIR BAG,

1 THE IDENTIFICATION NUMBER ASSIGNED TO EACH AIR BAG, AND THE NAME  
2 AND ADDRESS OF THE PERSON TO OR FROM WHOM EACH AIR BAG WAS PUR-  
3 CHASED, ACQUIRED, OR SOLD. THE RECORD OF THE SALE, PURCHASE, OR  
4 ACQUISITION OF EACH AIR BAG SHALL BE MAINTAINED IN OR ATTACHED TO  
5 A POLICE BOOK AS DESCRIBED IN SECTION 251 OF THE MICHIGAN VEHICLE  
6 CODE, ACT NO. 300 OF THE PUBLIC ACTS OF 1949, BEING SECTION  
7 257.251 OF THE MICHIGAN COMPILED LAWS. THE FACILITY'S POLICE  
8 BOOK AND THE RECORDS OF AIR BAG SALES, PURCHASES, OR ACQUISITIONS  
9 SHALL IMMEDIATELY BE MADE AVAILABLE FOR INSPECTION BY THE ADMIN-  
10 ISTRATOR AND OTHER LAW ENFORCEMENT OFFICIALS AFTER A REQUEST FOR  
11 INSPECTION IS MADE.

12 (2) RECORDS REQUIRED UNDER THIS SECTION SHALL BE MAINTAINED  
13 BY THE FACILITY FOR NOT LESS THAN 5 YEARS.
