

## **SENATE BILL No. 139**

January 17, 1995, Introduced by Senator CHERRY and referred to the Committee on Government Operations.

A bill to create the office of the environmental ombudsman; and to prescribe the powers and duties of the office and certain state agencies and officials.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "environmental ombudsman act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Council" means the legislative council established
- 5 under section 15 of article IV of the state constitution of
- 6 1963.
- 7 (b) "Ombudsman" means the environmental ombudsman created in
- 8 section 3.
- 9 Sec. 3. (1) The office of the environmental ombudsman is
- 10 created within the council.

1 (2) The principal executive officer of the office of the

2 environmental ombudsman is the environmental ombudsman.

- 3 (3) The ombudsman shall be appointed by the council for 1
- 5 the entire 6-year period, a successor shall be selected for a
- 6 nonrenewable 6-year term. The ombudsman may be removed by the
- 7 council before the expiration of his or her term for cause.
- 8 Sec. 4. The ombudsman shall perform all of the following
- 9 duties and responsibilities:

- 10 (a) Act within state government on behalf of individuals and
- 11 businesses who have concerns regarding the state's system of
- 12 environmental protection and resource management, and assist them
- 13 in directing and communicating their concerns to the appropriate
- 14 state agency.
- (b) Assist the public in gaining access to the environmental
- 16 decision-making process before any final decision is rendered by
- 17 a state agency.
- 18 (c) Assist the public in obtaining efficient, thorough, and
- 19 timely responses regarding natural resources and environmental
- 20 protection questions.
- 21 (d) Recommend to appropriate state agencies and the legisla-
- 22 ture methods by which public participation in natural resources
- 23 and environmental decision-making could be improved.
- 24 (e) Compile, maintain, and make available upon request a
- 25 complete list of all citizen advisory committees within state
- 26 agencies that are involved with natural resources and
- 27 environmental issues.

- 1 (f) Serve as a liaison between the public and the state 2 agencies involved with natural resources and environmental
- 3 issues.
- 4 (g) Investigate complaints regarding violations of environ-
- 5 mental laws and rules promulgated under those laws, or regarding
- 6 state agencies not enforcing environmental laws.
- 7 (h) Assist individuals, businesses, and local units of gov-
- 8 ernment in obtaining information regarding permit applications
- 9 and the permit process, but refrain from intervening on behalf of
- 10 any party after the process has commenced.
- 11 Sec. 5. All agencies of state government shall cooperate
- 12 fully with the ombudsman, and shall assist the ombudsman in the
- 13 performance of his or her duties and responsibilities under this
- 14 act.
- 15 Sec. 6. The council shall establish procedures for approv-
- 16 ing the budget of the office, for expending funds, and for the
- 17 employment of any personnel of the ombudsman.
- 18 Sec. 7. The responsibilities granted to the ombudsman under
- 19 this act shall not limit or affect any existing rights of public
- 20 participation or appeals related to any programs in any state
- 21 agency, and are intended to be in addition to any such existing
- 22 processes.
- 23 Sec. 8. This act shall take effect October 1, 1995.
