



# SENATE BILL No. 299

## EXECUTIVE BUDGET

February 16, 1995, Introduced by Senators MC MANUS and GAST and referred to the Committee on Appropriations.

A bill to make appropriations for the department of natural resources for the fiscal year ending September 30, 1996; to provide for the expenditure of those appropriations; to create funds and accounts; to require reports; to prescribe certain powers and duties of certain state departments and officers, institutions, and agencies; to authorize certain transfers by certain state agencies; and to provide for the disposition of fees and other income received by the various state agencies.

19 **GENERAL SECTIONS**

20 Sec. 201. The expenditures and funding sources authorized under  
 21 this bill are subject to the management and budget act, Act No. 431 of  
 22 the Public Acts of 1984, being sections 18.1101 to 18.1594 of the  
 23 Michigan Compiled Laws.

24 Sec. 202. (1) The amounts appropriated from one fund to another  
 25 fund shall be authorized pursuant to annual appropriations within the  
 26 departments responsible for each fund's appropriations.

27 (2) Funds for which the state is acting as the custodian or agent  
 28 are not subject to annual appropriation.

29 Sec. 203. (1) The number of Permanent career FTE employees shall

1 not exceed the number listed in section 101 of this bill unless an  
2 exception has been granted by the director of the department of  
3 management and budget. Exceptions shall only be given if failure to  
4 fill the positions will result in rendering the department unable to  
5 deliver basic services, cause a loss of revenue to the state, or  
6 necessitate additional expenditures that exceed savings from  
7 maintaining a vacancy. On the fifteenth of each month, the department  
8 of management and budget shall report to the house and senate  
9 appropriations committees and the governor any exceptions that have  
10 been granted in the preceding month.

11 (2) Permanent career appointments shall be used as defined by the  
12 civil service commission.

13 (3) The number of FTEs to be funded by each individual line item  
14 amount shall be determined by the department within the overall limit  
15 on permanent career FTEs for the department.

16 Sec. 204. (1) Any federal, local, private, or state restricted  
17 funds received by a department in addition to the amount appropriated  
18 in section 101, are appropriated.

19 (2) Funds appropriated in subsection (1) totalling less than  
20 \$50,000.00 during the fiscal year from any one source may be expended  
21 for the purposes for which the funds were made available. Receipt of  
22 these funds shall be reported to the senate and house appropriations  
23 committees and the house and senate fiscal agencies within thirty days  
24 after the close of each fiscal quarter.

25 (3) Funds appropriated in subsection (1) totalling \$50,000.00 or  
26 more during the fiscal year are not available for expenditure until  
27 they have been transferred to another line item in this act through an  
28 administrative transfer as defined in section 393(1) of Act No. 431 of  
29 the Public Acts of 1984, as amended, being section 18.1393(1) of the  
30 Michigan Compiled Laws.

1       Sec. 205. The department of civil service shall bill departments  
2 and/or agencies at the end of the first fiscal quarter for the 1%  
3 charges authorized by section 5 of Article XI of the State Constitution  
4 of 1963. Payments shall be made for the total amount of the billing by  
5 the end of the second fiscal quarter.

6       Sec. 206. As used in this act:

7       (a) "CESARS" means chemical evaluation search and retrieval system.

8       (b) "Commission" means the commission of natural resources.

9       (c) "DAG-Federal" means the United States department of  
10 agriculture-forest service.

11       (d) "Department" means the department of natural resources.

12       (e) "DOC-Federal" means the United States department of  
13 commerce-national oceanic and atmospheric administration.

14       (f) "DOD-Federal" means the United States department of  
15 defense-army and the United States department of defense-navy.

16       (g) "DOE-federal" means the United States department of energy.

17       (h) "DOI-federal" means the United States department of interior.

18       (i) "DOT-federal" means the United States department of  
19 transportation.

20       (j) "EPA-federal" means the United States environmental protection  
21 agency.

22       (k) "FEMA-federal" means the federal emergency management agency.

23       (l) "PCB" means polychlorinated biphenyl.

24       (m) "SBA-federal" means the United States small business  
25 administration.

26       Sec. 207. (1) From funds appropriated under section 101, the  
27 department shall prepare a report that lists all of the following  
28 regarding grant or loan or grant and loan programs administered by the  
29 department for the fiscal year ending on September 30, 1996:

30       (a) The name of each program.

1 (b) The criteria, eligibility, process, and deadlines for each  
2 program.

3 (c) The maximum and minimum grant and loan available and whether  
4 there is a match requirement for each program.

5 (d) The amount of any required match, and whether in-kind  
6 contributions may be used as part or all of a required match.

7 (e) Information pertaining to the application process, timeline for  
8 each program, and the contact people within the department.

9 (f) The source of funds for each program, including the citation of  
10 pertinent authorizing acts.

11 (g) Information regarding plans for the next fiscal year for the  
12 phaseout, expansion, or changes for each program.

13 (h) A listing of all recipients of grants or loans awarded by the  
14 department by type and amount of grant or loan.

15 (2) The reports required under this section shall be submitted to  
16 the senate and house of representatives appropriations subcommittees on  
17 natural resources by January 1, 1996.

18 Sec. 208. The department shall not transfer ownership, control, or  
19 administrative responsibilities of any harbor funded with money  
20 appropriated in section 101 to any other entity until 30 days after  
21 notification of the house and senate appropriations subcommittees and  
22 house and senate standing committees charged with the department's  
23 operations.

24 Sec. 209. The department shall establish and use a cost accounting  
25 process that allocates intradepartmental charges among divisions. This  
26 process shall be acceptable to both the department of management and  
27 budget and the legislative auditor general. The department shall  
28 provide an annual report to the senate and house appropriations  
29 subcommittees on natural resources, and the senate and house fiscal  
30 agencies, on the amount and type of charges for intra-departmental

1 services.

2       Sec. 210. From the funds appropriated in section 101 such payments  
3 of wages and salaries as are made for classified state employees shall  
4 be made in accordance with applicable laws, rules, and regulations of  
5 the civil service commission. The funds identified in section 101 for  
6 unclassified employees are based upon prior year levels adjusted  
7 consistent with pay plan recommendations for non-exclusively  
8 represented employees (NEREs) of the civil service commission, except  
9 in the case of department directors and heads of type I agencies, where  
10 the funds provided are in an amount equal the standards established by  
11 the civil service commission as the maximum pay for state executive  
12 service classification 20 and state executive service classification 18  
13 employees, respectively. Although the funds identified in section 101  
14 for unclassified employees are based upon the standards set forth  
15 above, the exact salaries of individual unclassified employees shall be  
16 set by the appointing authority, not to exceed the state executive  
17 service classification 20 maximum payment in the case of a department  
18 director, or the state executive service classification 18 maximum  
19 payment in the case of a head of a type I agency. The salaries of  
20 individual unclassified employees shall be a matter of public record.

21 **EXECUTIVE**

22       Sec. 301. The appropriations in section 101 may be used for per  
23 diem payments to the members of commissions or committees for a full  
24 day of commission or committee work at which a quorum is present, for  
25 attending a hearing as authorized by the respective commission or  
26 committee, or for performing official business as authorized by each  
27 respective commission or committee. The per diem payments for members  
28 of the commission of natural resources shall be at a rate of \$75.00 per  
29 day.

30       Sec. 302. Of the total funds appropriated in section 101 for the

office of the Great Lakes, the department shall assign 1.0 FTE position and \$100,000.00 from the Great Lakes protection fund to implement Act Nos. 326 and 327 of the Public Acts of 1990. The director of the office of the Great Lakes will report to the house and senate appropriations subcommittees on natural resources by September 30, 1996, regarding the progress in implementation of these acts.

#### **ADMINISTRATIVE SERVICES**

Sec. 401. The following are the estimated revenues available in the game and fish protection fund-general purpose for the state fiscal year beginning October 1, 1995:

Sec. 402. Of the state general fund/general purpose resources appropriated in section 101 to administrative services and field administration, \$2,240,000.00 is to provide reimbursement to the game and fish protection fund for senior citizen discount.

Sec. 403. The department shall provide the senate and house appropriations subcommittees on natural resources and the senate and house fiscal agencies with a March 31, 1996 and year-end report on the Michigan underground storage tank financial assurance fund. The March 31, 1996 report shall include the fund balance, estimate of available revenues, number and dollar value of claims processed through September 30, 1995, and total estimated claims liability through December 22, 1998. The year-end report shall be provided within 30 days of the end of the fiscal year and include fund balance, estimate of available revenues, number and dollar value of claims processed for the fiscal year 1995-96 and total estimated claims liability through December 22,

1 1998.

2 **DEPARTMENTAL OPERATIONAL SUPPORT**

3 Sec. 501. The department shall report on February 1, 1996, to the  
4 senate and house of representatives appropriations committees and to  
5 the senate and house fiscal agencies. The report shall include both of  
6 the following:

7 (a) The amount of contributions, gifts, bequests, grants, and  
8 donations received by the department for the fiscal year ending  
9 September 30, 1995.

10 (b) A listing of the expenditures made from the amounts received as  
11 reported in subdivision (a).

12 **STATE PARKS**

13 Sec. 601. The department may charge the appropriations contained in  
14 section 101, including all special maintenance and capital projects  
15 appropriated for the fiscal year ending September 30, 1996, for  
16 engineering services provided, a standard percentage fee to be  
17 determined by the director of the department of management and budget,  
18 and may use the revenue derived to support the engineering services  
19 charges provided for in section 101.

20 Sec. 602. (1) The amount appropriated in section 101 for state  
21 parks derived from state park endowment fund revenues shall be used for  
22 the following purposes:

23 (a) Construction, equipment, and development of facilities for  
24 state parks.

25 (b) Infrastructure repair and improvements for existing state park  
26 properties.

27 (c) Preservation of the natural and historic resources in state  
28 parks.

29 (d) Operations, administration, and maintenance of state parks.

30 (2) Amounts appropriated for state park endowment in section 101 is



1 \$4,104,000. This amount is estimated interest earnings from the fund.  
2 If actual interest earnings are higher or lower than the amount in  
3 section 101, these amounts are appropriated.

4 (3) All capital expenditures shall be made in conformance with the  
5 management and budget act, Act No. 431 of the Public Acts of 1984,  
6 being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

7 Sec. 603. The amount appropriated in section 101 from the Michigan  
8 civilian conservation corps revenues shall be used to provide job  
9 training for public assistance recipients and other low-income youth  
10 for natural resources and conservation projects.

#### 11 **FOREST RESOURCE MANAGEMENT**

12 Sec. 701. A forest recreation advisory committee shall be  
13 established to assure that all products of state forests be given fair  
14 and equitable consideration. The committee shall address recreational,  
15 environmental, and aesthetic aspects of state forest lands, and make  
16 recommendations to the commission of natural resources and director of  
17 the department on strategies for revenue generation and public use  
18 enhancement. The committee will also review and make recommendations on  
19 the organizational placement of state forest recreation programs in the  
20 forest management division. It is the intent of the legislature that no  
21 trails or campground facilities on state forest lands be permanently  
22 closed until the recommendations made by the forest recreation advisory  
23 committee are implemented and a report provided to the senate and house  
24 appropriations subcommittees on natural resources, and house and senate  
25 committees that consider natural resources and conservation  
26 legislation. The forest recreation advisory committee shall consist of  
27 members from a minimum of 10 state forest user groups, staff assigned  
28 to forest recreation programs in the forest management, recreation,  
29 fisheries, parks, and wildlife management divisions of the department,  
30 and representatives from the house and senate fiscal agencies.

1       Sec. 702. The department shall establish criteria to use in  
2       determining the propriety or necessity of closing, consolidating, or  
3       transferring any state forest campground. All state forest campground  
4       closures, consolidations, or transfers are subject to the criteria  
5       developed pursuant to this section. The department shall notify the  
6       chairpersons of the senate and house appropriations subcommittees and  
7       standing committees on natural resources prior to closing,  
8       consolidating, or transferring a state forest campground.

9       Sec. 703. The department shall review the list of state forest  
10      campgrounds slated for temporary closure and, where possible, utilize  
11      the increased appropriations in section 101 for forest recreation to  
12      provide infrastructure repairs and operational support to keep open  
13      those facilities that have unique natural features, significant  
14      attendance, or other potential sources of income.

15      Sec. 704. The commission may establish and collect fees for the  
16      processing of applications for the use of state forests that require  
17      extensive review. The fees shall cover the cost to the department of  
18      processing the applications. Any unexpended application fees for the  
19      use of state forests, along with any excess collections from prior  
20      fiscal years, shall be carried over into subsequent fiscal years and  
21      shall be available for appropriation.

## 22      **REAL ESTATE**

23      Sec. 801. The department may charge land acquisition projects  
24      appropriated for the fiscal year ending September 30, 1996, and for  
25      prior fiscal years, a standard percentage fee to be determined by the  
26      state budget director, and may use the revenue derived to support the  
27      land acquisition service charges provided for in section 101.

28      Sec. 802. The land sale fund is created. An amount equal to the  
29      cost of personal services, printing, postage, advertising, contractual  
30      services, and facility rental associated with tax reverted lands shall

1 be deducted from the sales and credited to the land sale fund.

2 **GEOLOGICAL SURVEY**

3 Sec. 901. From fees collected pursuant to section 22 of Act No. 61  
4 of the Public Acts of 1939, being section 319.22 of the Michigan  
5 Compiled Laws, there is appropriated \$125,000.00 to be known as the  
6 brine loss investigation fund that shall be utilized by the supervisor  
7 of wells for response and investigation of existing or future alleged  
8 instances of groundwater contamination resulting from drilling or  
9 operation of oil or gas wells. If necessary, and after consultation  
10 with the oil and gas advisory board, the supervisor of wells may  
11 negotiate and authorize direct contractual services for surface of  
12 hydrogeologic investigations. The fund shall not be used for research  
13 or for soil or groundwater sampling where verified complaints do not  
14 exist.

15 Sec. 902. The department shall cooperate with the United States  
16 geological survey in maintaining a groundwater data base in Michigan.

17 Sec. 903. From the amounts appropriated in section 101 for mineral  
18 wells management and hazardous waste permits, \$65,000.00 and 1.0  
19 position is specifically allocated for the review of deep well  
20 injection permits. These funds shall be dedicated when permit  
21 applications are received by the department.

22 **LAND AND WATER MANAGEMENT**

23 Sec. 1001. It is the intent of the legislature that ongoing program  
24 activities of the land and water management division, except for the  
25 accelerated land and water permit process, not receive land and water  
26 management permit fee revenue to address potential funding shortfalls  
27 in those programs.

28 **AIR QUALITY**

29 Sec. 1101. From the funds appropriated in section 101, the  
30 department shall report on the status of clean air act amendment

1 implementation planning and permit backlog reduction activities,  
2 including status of revenue collections, on a quarterly basis. The  
3 report shall be provided to the house and senate appropriations  
4 subcommittees on natural resources, the house and senate standing  
5 committees of the legislature that are responsible for issues  
6 pertaining to air quality, the commission of natural resources, and the  
7 governor.

#### 8 **ENVIRONMENTAL RESPONSE**

9       Sec. 1201. (1) From the appropriation in section 101 for the act  
10 307 cleanup program, the department shall continue to make  
11 authorizations for site evaluation, interim response activity, final  
12 response activity, and contingencies for all environmental  
13 contamination sites and for the administration of the program created  
14 by the environmental response act, Act No. 307 of the Public Acts of  
15 1982, being sections 299.601 to 299.618 of the Michigan Compiled Laws.

16       (2) The department shall report all of the following information  
17 relative to allocations made from the lines "state cleanup" and "state  
18 cleanup management" in section 101 to the senate and house  
19 appropriations committees and the senate and house fiscal agencies:

20       (a) The name and location of the site for which an allocation is  
21 made.

22       (b) The nature of the problem encountered at the site.

23       (c) The estimated time necessary to prepare plans or complete any  
24 necessary study if the allocation is for plans or a study.

25       (d) A brief description of how the problem will be resolved if the  
26 allocation is made for a response activity.

27       (e) The estimated time to complete the response activity if the  
28 allocation is for a response activity.

29       (f) The amount of the allocation.

30       (g) A summary of the sites and the total amount of funds expended

1 at the sites at the conclusion of the fiscal year.

2 (3) The report prepared under subsection (2) shall also include the  
3 status of all state-owned facilities that are on the list compiled  
4 under Act No. 307 of the Public Acts of 1982.

5 (4) The report prepared under subsection (2) shall be made  
6 available in January of each year.

7 Sec. 1202. The unexpended portion of the appropriation in section  
8 101 for the state cleanup and superfund cleanup are considered work  
9 project appropriations and any unencumbered or unallotted funds are  
10 carried forward into the succeeding fiscal year. The following is in  
11 compliance with section 451(3) of the management and budget act, Act  
12 No. 431 of the Public Acts of 1984, being section 18.1451 of the  
13 Michigan Compiled Laws:

14 (a) The purpose of the projects is to provide contaminated site  
15 cleanup.

16 (b) The projects will be accomplished by contract.

17 (c) The total estimated cost projects is \$6,649,500 for state  
18 cleanup and \$22,746,900 for superfund cleanup.

19 (d) The tentative completion date is September 30, 1997.

20 Sec. 1203. (1) The department shall report all of the following  
21 information relative to site specific cooperative agreements made from  
22 the line "superfund cleanup" to the senate and house appropriations  
23 committees and the senate and house fiscal agencies:

24 (a) The name and location of the site for which the site specific  
25 cooperative agreement is made.

26 (b) The nature of the problem encountered at the site.

27 (c) The estimated time to prepare plans or complete any necessary  
28 study if the allocation is for plans or a study.

29 (d) A brief description of how the problem will be resolved if the  
30 allocation is made for a remedy.

1 (e) The estimated time to complete the remedy of the problem if the  
2 allocation is for a remedy.

3 (f) The amount of the anticipated financing for the site.

4 (g) A summary of the sites and the total amount of funds expended  
5 at the sites at the conclusion of the fiscal year.

6 (2) The report shall be made available in January of each year.

7 Sec. 1204. The appropriation in section 101 for the state cleanup  
8 program shall be used for the purpose of taking emergency response  
9 activities at sites listed under the environmental response act, Act  
10 No. 307 of the Public Acts of 1982, being sections 299.601 to 299.618  
11 of the Michigan Compiled Laws, for the implementation of the Act 307  
12 cleanup program, for remediation of contaminated sites on state-owned  
13 land, and for court ordered settlements and related agreements. The  
14 department shall report to the house and senate appropriations  
15 subcommittees on natural resources any projected shortfall of  
16 appropriations made under this section by April 2, 1996.

17 Sec. 1205. Of the funds appropriated in section 101 as state match  
18 for the superfund cleanup program, an amount not to exceed \$250,000.00  
19 shall be expended as state match for the hazardous substance research  
20 center.

#### 21 **UNDERGROUND STORAGE TANKS**

22 Sec. 1301. (1) The funds appropriated in section 101 from the  
23 Michigan underground storage tank financial assurance fund for the  
24 purpose of carrying out the duties and responsibilities as specified in  
25 the Michigan underground storage tank financial assurance act, Act No.  
26 518 of the Public Acts of 1988, being sections 299.801 to 299.828 of  
27 the Michigan Compiled Laws are considered work project appropriations  
28 and any unencumbered funds are carried forward into the succeeding  
29 fiscal year. The following is in compliance with section 451(3) of the  
30 management and budget act, Act No. 431 of the Public Acts of 1984,

1 being section 18.1451 of the Michigan Compiled Laws:

2 (a) The purpose of the projects to be carried forward is to carry  
3 out the responsibilities of Act No. 518 of the Public Acts of 1988.

4 (b) The projects will be accomplished by contract and state  
5 employees.

6 (c) The total estimated cost is \$60,013,600.

7 (d) The tentative completion date is September 30, 1997.

8 (2) The Michigan underground storage tank financial assurance  
9 policy board shall allocate the amount of the underground storage tank  
10 financial assurance fund to be distributed to the department. If the  
11 amount recommended by the board is less than that appropriated in  
12 section 101, expenditures shall be adjusted accordingly.

13 (3) Included in the amounts appropriated in section 101 from the  
14 Michigan underground storage tank financial assurance fund are amounts  
15 sufficient to pay debt service costs on the bonds or notes issued  
16 pursuant to the Michigan underground storage tank financial assurance  
17 act, Act No. 518 of the Public Acts of 1988, being sections 299.801 to  
18 299.828 of the Michigan Compiled Laws.

#### 19 **WASTE MANAGEMENT**

20 Sec. 1401. Of the funds appropriated in section 101 for the  
21 resource recovery program, \$100,000.00 shall be used to implement the  
22 used oil recycling act, Act No. 411 of the Public Acts of 1980, being  
23 sections 319.311 to 319.316 of the Michigan Compiled Laws, as it  
24 pertains to preparation of plans and demonstrations regarding used oil  
25 recycling and development of a statewide used oil collection system.  
26 The department shall report to the chairpersons of the senate and house  
27 appropriations subcommittees on natural resources on the progress of  
28 implementation of this act by April, 1996.

#### 29 **GRANTS**

30 Sec. 1501. If a certified health department does not exist in a

1 city, county, or district or does not fulfill its responsibilities  
2 under the septage waste servicer's act, Act No. 181 of the Public Acts  
3 of 1986, being sections 325.311 to 325.332 of the Michigan Compiled  
4 Laws, then the department may spend funds appropriated in section 101  
5 under the septage waste compliance program in accordance with section  
6 17(3) of the septage waste servicer's act, Act No. 181 of the Public  
7 Acts of 1986, being section 325.327 of the Michigan Compiled Laws.
