



# SENATE BILL No. 1101

July 3, 1996, Introduced by Senator DE GROW and referred to the Committee on Appropriations.

A bill to amend section 99 of Act No. 94 of the Public Acts of 1979, entitled as amended

"The state school aid act of 1979,"

as amended by Act No. 300 of the Public Acts of 1996, being section 388.1699 of the Michigan Compiled Laws.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Section 99 of Act No. 94 of the Public Acts of  
2 1979, as amended by Act No. 300 of the Public Acts of 1996, being  
3 section 388.1699 of the Michigan Compiled Laws, is amended to  
4 read as follows:

5 Sec. 99. (1) From the general fund/general purpose appro-  
6 priation in section 11, there is allocated an amount not to  
7 exceed ~~\$7,560,800.00~~ \$7,696,500.00 for 1996-97 for implementing  
8 the comprehensive master plan for mathematics and science centers

1 developed by the department and approved by the state board on  
2 February 17, 1993.

3 (2) Within a service area designated locally, approved by  
4 the department, and consistent with the master plan described in  
5 subsection (1), an established mathematics and science center  
6 shall address 2 or more of the following 6 basic services, as  
7 described in the master plan, to constituent districts and  
8 communities: leadership, pupil services, curriculum support,  
9 community involvement, professional development, and resource  
10 clearinghouse services.

11 (3) The department shall not award a grant under this sec-  
12 tion to more than 1 mathematics and science center located in a  
13 particular intermediate district unless each of the grants serves  
14 a distinct target population or provides a service that does not  
15 duplicate another program in the intermediate district.

16 (4) As part of the technical assistance process, the depart-  
17 ment shall provide minimum standard guidelines that may be used  
18 by the mathematics and science center for providing fair access  
19 for qualified pupils and professional staff as prescribed in this  
20 section.

21 (5) Allocations under this section to support the activities  
22 and programs of mathematics and science centers shall be continu-  
23 ing support grants to all 25 established mathematics and science  
24 centers ~~and the 8 satellite extensions~~ that were funded in  
25 ~~+1994-95-~~ 1995-96. Each established mathematics and science  
26 center that was funded in ~~+1994-95-~~ 1995-96 shall receive an  
27 amount equal to ~~+10% of~~ the amount it received under this

1 section in ~~1994-95~~ 1995-96. IN ADDITION, EACH ESTABLISHED  
2 MATHEMATICS AND SCIENCE CENTER THAT OPERATED A SATELLITE EXTEN-  
3 SION IN 1995-96 SHALL RECEIVE AN ADDITIONAL \$82,500.00 FOR  
4 1996-97 UNDER THIS SECTION FOR OPERATING THE SATELLITE EXTENSION  
5 IN 1996-97, AND THE SAGINAW VALLEY STATE UNIVERSITY MATHEMATICS  
6 AND SCIENCE CENTER SHALL RECEIVE AN ADDITIONAL \$82,500.00 FOR  
7 1996-97 UNDER THIS SECTION TO ESTABLISH AND OPERATE A SATELLITE  
8 EXTENSION IN THE TUSCOLA INTERMEDIATE SCHOOL DISTRICT IN 1996-97.  
9 The balance of the allocation under this section for ~~1995-96~~  
10 1996-97 shall be distributed ~~as determined by the department,~~  
11 ~~subject to approval by the house and senate appropriations sub-~~  
12 ~~committees that have responsibility for this act~~ BY THE DEPART-  
13 MENT TO THE STATEWIDE PROJECT "TUNE IN MATH AND SCIENCE" CON-  
14 DUCTED BY MICHIGAN STATE UNIVERSITY.

15 (6) In order to receive funds under this section, a grant  
16 recipient shall allow access for the department or the  
17 department's designee to audit all records related to the program  
18 for which it receives such funds. The grant recipient shall  
19 reimburse the state for all disallowances found in the audit.
