A bill to amend 1962 PA 192, entitled "Professional service corporation act," by amending section 4 (MCL 450.224), as amended by 1997 PA 139.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4. (1) One or more licensed persons may organize under
- 2 this act to become a shareholder or shareholders of a profes-
- 3 sional corporation for pecuniary profit.
- **4** (2) Except as otherwise provided in <del>subsection (3)</del>
- 5 SUBSECTIONS (3) AND (4) or otherwise prohibited, a professional
- 6 corporation may render 1 or more professional services, except
- 7 that each shareholder must be a licensed person in 1 or more of
- 8 the professional services rendered by the corporation.
