- 6 (B) "EURO" OR "EUROS" MEANS THE CURRENCY OF PARTICIPATING
- 7 MEMBER STATES OF THE EUROPEAN UNION THAT ADOPT A SINGLE CURRENCY
- 8 IN ACCORDANCE WITH THE TREATY ON EUROPEAN UNION SIGNED FEBRUARY
- **9** 7, 1992. [MEMBER STATES ARE THOSE THAT HAVE DECIDED TO ADOPT THE EURO, AND OTHER MEMBER STATES THAT MAY CHOOSE TO PARTICIPATE.]
