H.B. 5862

A bill to amend 1905 PA 80, entitled

"An act to authorize and empower certain state departments, and the board of control, board of trustees or governing board of certain state institutions, or the governing body of a municipal corporation, to make, prescribe and enforce rules and regulations for the care, order and preservation of buildings or property dedicated and appropriated to the public use and the conduct of those coming upon the property thereof; to prescribe penalties for a violation thereof and to repeal all acts or parts of acts inconsistent with the provisions of this act,"

by amending section 2 (MCL 19.142), as amended by 1996 PA 231.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. (1) A person shall not do any of the following with
- 2 respect to property that is dedicated or appropriated to public
- 3 use and is within the control or under the jurisdiction of a
- 4 board or department prescribed in section 1:
- 5 (a) Willfully cut, peel, or otherwise injure or destroy a
- 6 tree or shrub standing on the property.

- 1 (b) Carry, draw, leave, or deposit within or upon the
- 2 property any filth, rubbish, or garbage.
- 3 (c) Efface a mark or inscription on the property, or muti-
- 4 late or destroy a building, machine, or appliance, fence, or

- 6 (d) Enter, hunt, or trespass upon the property, or skate
- 7 upon, or fish, in a pond, brook, or stream, the use of which is
- 8 forbidden to the general public, and relative to which WHERE
- 9 there are signs or notices prohibiting this conduct.
