

SENATE SUBSTITUTE FOR
HOUSE BILL NO. 5956

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
by amending section 625i (MCL 257.625i), as amended by 1996 PA
493.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 625i. (1) The department of state police shall prepare
2 an annual report which shall be designated the Michigan annual
3 drunk driving audit. The secretary of state, circuit court, dis-
4 trict court, ~~probate~~ FAMILY DIVISION OF CIRCUIT court, munici-
5 pal courts, and local units of government in this state shall
6 cooperate with the department of state police to provide informa-
7 tion necessary for the preparation of the report. A copy of the
8 report prepared under this subsection shall be submitted to the
9 governor, the secretary of the senate, the clerk of the house of
10 representatives, and the secretary of state on ~~June~~ JULY 1 of

1 each year. The report shall contain for each county in the state
2 all of the following information applicable to the immediately
3 preceding calendar year:

4 (a) The number of alcohol related motor vehicle ~~accidents~~
5 CRASHES resulting in bodily injury, including a breakdown of the
6 number of those injuries occurring per capita of population and
7 per road mile in the county.

8 (b) The number of alcohol related motor vehicle ~~accidents~~
9 CRASHES resulting in death, including the breakdown described in
10 subdivision (a).

11 (c) The number of alcohol related motor vehicle ~~accidents~~
12 CRASHES, other than those enumerated in subdivisions (a) and (b),
13 including the breakdown described in subdivision (a).

14 (d) The number of arrests made for violations of section
15 625(1)(a) or (b) or local ordinances substantially corresponding
16 to section 625(1)(a) or (b).

17 (e) The number of arrests made for violations of section
18 625(3) or local ordinances substantially corresponding to section
19 625(3).

20 (f) The number of arrests made for violations of
21 section 625(6) or local ordinances substantially corresponding to
22 section 625(6).

23 (g) The number of arrests made for violations of
24 section 625(4) or (5).

25 (H) THE NUMBER OF ARRESTS MADE FOR VIOLATIONS OF SECTION
26 625(7).
