- 3 CAL, OR SURGICAL POLICY OR CERTIFICATE SHALL NOT RATE, CANCEL
- 4 COVERAGE ON, REFUSE TO PROVIDE COVERAGE FOR, OR REFUSE TO ISSUE
- 5 OR RENEW A POLICY OR CERTIFICATE SOLELY BECAUSE AN INSURED OR
- 6 APPLICANT FOR INSURANCE IS OR HAS BEEN A VICTIM OF DOMESTIC
- 7 VIOLENCE.
- 8 (2) THIS SECTION DOES NOT PROHIBIT AN INSURER FROM INQUIRING
- 9 ABOUT, UNDERWRITING, OR CHARGING A DIFFERENT PREMIUM ON THE BASIS
- 10 OF THE INDIVIDUAL'S PHYSICAL OR MENTAL CONDITION, REGARDLESS OF
- 11 THE CAUSE OF THE CONDITION.
