HOUSE BILL No. 4211

January 30, 1997, Introduced by Reps. Kaza, Raczkowski, Mans and Lowe and referred to the Committee on House Oversight and Ethics.

A bill to amend 1978 PA 472, entitled

"An act to regulate political activity; to regulate lobbyists, lobbyist agents, and lobbying activities; to require registration of lobbyists and lobbyist agents; to require the filing of reports; to prescribe the powers and duties of the department of state; to prescribe penalties; and to repeal certain acts and parts of acts,"

by amending section 7 (MCL 4.417).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7. (1) Not later than 15 days after becoming a lobby-
- 2 ist, a lobbyist shall file a registration form with the secretary
- 3 of state. The registration shall contain ALL OF the following

- 14 the secretary of state within 30 days after ceasing to lobby for
- 15 a lobbyist.
