## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 61. (1) THE OLDER MICHIGANIANS PHARMACEUTICAL ASSIST-
- 2 ANCE FUND IS ESTABLISHED IN THE DEPARTMENT OF TREASURY TO BE
- 3 ADMINISTERED BY THE OFFICE. THE STATE TREASURER SHALL CREDIT TO
- 4 THE FUND ALL AMOUNTS APPROPRIATED FOR THAT PURPOSE IN SECTION 273
- 5 OF THE INCOME TAX ACT OF 1967, 1967 PA 281, MCL 206.273, AND
- 6 MONEY CONTRIBUTED TO THE FUND FROM ANY OTHER SOURCE. ANY MONEY,
- 7 INCLUDING INTEREST EARNED BY THE FUND, REMAINING IN THE FUND AT
