THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. (1) —In— UNLESS THE BUYER IN a home solicitation
- 2 sale -, unless the buyer requests THAT the seller -to provide
- 3 goods or services without delay in an emergency, the seller shall
- 4 present to the buyer and obtain the buyer's signature -to- ON a
- 5 written agreement or offer to purchase which THAT SPECIFIES THE
- 6 TERMS OF THE TRANSACTION AND designates as the date of the trans-
- 7 action the date on which the buyer actually signs.
- 8 The agreement or offer to purchase shall contain a statement
- 9 substantially as follows in immediate proximity to the space

28 date the buyer signs the written agreement, and the date for
29 mailing the notice of cancellation. An error in entering this
30 information shall DOES not diminish the buyer's rights under

- 5 the buyer may cancel the home solicitation sale by notifying the
- 6 seller in any manner and by any means of his or her intention to
- 7 cancel.
