THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 14101. AS USED IN THIS PART:
- 2 (A) "ENVIRONMENTAL WASTES" MEANS ALL ENVIRONMENTAL POLLUT-

- SEC. 14103. IT IS THE POLICY OF THIS STATE TO REDUCE THE 5
- 6 DISPOSAL AND RELEASE OF ENVIRONMENTAL WASTES THAT MAY HAVE SERI-
- 7 OUS, ADVERSE EFFECTS ON HEALTH AND THE ENVIRONMENT, TO PROMOTE
- 8 POLLUTION PREVENTION AS THE PREFERRED MEANS OF ACHIEVING COMPLI-
- 9 ANCE WITH ENVIRONMENTAL LAWS, TO USE EXISTING REGULATORY PROGRAMS

- 12 SEC. 14104. (1) IT IS THE GOAL OF THIS STATE TO REDUCE
- 13 ENVIRONMENTAL WASTES BY 50% WITHIN 5 YEARS AFTER THE EFFECTIVE
- 14 DATE OF THIS SECTION. THIS GOAL IS NOT INTENDED TO IMPOSE A
- 15 LEGAL REQUIREMENT ON THE DEPARTMENT BUT RATHER A TARGET TOWARD
