THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2964. (1) A PERSON WHO COMMITS OR ATTEMPTS TO COMMIT
- 2 SUICIDE IN VIOLATION OF A LAW OF THIS STATE OR WHO ASSISTS
- 3 ANOTHER PERSON TO COMMIT OR ATTEMPT TO COMMIT SUICIDE IN VIOLA-
- 4 TION OF A LAW OF THIS STATE IS RESPONSIBLE FOR PAYING THE ACTUAL
- 5 AND REASONABLE COSTS INCURRED BY THE COUNTY MEDICAL EXAMINER AND
- 6 EACH POLICE AGENCY FOR INVESTIGATING THAT SUICIDE. AS USED IN
- 7 THIS SECTION, "COSTS" INCLUDES, BUT IS NOT LIMITED TO, ALL OF THE
- 8 FOLLOWING:
- 9 (A) THE COSTS OF PERSONNEL NEEDED TO INVESTIGATE THE
- 10 SUICIDE, INCLUDING, BUT NOT LIMITED TO, THE COSTS OF SUPPORT

- 15 SUICIDE ON THE PROPERTY OF ANOTHER PERSON WITHOUT THE WRITTEN
- 16 PERMISSION OF THE PROPERTY OWNER.
- 17 (2) A PERSON WHO VIOLATES SUBSECTION (1), OR HIS OR HER
- 18 ESTATE, IS RESPONSIBLE FOR PAYING 3 TIMES THE DAMAGES INCURRED BY
- 19 THE PROPERTY OWNER AS A RESULT OF THE SUICIDE OR ATTEMPT TO
- 20 COMMIT SUICIDE ON THAT PROPERTY OR \$10,000.00 WHICHEVER IS GREAT-
- 21 ER, PLUS COURT COSTS AND ACTUAL AND REASONABLE ATTORNEY FEES.
- 22 DAMAGES THAT MAY BE RECOVERED UNDER THIS SECTION INCLUDE, BUT ARE
- 23 NOT LIMITED TO, ALL OF THE FOLLOWING:
- 24 (A) THE COSTS OF MATERIAL AND LABOR.
- 25 (B) LOSS OF BUSINESS REVENUE.
- 26 (3) AS USED IN THIS SECTION, "PROPERTY OF ANOTHER PERSON"
- 27 MEANS PUBLIC OR PRIVATE PERSONAL OR REAL PROPERTY THAT BELONGS TO

- ${f 1}$ A PERSON OTHER THAN THE PERSON COMMITTING OR ATTEMPTING TO COMMIT
- 2 SUICIDE OR THE PERSON ASSISTING THAT PERSON TO COMMIT OR ATTEMPT
- 3 TO COMMIT SUICIDE.
