November 4, 1997, Introduced by Reps. Callahan, Schauer, Wojno, DeHart, Voorhees, Horton and Anthony and referred to the Committee on Regulatory Affairs.

A bill to amend 1917 PA 273, entitled

"An act to regulate and license pawnbrokers in cities and incorporated villages of this state, having a population of more than 3,000,"

by amending section 5 (MCL 446.205).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 5. (1) Every such A pawnbroker shall keep a book to be inspected by the chief of police or chief police officer of the city or village in which shall be IS written in English, the time he shall receive THE PAWNBROKER RECEIVES any article of personal property — or other valuable thing by way of pledge or pawn, a description of such THE article, A SEQUEN-TIAL TRANSACTION NUMBER, the ANY amount of money loaned thereon, the rate of interest to be paid on such loan, the name, presidence, and general description, AND DRIVER LICENSE NUMBER, OFFICIAL STATE PERSONAL IDENTIFICATION CARD NUMBER, OR GOVERNMENT

SUBSECTION (4). EACH RECORD OF TRANSACTION SHALL BE COMPLETED IN
QUADRUPLICATE BY THE PAWNBROKER, LEGIBLY IN INK IN THE ENGLISH
LANGUAGE, AND SHALL CONTAIN ALL APPLICABLE INFORMATION REQUIRED
TO COMPLETE THE RECORD OF TRANSACTION FORM UNDER SUBSECTION (4).
(3) THE PAWNBROKER SHALL RETAIN 1 COPY OF THE RECORD OF
TRANSACTION AND, WITHIN 48 HOURS AFTER THE PROPERTY IS RECEIVED,
SHALL SEND 1 COPY OF THE RECORD OF TRANSACTION TO THE LOCAL
POLICE AGENCY.
