## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 39C. (1) FOR TAX YEARS BEGINNING AFTER DECEMBER 31,
- 2 1996, A TAXPAYER MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED BY
- 3 THIS ACT EQUAL TO 5% OF THE COSTS PAID IN THE TAX YEAR FOR POLLU-
- 4 TION PREVENTION EQUIPMENT USED BY THE TAXPAYER AT A FACILITY IN
- 5 THIS STATE TO MITIGATE AIR OR WATER POLLUTION.
- 6 (2) A TAXPAYER MAY CLAIM A CREDIT UNDER THIS SECTION FOR
- 7 COSTS THAT WERE USED BY THE TAXPAYER TO CALCULATE A CREDIT UNDER
- 8 SECTION 23.
- 9 (3) IF THE CREDIT ALLOWED UNDER THIS SECTION FOR THE TAX
- 10 YEAR AND ANY UNUSED CARRYFORWARD OF THE CREDIT ALLOWED BY THIS
- 11 SECTION EXCEED THE TAXPAYER'S TAX LIABILITY FOR THE TAX YEAR,

- 1 THAT PORTION THAT EXCEEDS THE TAX LIABILITY FOR THE TAX YEAR
