## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 706a. (1) The department shall prepare and distribute
- 2 to each community mental health services program copies of a pam-
- 3 phlet containing information regarding resources available to
- 4 individuals with serious mental illness and their families. The
- 5 information shall include a description of advocacy and support
- 6 groups —, and other information of interest to recipients and
- 7 their families. The pamphlet shall include the name, address,
- 8 and telephone number of the organization designated by the
- 9 governor under section 931 to provide protection and advocacy for
