- 1 SEC. 356E. (1) A PERSON SHALL NOT REMOVE, DAMAGE, OR
- 2 DESTROY 5 OR MORE COPIES OF A PERIODICAL FROM ANY LOCATION OR
- 3 COMBINATION OF LOCATIONS AT WHICH THEY ARE OFFERED FREE OF CHARGE
- 4 BY ANOTHER PERSON FOR REVIEW BY MEMBERS OF THE PUBLIC WITH THE
- 5 INTENT TO DEPRIVE ANY OTHER MEMBER OF THE PUBLIC THE OPPORTUNITY
- 6 TO REVIEW ANY INFORMATION CONTAINED IN THAT PERIODICAL.
- 7 (2) SUBSECTION (1) DOES NOT PROHIBIT A PROPERTY OWNER OR HIS
