- 2 PUBLIC SCHOOL HAS GOOD REASON TO BELIEVE THAT A PUPIL'S PRESENCE
- 3 IN A CLASS, SUBJECT, OR ACTIVITY POSES AN IMMEDIATE AND CONTINU-
- 4 ING DANGER TO THE PUPIL, 1 OR MORE OTHER PUPILS, OR SCHOOL PER-
- 5 SONNEL OR POSES AN IMMEDIATE AND CONTINUING THREAT OF DISRUPTION
- 6 OF THE CLASS, SUBJECT, OR ACTIVITY, THE TEACHER OR SCHOOL ADMIN-
- 7 ISTRATOR MAY CAUSE THE PUPIL TO BE REMOVED IMMEDIATELY FROM THE
- 8 CLASS, SUBJECT, OR ACTIVITY AND SENT TO THE SCHOOL PRINCIPAL OR
- 9 HIS OR HER DESIGNEE. THE PUPIL'S REMOVAL FROM CLASS SHALL
