- 4 STATE, AS DETERMINED BY THE DIRECTOR OR BY THE FEDERAL CENTERS
- 5 FOR DISEASE CONTROL, THE DIRECTOR SHALL ASSURE THAT THE FOLLOWING
- 6 INDIVIDUALS HAVE PRIORITY ACCESS TO AVAILABLE ANTHRAX VACCINE:

- 8 (B) FIREFIGHTERS.

- 1 (D) "ORGANIZED FIRE DEPARTMENT" MEANS AN ORGANIZATION OR
- 2 DEPARTMENT THAT PROVIDES A FIRE SERVICE DELIVERY SYSTEM WITHIN A
- 3 MUNICIPALITY AND IS A FIRE DEPARTMENT OF A MUNICIPALITY OR IS A
- 4 FIRE SERVICE DELIVERY SYSTEM DESIGNATED BY A MUNICIPALITY PURSU-
- 5 ANT TO A CONTRACT WITH THAT MUNICIPALITY. ORGANIZED FIRE DEPART-
- 6 MENT INCLUDES, BUT IS NOT LIMITED TO, A DEPARTMENT OF COUNTY
- 7 EMPLOYEES WHO ARE RESPONSIBLE FOR PROVIDING A FIRE SERVICE DELIV-
- 8 ERY SYSTEM FOR AN AIRPORT OPERATED BY THE COUNTY OR AN AGENCY OF
- 9 THE COUNTY.
