## HOUSE BILL No. 6028

September 15, 1998, Introduced by Rep. Martinez and referred to the Committee on Urban Policy and Economic Development.

A bill to amend 1943 PA 184, entitled "Townships zoning act,"

by amending section 40 (MCL 125.310), as added by 1996 PA 570, and by adding section 1b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1B. AN ORDINANCE MAY REQUIRE OR PROVIDE INCENTIVES FOR
- 2 THE OWNER OR OPERATOR OF A PROPOSED HOUSING DEVELOPMENT PROJECT
- 3 OF MORE THAN 50 DWELLING UNITS TO DO EITHER OF THE FOLLOWING:
- 4 (A) OFFER UP TO 25% OF THE DWELLING UNITS AS LOW OR MODERATE
- 5 INCOME HOUSING.
- 6 (B) OFFER UP TO 20% OF THE DWELLING UNITS AS LOW OR MODERATE
- 7 INCOME HOUSING AND UP TO 5% OF THE DWELLING UNITS AS VERY LOW
- 8 INCOME HOUSING.
- 9 Sec. 40. (1) As used in this act:

- 1 (a) "Agricultural land" means substantially undeveloped land
- 2 devoted to the production of plants and animals useful to humans,
- 3 including forage and sod crops; grains, feed crops, and field
- 4 crops; dairy and dairy products; poultry and poultry products;
- 5 livestock, including breeding and grazing of cattle, swine, and
- 6 similar animals; berries; herbs; flowers; seeds; grasses; nursery

- 8 FOR INDIVIDUALS OR FAMILIES WHOSE INDIVIDUAL OR FAMILY INCOME IS
- 9 60% OR LESS OF AREA MEDIAN INCOME.
