THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 261C. (1) THE DEPARTMENT SHALL NOT ENTER INTO A PRIVA-
- 2 TIZATION CONTRACT UNLESS THAT PRIVATIZATION CONTRACT CONTAINS ALL
- 3 OF THE FOLLOWING PROVISIONS:
- 4 (A) THE CONTRACTOR WILL OFFER AVAILABLE EMPLOYMENT POSITIONS
- 5 TO CURRENT OR FORMER EMPLOYEES OF THIS STATE WHO WORKED FOR THE
- 6 STATE AGENCY AND PERFORMED THE TASKS NOW BEING PERFORMED BY THE
- 7 CONTRACTOR.
- 8 (B) THE CONTRACTOR WILL COMPLY WITH ALL LAWS AND REGULATIONS
- 9 REGARDING EMPLOYMENT, EMPLOYMENT DISCRIMINATION, AND EQUAL
- 10 OPPORTUNITY.

- 1 (C) THE CONTRACTOR COVENANTS THAT THE CONTRACTOR AND ITS
- 2 OFFICERS, PARTNERS, MEMBERS, OR MANAGERIAL EMPLOYEES DO NOT HAVE

- 10 DETERMINED BY THE DEPARTMENT.
- 11 (E) THE CONTRACTOR WILL PAY A PERCENTAGE OF THE WAGE OF AN
- 12 EMPLOYEE FOR A MEDICAL HEALTH PLAN FOR ITS EMPLOYEES AS DETER-
- 13 MINED BY THE DEPARTMENT. THE DEPARTMENT SHALL NOT DETERMINE A
- 14 PERCENTAGE LESS THAN THE COMPARABLE PERCENTAGE THIS STATE PAYS ON
- 15 AVERAGE FOR ITS EMPLOYEES.
- 16 (2) AS USED IN THIS SECTION, "PRIVATIZATION CONTRACT" MEANS
- 17 A WRITTEN CONTRACTUAL AGREEMENT OR COMBINATION OF AGREEMENTS IN
- 18 WHICH A PERSON WHO IS NOT A GOVERNMENTAL AGENCY AGREES TO PROVIDE
- 19 SERVICES TO 1 OR MORE STATE AGENCIES, VALUED AT MORE THAN
- 20 \$100,000.00, THAT ARE SUBSTANTIALLY SIMILAR TO AND IN LIEU OF
- 21 SERVICES PREVIOUSLY PROVIDED, IN WHOLE OR IN PART, BY EMPLOYEES
- 22 OF THIS STATE. AN AGREEMENT SOLELY TO PROVIDE LEGAL, MANAGEMENT
