- 3 STATE FOR A SPECIAL REGISTRATION PLATE, WHICH SHALL HAVE THE
- 4 WORDS "MICHIGAN, GREAT LAKES STATE, CONGRESSIONAL MEDAL OF HONOR
- 5 RECIPIENT" INSCRIBED BENEATH THE REGISTRATION NUMBERS.
- 6 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE DESCRIBED
- 7 IN SUBSECTION (1) SHALL BE ON A FORM PRESCRIBED BY THE SECRETARY
- 8 OF STATE, AND SHALL BE ACCOMPANIED BY ANY PROOF OF THE APPLICANT
