"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license; to provide for the forfeiture of firearms possessed in violation of this act; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; and to repeal all acts and parts of acts inconsistent with the provisions of this act,"

(MCL 28.421 to 28.434) by adding section 5e.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 5E. IF THE CONCEALED WEAPON LICENSING BOARD DENIES
ISSUANCE OF A LICENSE TO CARRY A CONCEALED PISTOL, OR FAILS TO
ISSUE THAT LICENSE AS PROVIDED IN THIS ACT, OR ISSUES A
RESTRICTED LICENSE, THE APPLICANT MAY PETITION THE DISTRICT COURT
IN THE JUDICIAL DISTRICT IN WHICH HE OR SHE RESIDES TO REVIEW THE
DENIAL, THE FAILURE TO ISSUE THE LICENSE, OR THE ISSUANCE OF A
